As a concerned member of country NSW I have taken the time to research wind energy in other countries and also that which is being generated at Balaney

My findings are that they are only- at most - efective 30% of the time if you are lucky. In Canada the statistics are much less and there is a lot of the time that little or no energy is produced

They are incapable of producing base load power anywhere in the world and most areas that use off peak power, which is at night there is more often than not any wind to produce power so very little backup effect is available

How can a small area own a wind farm? or run it after construction ,as is being considered Huge companies run power stations and own them not small communities

The expense to construct a wind farm is huge ,not to mention the huge amount of greenhouse gases produced during the years they take to construct and damage to small community roads and infrastructure. Having just read the EA for The KYOTO ENERGY Park proposal and living in this area for more of these small operations to be considered anywhere is lunacy. It shouldn't be being done so close to any town ever. Not in NSW how would Sydney react if you put the turbines all along the coast in Sydney where there is always wind and the greatest users of power live There would be an uproar.

The proposal such as Silverton with 598 Turbines near an energy grid does make sense and there are very few people affected

Values of Rural land does go down and promotors of wind farms should be put in a position of having to acquire any property within 3-5 km of the turbines (if they wish to sell the property) if its value or the vibritations that are produced by the turbines effects them This cannot be measured by modelling before construction Modelling is hypothetical at best and is all we have at present

The same as has been the law with Coal mines any noise, water problems, dust, environmental problems has required the proposed mine to buy those affected Lets see how keen these promotors are to buy affected peoples land rather then just rent 1 persons land and give no consideration to anyone else

In the case of huge turbines many will be affected visually but not by these other problems I know during constuction phase that jobs are created but after there is almost no one left to care for the turbines

Once the company that constructs these wind farms Who will be in charge of them? The investor is only wanting to put them up not run them they are there for the short term What happens 5/6 years down the track? Who will maintain them?

What happens when the life of the turbine is finished is the original investor returning to deconstruct these great monstrosities or is the small community left with rusting infrastructure as has been seen so often in the past

Why are we not doing more with solar power?
