Inquiry into Dental Services in New South Wales

COTA National Seniors Partnership (CNSP) wishes to bring before the Standing Committee on Social Issues a number of matters of relevance to the Inquiry into Dental Services in New South Wales.

We are gravely concerned that the State-funded dental services program has not filled the gap left by discontinuance of the federal program, which was abolished in 996. Seniors and other on low incomes are disadvantaged with public dental hospitals, either not accepting any new cases or reporting waiting lists of up to 4 years. When treatment is available it is often for emergencies only.

We are also concerned that provision of vouchers for dental services purchased from private dental practitioners has not proven a successful strategy because there is insufficient incentive for private dentists to become involved with this program.

Lack of access to dental services not only leads to poor dental health and oral hygiene but to a range of other health problems either directly or indirectly through a decline in nutrition. Poor nutrition in turn is linked to a wide range of chronic health problems.

It is the agreed policy of CNSP that a national dental and oral health plan, specifically for older Australian, both in the community and aged care facilities should be development and funded.

The national plan should:

- focus on preventative dental services
- ensure that treatment is appropriate and timely

- enable the public dental services to contract private dentists or services
- ensure that people in rural and remote areas have access to public dental services
- ensure that people with special needs including those in residential aged care have access to public dental services, and
- provide catch-up funding to clear the back-log of waiting lists for state public dental health services.

CNSP is also of the view that steps need to be taken to ensure that people with special needs living in resident aged care facilities have access to public dental services.
