I apologise for my late submission. The reason being I do not subscribe regularly to any media publications or TV.

I was employed as a Power Station Operator for 33 years in various NSW State Power Stations completing my career as a Charge Engineer at Vales Point B Station in 1992. A submission was mailed to the NSW Premier objecting to the Snowy or any thermal power station sale to receive a guarantee that no public generators or transmission system will be sold - another lie. The main reason why this sale was aborted by State and Federal governments would be a fear of election reaction in 2007 after which the sale will proceed despite the public orders to the contrary particularly if the LNP succeeds.
