

I have requested the report or at least some details from the ASNSW and they are not co-operating. Indeed, I will allege that no such report was ever made to the police and that lied to the commission.

Also of concern was an email sent by to the then Health Minister Haztigos. The email was outlining concerns that the ASNSW had spent approx half a million dollars at the time trying to dismiss me and that the funds could be spent better elsewhere. Hazxtigos did NEVER reply to that email, however, he provided it to the IRC and it was used as evidence against me and it can be found in exhibits of my IRC matter. Also, my request to Iemma that he investigate my assault which was witnessed by 2 managers within the ASNSW who gave sworn evidence (also can be found in exhibits including) and Iemma allowed Rochford to deny interviewing the witnesses and subsequently promoted to the assailant.

In addition, the IRC commissioner allowed for the ASNSW to use Illegally obtained tape recordings on no less then 5 occassions to be played in the 33 day unfair dismissal hearing. No action has ever been taken against the ASNSW for its breach of the listening devices act.

I have too many numerous well documented and verifiable incidents that I could put forward. I have sent countless evidence to John Brogden and many other ministers since. I lost faith in the system when I saw how the ASNSW and government ministers such as Hastigos and Iemma can influence the IRC and act in a manner that I thought was lawless.

I have attached a number of documents-stored on my computer from previous correspondence to the ASNSW and also Alan Jones via and John Brogden in addition i will be forwarding some emails on from my private email address which have been received from the ASNSW over time, including their most recent reply yesterday regarding my requests for crucial information I wish to present to this Inquiry which will prove the ASNSW indeed had lie to the IRC I believe. This information has still not been provided by the ASNSW in spite of being requested several weeks ago.

I would applaud and support any enquiry into the ASNSW which explores builying and harassment as I feel in my plus years I was subjected to this on many occassions. I give authority for any and all of the matters in my IRC hearing to be explored by the Inquiry committee.
