GRNSW GRADING POLICY.

It is absolutely ludicrous when a Free For All Greyhound at Wentworth Park over 520 metres, can come onto a 'B' TAB meeting over 400 metres, be classified a 4/5 th. Greyhound.

If you are a FFA at Wentworth Park, it should be FFA. on any track you race on.

Excluding distance races example 700 metres.

It is very unfair to grade a dog that has only won one or two races against a dog that has won 20 races.

Regardless of distances dogs are running, they should be classified the same grade on all TAB tracks. For instance a dog classified Free For All. at the Gardens over 400 metres, if nominated for another B grade track at the same distance, should still be classified as Free For All.

Not a lower grade because they have not won ex amount of races on that track.

There should be races classified Non Graded over all distances , for dogs four years, and above. These fine athelete's love to race. Not only that it would extend the life of the Greyhound.

I have seen Greyhounds on a race programme six years old and still winning.

I personally think the Grading Policy should be brought into suiting all racing participants and not just the large kennels.

The grading policy needs to be looked at seriously and cater for all.
