

**INQUIRY INTO REMEDIES FOR THE SERIOUS INVASION
OF PRIVACY IN NEW SOUTH WALES**

Dear Sir/ Madam,

I have been living at this rental property for eight years now, and have been a victim of intimidation, harassment, threatened, been called racist names and falsely accused on a daily basis from these neighbours, which could only be described as "Neighbours from Hell". I do have thirty six pages of documented incidents/ evidence that I have entered over the years. Despite the fact that we have been to court on numerous occasions, and have been to mediation which they were very uncooperative, and not willing to compromise and walked out.

I have recently taken out an AVO on [redacted] and had no legal representation at court where they had their lawyer. I could not afford one as I am unemployed and on Newstart. The judge at [redacted] Court was clearly not interested in my evidence, while she felt sorry for [redacted] condition. He is a stroke victim.

I could write a book on all the incidents, and would take up too much space. A few months ago, they had seven security cameras professionally installed, recording video and audio, which I believe is illegal in NSW. What is bothering me and causing me a tremendous amount of stress and depression, is the fact that three of the cameras are pointed at my property. One on my driveway, one at my lounge window and one at my back staircase and backyard. Three of the cameras on the other side of his house are pointed at [redacted] property and window. The other camera at the front is pointing at the neighbour across the road.

These neighbours have chased four previous tenants from this rental property, and their main objective is to get me to move out, and they have threatened to do so on numerous occasions. I have been falsely accused of playing loud music, playing drums on which the police were summonsed and witnessed that I don't make noise, and there are no drums in my house. I am a 63yr old Christian man, and do not engage in these obnoxious allegations. Basically, they have no friends and are hated by everyone in [redacted], whom they have terrorised through the years. [redacted] is the main instigator and has been banned from numerous shops, such as Subway [redacted] Priceline [redacted] Pharmacy and various clubs in the area just to name a few.

One incident that really traumatised me, and I could swear it looked like a demon. In March 2014, [redacted] my landlord came around to cut some branches off their frangipani tree that were overhanging onto his property. In February, a month prior, [redacted] asked [redacted] very politely to please cut the overhanging branches. On the 13th March 2014, [redacted] knocked on his door and again asked him if he was going to cut the branches. [redacted] swore at him and said he was not goin to cut the tree, so [redacted] said okay if youre not goin to do that then I will. This is when all hell broke loose! Both [redacted] came out the front and swore at him, cursing him and calling him a fu--king bastard, and hope that he dies and goes to hell. At this stage I noticed [redacted] had a garden fork in her hand, and she was shouting and screaming, her eyes were bulging out of her head and frothing at the mouth, hence the Demon! I went inside and rang the police, they arrived 10mins later and went to speak to these neighbours, then came out and told [redacted] to proceed with cutting the branches.

Now a year later, she cut all the trees down in her front garden to get a better view with all these cameras. Including the tree that she was ready to kill someone over. Every time I open my front door I get bombarded with false accusations and harassment to the highest degree. It is impossible to live a normal life and I am very stressed and depressed. All I want is to be able to live like a normal human being, and to be left alone. I do not wish to associate or speak to these people They simply have to be stopped.
