RE: Health Ministers decision to alter Yaralla Estate to open parkland

Health Minister Jillian Skinner recently in a media release welcomed a decision by Sydney Local Health

District to convert paddocks on the Yaralla Estate at Concord to parkland for "Community enjoyment".

Sydney Local Health District have announced that the thirteen hectares of paddocks On the Yaralla Estate will be converted to public parkland, without the provision of agistment for community member owned horses in the future.

This most recent move, yet again pre-empts the findings of an upper house committee which had been reviewing SLHD culpable actions to date regarding the management of Yaralla and the eviction of community horses 31 May 2013. One of the plausible considerations of the select committee was to consider the possibility of allowing the land to be used by members of the public for the agistment of their horses.

Jillian Skinner's media release also cast aspersions in regards to the political alignment of the poorly managed situation at Yaralla and the Minister of health and SLHD in doing making these decisions and statements are showing absolute contempt to the parliamentary processes due to the fact that parliament have not even announced their findings and recommendations. They are acting in complete disregard of the voiced community interest and wants. It could be hypothesised that SLHD and the Minister for Health are attempting to avoid the likely adverse findings of the parliamentary inquiry in late September by ordaining such an unethical ruling.

SLHD continue to claim that the land at Yaralla is in poor condition and a risk to the public. The basis of this conclusion was unfounded as the conclusions were reached by a blue visions report in which the parliamentary committee ruled no confidence due to the improper methods employed by Blue Visions/SLHD and the questionable alliances with Liberal party lobbyist Michael Photias and American change management firm Conrad Capital.

Once again SLHD have claimed ownership and authority over Yaralla and the community that accesses the property by executing such an unfair and knee jerk reaction to changing the use of the land which was once bequest with best intentions for shared use and purpose of health services, public open space and agistment of local horses. Once again SLHD have back flipped and are withdrawing on their promise that "Horses would always be on the estate" (Media Release, SLHD 2013). Not only have they again, reneged on their promise they are also changing the long time use of the historical site and converting the jewel of the inner west to common parkland, very unlike the 70 years of constant horse agistment that made it a unique parkland unlike any other in the metropolis of Sydney. The Dame Eadith Walker and her Philanthropist family would be disappointed and disillusioned to have watched this bureaucratic affair.

It is charged that SLHD have shown contempt to the local community people and Parliamentary process in general by the following actions:

1 Signing a questionable deal with mounted police in the dead of night and then conceding to public pressure to subsequently terminated the Heads of agreement signed with the Mounted Police Unit.

2. With their intention of preparing a new lease with MPU as a result of a rigged public tender process to award MPU as the preferred tenders they were pressured to abandon this process by parliamentary inquiry recommendations.

3 SLHD have elected to alter the historical land use without public consultation and without parliamentary inquiry direction. This knee jerk reaction is seen to be an admission of guilt, SLHD trying to yet again seal the deal for their longer term plans before parliament have reached their findings via the select committee's recommendation report due on 19th September.

SLHD and the Minister of Health seem to act as if they have a level of immunity to local laws and regulations and ethical practice. Many community members have been concerned whether there was any consultation with local council or heritage prior to the recent erection of the ghastly silver external chain wire fencing? Most local residents are not permitted to even paint our house with a non heritage colour without being forced to comply with a myriad of approvals and forms.

The recent proposal of Yaralla becoming what the health Minister coined "the Centennial park of the inner west" will require significant investment of resources in order to convert the 13 hectares of horse paddocks and undulating grazing land to parkland. Ironically, Jillian Skinner seems to a have neglected to remember that Centennial park is the only place remaining in the Sydney Metro (thanks to her beurocrats actions with removing horses form Yaralla) where horses today can still be found. Concerns have been raised by the community as to, how the health department and SLHD intend on paying for this parkland conversion of Yaralla? Additionally, what sustainable plan do they have to ensure the cost of maintenance that they have failed to uphold for the last 17 years is completed in the future parkland area? Will Yaralla become a community burden with the raising of local council rates to balance the expenditure required or will valuable health dollars be spent on tasks involving the up keep of parkland? The reasonable and rational alternative is to have returned the community owned horses into the Yaralla paddocks as this would produce an income that could be re-invested into Yaralla as it should be. It would enable Yaralla to be protected and preserved for the future and intended use with horses and public open space for many generations to come.

The facts are daunting, SLHD have continually failed in their duty of care in so many areas but more recently discovered the 200 to 300 tons of contaminated asbestos fill allowed to be dumped on Yaralla estate.

A public hearing is imperative should SLHD contemplate and attempt to mandate a change in land use.

SLHD have not listened to the community, once again they have been found to be making decisions without community consultation that affect us the public The sensory and psychosocial interaction with horses is an important part of what the local community is in Concord and we see it necessary to continue to defend and advocate that horses can be kept at Yaralla for us living in the now, for our children and many generations to come. This Estate as it has been for 70 years must remain as it was intended. Yaralla and it's horses have always been in our blood, they are the saving grace, the little slice of the simple life as we all continue to slog and fight the urban life to in the sprawling metropolis of the Inner West.

Concord is already known has the suburb of green scapes, it has enjoyed one of the largest parkland density areas compared to many neighbouring local council areas.; It is questioned, although green is always good, do we really need more of the same? Is there the risk that in years or even months to come governments of the time or future will see this "double up" of green allocated space and turn it into housing? Who will fund the unnecessary - unwanted change? Yaralla as it was, did produce a positive income separate from any impacting negative drain on the tax payer dollar The only change should be that future profits made as a result of horse agistment are to be returned and re-invested back into the estate to address some of the obvious improvements that would be required over time.

These most recent actions of SLHD and the Health Minister have been perceived as a direct and deliberate retaliation against the horse owners and the community's wishes. The issue of removing horses off the Yaralla estate indefinitely is an issue held dearly by local council, the local residents and community, local schools and local businesses. It is not just the view of a small group of horse owners or the agisters that these decisions affect is clearly affecting all the ensure community who have protested with veracity. There would be further and a rapidly growing allegiance of supporters as more and more individuals join the campaign to reinstate and return the horses back to Yaralla- the intensity of this situation will grow, we will intensely doorknock, petition, rally and attract major media to spread the alternate voce and word to that of the conflicted health beurocrats.

A plight that we are passionate about is that the Yaralla Estate must remain sustainable in order for it to remain untouched by governments and development companies. It is a huge area and it would cost a small fortune to develop as parkland, however we fear it may be considered as a small cost by future governments if the capitalist driven economy decides that Yaralla should become the next episode of the urban sprawl along the Parramatta River. Concerns also exist regarding the never ending and unimaginable funds that would be required to maintain Yaralla as a proper Parkland and not a pseudo one where SLHD leave it as is, biding time for the highest offer to sell it off. Who does SLHD really think will pay for this, Health,? The Council,? Ratepayers,? Taxpayers of NSW?.

The money and effort provided by the local horse owners and agisters has the real potential of ensuring a well maintained property with the unique heritage value and land protected and preserved at no cost to community. Local horses in Yaralla paddocks do generate positive funds, and an option involving horses in the future would clearly be giving what the community want, Yaralla and its horses as it was for all of the public to enjoy.

We request the return of the Evicted horses back to Yaralla estate and seriously put an end to this infinite path of destruction. We invite and evoke SLHD to engage in real community

consultation where by sustainable and co- created solutions to the continued preservation and maintenance of Yaralla is achieved.
