SUBMISSION: Dental Services Inquiry

There has been too much misrepresentation and un-truths put forward by the Dental and Health Departments. I feel obliged to submit this, my opinion, re the fluoridation of the Hastings Municipal Water Supply.

1. No public forums by the above departments for debate - Just told we are getting it. Letters to departments: just making that statement by way of reply, sometimes not even that. I am enclosing copy of the letters I have sent, with reply attached.
2. Fluoride being referred to as a "nutrient", then when challenged, it became "an element", when in fact it is a compound (AlF_3), and toxic waste from industry - a POISON. This POISON fact being proven by a Court case against the Tasmanian Government in 1989, with a payout of \$65,000 plus expenses to a farmer for loss of stock through fluoride contamination of his farm. Newspaper clipping enclosed. Then in Tamworth, 1968, stock poisoned again (enclosed).
3. If this forced mass medication is allowed, it is the wedge to medicate the people - even to sterilization?? Where will it end? This country then becomes a Dictatorship.
4. Dental caries are due, in the most part, to poor diet and poor hygiene. Put the dental services back into the schools, as was when I was a child; teach hygiene; have dieticians give lectures to kids - kids aren't stupid.
Further, drop the dental fees - the dentists are too greedy. They should charge a more realistic fee, then more people could afford them.

5. Put a "SUGAR" tax on all drinks and confectionery - they have tax on tobacco, and it was once on confectionery. They, the Government, can give free vaccinations. Under a means test they could do the same with dental services.
6. The health care of this nation is a disaster and will only get worse unless people are encouraged to take responsibility for their own health and educated to help themselves. Where has the knowledge of home remedies gone?
I am 85 years of age and have never had a vaccination. I know what to do to treat myself in lots of ways by prevention remedies; also I have only had my tonsils removed and cataracts done.
7. To do the abovementioned, it would take the huge profit away from the pharmaceutical companies, and THAT would never do!! Or would it??
8. I distributed petitions into the Hastings area seeking to stop fluoridation and collected well over 2000 signatures. I can assure you that very few people declined to sign.
