BRIEFING PAPER FOR THE HOLY BISHOP'S SYNOD REGARDING THE MACEDONIAN ORTHODOX CHURCH PROPERTY TRUST BILL 2010

- 1. The Macedonian Orthodox Church Property Trust Bill 2010 (NSW) was introduced in the New South Wales Parliament on 10 June 2010. This Bill is a further attempt by the Macedonian Orthodox Church Diocese of Australia and New Zealand ("Diocese") for enactment of legislation in Australia to establish a statutory property trust for the Diocese.
- The Bill has been prepared based on the examples of legislation of other Christian churches in Australia after comprehensive consultations between our legal advisors and the advisors in the Parliament and parliamentary draftsmen, in order to ensure that it is in accordance with the Diocesan Statute but also to overcome any conflicts with the views held by Macedonian church communities in Australia regarding their assets.
- The Bill provides for the establishment of a statutory trust, named the Macedonian Orthodox Church Property Trust, which will be the body responsible for holding, dealing and managing property of the Church in the Diocese across Australia. This statutory body will have the same composition as the Diocesan Ruling Committee, thus ensuring that the dealing and decision making regarding Church property will be made by the same body and in the same manner as prescribed under the Statute of the Diocese.
- 4. The Bill will significantly assist us in the administration of the Diocese as it will make it possible for property of the Church to be held by a single body with perpetual succession, thereby overcoming the difficulties in having several trustee bodies acting for the Church. The Bill will enable the Diocese to better organise the holding, management and protection of its asset base.
- 5. This manner of holding of church property is common for other Christian churches in Australia, and if the Bill is passed we believe will serve as an indication that our Church is acknowledged, organised and well administered.
- 6. Most importantly, this Bill differs from the previous attempts as it only affects four properties which, on appointment by the Diocesan Ruling Committee are held by myself as Bishop, Fr Simonovski and Fr Gulev as trustees for the Church. If the Bill is passed, these properties will be immediately divested from the current trustees and vested in the Trust. This will finally deal with our longstanding concern of holding Church property in the name of individuals and will hopefully put at rest negative public comments and attacks to the current trustees and their families for being registered proprietors of Church property, due to their trustee role not being able to be identified on certificates of title in Australia.
- The Bill has been very carefully prepared to ensure that no other properties be affected by the Bill, but there is a mechanism to enable transfers to the Trust in future only with the voluntary consent of the parties to the transfer. It is important to emphasise that there is no requirement or compulsion for any person to transfer property to the Trust.
- 8. The provisions of the Bill, if enacted, cannot be changed other than by an Act of Parliament. This not only provides protection for Church assets in perpetuity, but also it provides certainty to all clergy and parishioners that the property holding structure for the Diocese is well structured and set by statute.



- By being assisted to better organise our administration, the Diocese will focus its resources
 where they are most needed in contribution to religious and charitable works and activities
 throughout Australia.
- 10. All Macedonian Orthodox Church Communities, Parishes, Churches and Monasteries in the Diocese have been informed of the progress of the Bill and significant support has been received from most of them but also from many other Macedonian organisations that operate in Australia and support our Church with this endeavour that is of historical importance and will place our Church together with the other Christian churches with statutory property trusts. At the same time, the Diocese is working on continuous explanations to the Macedonian public in Australia that the Bill does not allow the Church to take over, compulsorily acquire or otherwise forcefully take property owned by any person, even that of churches that are in communion with the Macedonian Orthodox Church and are part of the Diocese.
- 11. The Parliament of New South Wales is currently not sitting during the winter recess and it was decided by the Parliament that the Bill be referred to a special committee for consideration and report to Parliament after having considered all documentation submitted by the Church and Macedonian community.
- 12. With God's blessing, we are hopeful for a positive report of the above committee and that after the winter recess the Bill will be enacted by the Parliament of New South Wales.


