During this time I have gained many qualifications. Basic fire Fighter, Advanced Fire fighter, Crew Leader, Rural Fire Driver, Air Base Operator. I have participated in many away firefighting teams. Many of these fires were section 44 fires. I have attended many Motor Vehicle Accidents. Some which involved fatalities. As is a rural area we were involved in fighting house fires factory fires. I have led many teams in fire and flood rescues. Working with State Emergency Service, Ambulance Service, Fire and Rescue, Police, State Forestry. many times on fire grounds I have done running repairs on fire trucks to get the trucks so that they can be used safely and not be taken off the fire ground that is to maintain them being operational. I have my service Medals. As the Rural Fire Service was a large part of my life it devastated me when I was bullied into handing in my resignation from the Rural Rare Service.

I felt I had no choice other than to resign so did not endure what and I had endured, As a result of this bulling and harassing behaviour I myself became depressed as I had lost something that had been a large part of my life for many years. I ended up seeking help from my GP whom commenced me on antidepressant medication and I remain of it to this very day. Although this treatment has helped I would like some closure as I feel that there are things that have not been addressed to my satisfaction resulting gaining me some closure to this adversity.

I am writing to you today as upon reflection during the period since my resignation from the Rural Fire Service I find that I continue to be unable to accept and resolve the events that led to me feeling that there was no other way but resign from the Rural fire Service. The Rural fire Service had been a large part of my life. It was my way of giving back to the community in which I live.

This is my submission. It is my hope that other people that have been bullied and harassed in the Rural Fire Service join me in lodging their submission as well

It was after this incident that I found myself having several complaints made against me. I am sure that it was

. They were leading a vendetta to rid the RFS of myself and my family.

As a result of these complaints the RFS made the decision to hold a hearing for me to have a 'voice' and answer these complaints. I had with some assistance written responses to these complaints. You have a copy of the RFS documents and a copy of my responses.

Before the hearing had commenced I handed my written resignation which was effective immediately.

The panel of this hearing chose to go ahead with the hearing. I thought at the time I had no choice but to let them continue with the hearing.

My wife was with me as my support person. She was told that she was not able to speak. At this point she did say that this was nothing but a Kangaroo Court.

With reflective and mindful consideration I have questions that I need answers to in order for me to move on from this disgusting end to a very long career of volunteering in the RFS.

- I have never been given copies of the original written complaints. I have verbally asked for copies as well as my solicitor.
- 2. My resignation was effective immediately. Why did the hearing go ahead?

- 3. I was given a penalty. I had furnished them with my resignation. Can a member of the public be given a penalty?
- 4. Why was the video camera only on me?
- Why was there no independent person on the panel? The panel consisted of all RFS people.
- Why was my wife not allowed to speak as she was my support person? I was upset and not able to think as clearly as I normally would.
- 7. Why was the appropriate training not provided
- Why was the zone manager not on the panel? Why did he not investigate the complaints? I feel he lacks people skills.

During the whole of this process commencing with what they put through and then myself I felt targeted, bullied and harassed.
