While we are sometimes frustrated with the complexities of entering the Centre, we understand the need for security and appreciate the courtesy and patience of your officers. They are always both polite and thorough and as a result, we feel safe knowing that they are watchful and aware of risks and dangers.

In all situations, there are times when things happen that make activities more difficult. Those in charge at Parklea have always been available to hear our concerns and make alternative arrangements if possible. In cases where changes could not be made due to security or operational concerns, a satisfactory explanation has been given.

The training given to us before being approved for entry appears a little excessive being based on contract worker needs, but it does provide a thorough insight into the risks of working inside a prison and the dangers to avoid.

I love that the officers appear to be interested in and supportive of what we are doing and make our visits pleasant in spite of the necessary thorough searches of our equipment. In response, we try to keep ourselves and our equipment as ordered and visible as we can to make their work easier.

In short, it is a pleasure to present our courses and ministry in Parklea Area 4.

I have been a participant within the Kairos Prison Ministry since 2001. In that time I have served on Kairos teams in many prisons as a Team Leader, Team Coordinator, musician and regular team member. I am also the NSW State Chair for Kairos and as such get to see what teams experience in most prisons within NSW.

My experience in working with the GEO Group at Parklea Correctional Centre since Kairos first ran a short course program within the prison, some three or so years ago has been one of the more pleasing experience when compared to other prisons that I have worked with.

Entering a prison can be an intimidating experience for an outsider, however, the staff of GEO managed to always convey an atmosphere of safety and a secure calm, despite the potentially aggressive setting that is common within the prison environment.

I have always found the staff to be friendly and polite, albeit totally professional in our interaction together. The staff engagement in supporting our program has always been helpful, polite and proactive, enabling us to get our job done with a minimum of fuss and a maximum of impact.

This interactive prison environment that we find ourselves in, has many potential areas that could bring us as a team unstuck and at potential risk whether it be from the inmates or from the correctional services system. Here again is where GEO's systems come to the fore. GEO's methodology of training us as a team and their ongoing checks, assists all members of the team to know exactly where they are and what is expected from them.

Whether it is the Short Course or the ongoing Journey Program, there is always a large amount of equipment to be taken into the prison as part of the Kairos activity. We understand that searches are part of the day to day norm. GEO's procedures of checks and balances prove to be interactively efficient, and still create the least amount of stress on those involved.

In conclusion I have enjoyed, and continue to enjoy working with the GEO Group at Parklea Correctional Centre because of their professional and courteous approach in all that they do.

To the Upper House Committee,

My name is Phillip Simpson, I am writing to you about my experience with the GEO group at Parklea CC.

I am the current leader with the Kairos Prison Ministry that attends Parklea CC Area 4.

We come in under the invitation of the Chaplain and GEO to hold a 3 1/2 day course on Christian Living, twice yearly.

This is followed up every fortnight on a Tuesday at 5.30pm - 6.30pm to run a follow up program which is called the Journey.

I have been involved with this ministry in Area 4, for the past 2 years. During this time I have never felt uneasy or threatened in any way. The inmates who attend each fortnight vary from in number between 8 to 18. Their behaviour is one of courtesy and respect. They are engaged in every aspect of the program and are thankful for us being there.

Security and Training: All team members prior to being involved, attend a 1 day security course run by GEO. This is very informative and helpful for each team member to know what is expected and how to respond to different situations. This is followed up each year, as there is a requirement to do the online security course run by GEO before we enter the facility.

When we enter the facility each time, we are required to present photo ID, and names are checked against a list by a GEO officer of those who have been cleared by intel to enter the facility. Each team member has the the metal detector waved over them. All equipment which has been approved to be taken into the facility is then searched by the officers. At all times the officers have always behaved professionally and with diligence, while always being courteous and respectful.

We are always treated with respect from the Hierarchy of GEO down to the officers in charge of area 4.

Prior to each course we have a meeting with the MOS and Programs manager. At the moment these people are Jaqui Geveke and Alison Lang We discuss the details of the upcoming short course, including any security issues and submit detailed lists of equipment we can bring in to be approved by the General Manager Peter Ma'a We also have a debrief meeting a week after the course to discuss how the course went and the response of the participants, and give feedback as well as to discuss any concerns that may have arisen during the course.

The GEO management at Parklea and their staff have always been helpful, supportive and professional. I have appreciated the extent to which the Management and staff have supported Kairos, to the extent of coming in to see what we do and how the participants are responding.

Feedback we have received from the last course was very favorable. One comment from the staff in Area4 was, how the behavior in the compound had changed for the better.

I am thankful for the ongoing support of the Kairos Prison Ministry given to us by GEO.
