If this larger complex is complete, the Trust has stated that it can then hold an extra 20 large events per year!

Unfortunately, the Trust refuses to acknowledge the chaos and gridlock that local residents are currently subjected to when a major event is held. To increase activity means more frustration. It's totally unfair, as many residents have lived in the vicinity for many years, long before this area was turned into an entertainment venue, and, as we now have an independent politician representing the seat of Sydney in the State Government, we feel we do not have the right of opinion from this current State Government. Obviously, The Sydney Cricket & Sports Trust have little concern of our local issues, being more focused on enlarging their entertainment venue to maximise their stadium whilst they have the opportunity of a 'like minded' Minister for Sports supporting their claims.
