Please find my comments on the Inquiry into the impact of WestConnex based on the Terms of Reference as follows.

I agree to my name being published.

(a) The adequacy of the business case for the WestConnex project, including the cost-benefits ratio

There is no case for Westconnex. It is just apart of the LNPs agenda to appease its political donors and disregard the wellbeing of the people of this state. The LNP are city planners worst nightmare.

(b) The cost of WestConnex project, including the size and reasons for overruns

Its ridiculous! Plunging the state into 17 billion dollars worth of debt over saving residents of Liverpool 15 minutes to get to work? Having toll roads that extend well into the future (beyond 2050)? (f) The extent to which the project is meeting the original goals of the project as articulated in 2012

(g) The relationship between WestConnex and other toll road projects including the Sydney Gateway, Western Harbour Tunnel, F6 and Beaches Link

(j) Any other related matter

It is an environmental disaster as well as a poor, 1950s solution to Sydney's congestion problem. On top of that, the statistics that the Berjikillian government provides is in fact incorrect.
