#### FMA Submission - Inquiry into the Water NSW Amendment (Warragamba Dam) Bill 2018

Floodplain Management Australia (FMA), formerly Floodplain Management Association, is grateful for the opportunity to make this submission to the Standing Committee Inquiry regarding the above. The purpose of this submission is to provide comments concerning the flood mitigation role of Warragamba Dam and the proposed raising of the dam wall.

Natural disasters are costing Australia over \$560 million a year, and flooding from rivers and local catchments is the costliest and yet most manageable of natural disasters.

These impacts will inevitably worsen in the future with the effects of climate change. The forecasts are for increases in rainfall intensity which will increase the prevalence and severity of flooding, and the associated risks to life and damage to private property and pubic infrastructure.

### Floodplain Management Australia

FMA was established in 1961, following the disastrous floods of the 1950's, to support and promote best practice in floodplain management across NSW. #### Raising the Warragamba Dam Wall to Provide Flood Protection

FMA has previously provided comments on proposals to reduce the very real risks of catastrophic flooding to communities of Western Sydney, and has been pleased to provide input to development of the Hawkesbury-Nepean Valley Flood Risk Management Strategy.

At present over 60,000 people occupy the floodplain downstream of Warragamba Dam, and whist there are some actions which can be taken to marginally reduce the risks, it does appear that the only viable strategy for providing an acceptable level of flood risk by raising the wall of Warragamba Dam.

FMA's position concerning the need to raise to dam wall to provide an acceptable level of community safety is stated in the attached Press Releases dated 17 June 2016 and 8 May 2017, and is reaffirmed.

## Warragamba Dam Plan Applauded

17 June 2016

Australia's network of flood professionals, Floodplain Management Australia (FMA), has applauded the announcement by NSW Premier Mike Baird that his government plans to reduce the flood risk to the Hawkesbury-Nepean Valley by raising Sydney's Warragamba Dam.

FMA President Ian Dinham said that the Hawkesbury-Nepean Valley has a flood prone population of 73,000 people for whom appropriate emergency management and recovery arrangements must be developed.

"The parts of Windsor, Richmond and Penrith have long been recognised as being at serious risk in the event of major floods, and FMA has been pleased to contribute its expertise to the Hawkesbury-Nepean Valley Flood Risk Management Review" said Mr Dinham.

"An enormous amount of work has gone into the review process over the last four years, and we congratulate all who have been involved in completing this very complex and thorough review.

"The strategy represents an important milestone for flood risk management in Australia. It is satisfying that the NSW Government understands the seriousness of the flood risk, and is committing funding not just to further planning and studies for the dam, but also to immediate improvements in emergency response and evacuation arrangements.

"Climate change forecasts indicate that the likelihood of flooding will increase with rising global temperatures. The threat of flood is not dissipating - flood risk management projects like this must be supported."

Flooding is the most costly, yet manageable of natural disasters with recent estimates costing Australia over \$560 million a year.

# **Praise for Hawkesbury-Nepean Flood Strategy**

Floodplain Management Australia (FMA) President Ian Dinham has praised the newly released Hawkesbury-Nepean Valley Flood Risk Management Strategy saying it is a significant step towards improving the safety of Western Sydney communities.

"The Hawkesbury –Nepean Valley is home to over 60,000 people who may need to evacuate in a major flood, and that number is growing every year. Alarmingly many of those residents are unaware of the risk, or what to do when a big flood does occur.

"The theme of FMA's National Conference in Newcastle next week is "Preparing for the Next Great Flood", and this is exactly what this Strategy is about" Mr Dinham said.

"This year is the 150<sup>th</sup> anniversary of the Hawkesbury-Nepean River's great flood of 1867. If this flood were to happen again this year an estimated 5,000 residential properties in parts of Windsor, Richmond, Penrith and Wallacia would be affected, some with water over their roofs. As we have seen with the last month's floods in northern NSW and Queensland destructive foods still do happen.

"It is satisfying that the NSW Government has thoroughly investigated the flood risk, and now understands its seriousness. An enormous amount of work has gone into the investigation over the last five years, and FMA has been pleased to contribute its expertise to the process. We congratulate all who have been involved in completing the review" Mr Dinham said.

"The strategy and its recommendations represent an important milestone for flood risk management in Australia. The suite of recommendations including raising the height of Warragamba Dam, managing future flood risk through wise land use planning, and developing an aware, prepared and responsive community will set a standard for flood risk management in Australia.

"Climate change forecasts indicate that the likelihood of flooding will increase with rising global temperatures. The threat of flood is not dissipating - flood risk management initiatives like this must be supported."
