## INQUIRY INTO REPRODUCTIVE HEALTH CARE REFORM BILL 2019

I, am currently an elected councillor for the Campbelltown Local Government. On behalf of my constituents, I make the following submissions regarding the 2019 NSW abortion-to-birth bill:

After reviewing this bill, I along with my constituents are greatly concerned and call for this bill to be rejected immediately or failing that, amended reflecting the following points of concerns:

- 1) This bill legalises abortions, including late-term children after 22 weeks of conception.
- This bill would legalise abortions for the selfish reseason/s of sex-selection. This basically means a healthy child could be aborted by its parents simply because the parents prefer a specific sex of a child, being male vs female. Where does that sit with gender equality?
- A 16 year old child can undergo an abortion procedure without the mandatory reporting being made to the Secretary of the Department of Communities and Justice. We have all been 16 or have children who are 16. Do you want to place that kind of responsibilty on a 16 year old child who woud be suffering from an unbearable amount of stress without sometype of intervention?
- 4) Counseling is not mandatory, which might provide females to make an informed decision based on all available options. We've all had to make a hard decision at some point of our lifes, and we all know that it would be unfair if we make that decision and found out later that there were other options aviable to us that we would have considered.

Whilst the above four points might appeal to your logical side, I think it is more important to also appeal to your human, good, reasonable and kind side.

A human life has a right to exist both prior to and post-birth. One can sit down and debate on hours on end, as to the definition of when a child is considered to be alive, but if aperson of resonable faimness takes the time to personally reflect on this question, you and I know that once a child can move, grow and feel (emotionally or physically) it has life. If that is not life, then i dont know what that is.

The only difference is that unborn child can not defend itself or make a choice for itself. One can argue that as the child can not make a choice for itself, then it is the responsibility of the parents to make these choices on the child's behalf. But where would you draw the line? Would you allow a parent to terminate their 1-month-old born child because they discover that the work of caring for a child is too hard? What would your stance be, if someone tried to pass a bill legalising a next of kin the authority to euthanise that ill or deceased person without their consent, simply because they can not fend for themselves, make a decision regarding thieir existence or the emotional/financial burden this may impact on their next of kin.

Unfortunately, in todays day and age, the media has norallised the term "abortion" removing one's ability to comprehend and actually reflect as to what we are actually asking to do. Whilst some might argue that these may be a harsh use of words, I woud say that it is realistic to define "abortion" as "the mass-murder of helpless children who can not defend themselves or voice their own concerns by those who are meant to love and care for them" I can not think of anything more selfish.

I don't envy you for having to make this decision of approving or rejecting this bill.

I am sorry that you are the person that has to make this decision as i have no doubt it is a hard one.
