## Re Provision of the Right to Farm Bill (NSW) 2019

Dear Mr Banasiak, It has recently been bought to my attention that new laws preventing peaceful protests will soon be introduced, in terms of 'workplace' locations. I find this comparable to the AFP raids on journalists & whistle blowers. Without these brave individuals (especially whistle blowers) there can be NO democracy, it is the linchpin to a functioning impartial secular /democratic system. Prime Minister Bob Hawke made the right call , which is acclaimed and praised to this day.

The magnificent pristine forests of the North East (NSW) like Terrania Crk & Protesters Falls were saved ONLY due to prolonged protest camps in these threatened native forest areas. Agricultural corporations (most aren't small farm holdings) are not genuinely concerned about Bio security threats but are doing their best to conceal the cruel reality of their farming practices. Animal welfare groups are non violent, just like ecological NGO's and refrain from violent activities. Farmers have not been hurt (ever to my knowledge) their properties have NOT been damaged, they have not entered private homes or hurt individuals. Their purpose it to alert the public to what is hidden from view. Some things are far more important than profit...like Free Speech and compassion.
