THIS IS ONE BREEDERS LIFE AT THE HANDS OF RSPCA'S ACCUSATIONS OVER 30 YEARS.

I HAVE OWNED ANIMALS ALL MY LIFE & BRED DOGS FOR 50 YEARS, 35 YEARS AS A REGISTERED BREEDER WITH DOGS, N.S.W. - HAVING NO PROBLEMS.

FOR 20 YEARS RSPCA HAD BULKED INSPECTIONS BY ME OF ALL DOGS ON PROPERTY. NO CLARIFICATION WAS EVER GIVEN OF INSPECTION TAKING PLACE - THEY DON'T LIKE BEING ASKED ASKED FOR SUCH THINGS.

AFTER 20 YEARS OF LIES & DECEIT, I ERECTED THIS SIGN AT ENTRANCE TO PROPERTY IN 2010. EVEN THIS DIDN'T DETER THEM. ON 7-7-2011 RSPCA ARRIVED SO I CALLED POLICE TWICE - BEFORE THEY WOULD COME. AFTER THIS INSPECTION POLICE SAID, "RSPCA ARE POLICE WITHOUT A GUN", RSPCA & POLICE DO NOT GET ON - AND THE POLICE SAY NOTHING WHEN THE RSPCA ARE INVOLVED.

ON 5TH APRIL 2019 RSPCA ARRIVED, I REFUSED ENTRY, THEY CAME BACK WITH POLICE & SEIZED 4 ADULT DOGS 10 TO 14 YEARS OLD. AGAIN POLICE STOOD BY LIKE STATUES AND RSPCA DID AS THEY WANTED.

ON 15TH APRIL 2019, RSPCA RETURNED FOR ANOTHER INSPECTION TO TAKE REMAINING STUD DOGS. THEY TOOK 2 STUD DOGS 6 & 7 YEARS OLD & 3 FEMALES (10+ YEARS OLD PENSIONERS)

THEY ALSO SEIZED 3 CORRELLAS & 1 COCKATOO BECAUSE THEY WERE NOT FED FRUIT & VEGETABLES.

THE REASON FOR TAKING ALL STUD DOGS WAS
TO STOP ME FROM BREEDING. THEY LEFT ME WITH
12 BREEDING BITCHES - THEY HAD NO INTEREST IN THEM,
AS I CAN NOT GET AN A.V.O. OR COURT ORDER
TO KEEP THESE FOOLS OFF MY PROPERTY & POLICE
ARE OF NO HELP, IT LOOKS LIKE I AM LEFT TO
PROTECT MYSELF. AT 62 YEARS OF AGE IF I HAVE TO
GET A CRIMINAL RECORD, SO BE IT.

PLEASE FIND 2 VET REPORTS FOR DOGS
RSPCA DEEMED AS SICK.

NOTE NO GATE ON PROPERTY - IF I HAD
SICK, DEAD OR DYING ANIMALS, I WOULD NOT
HAVE OPEN ACCESS.
