This submission has been prepared by Directors of the Darug Custodian Aboriginal Corporation (DCAC).

Our interest in the submission for involvement into this inquiry draws primarily from our cultural connection as First Nations People and custodial role in providing extensive services and advice to a wide range of organisations (including Local and State Government, Education, private, public and community sectors) across the Sydney Basin to:

- 1. Maintain a custodial role in the protection of Darug sites and places,
- 2. Maintain a custodial role in relation to Darug cultural knowledge and traditions,
- 3. Promote community awareness and understanding of Darug culture, and
- 4. Provide an open venue for Darug descendants to discuss and negotiate matters relating to Darug people, land, and culture.

Although our primary focus is on the Darug people, land, and culture we extend this respect, advocacy and acknowledgment to all Aboriginal people, their countries, and continuous connections. As traditional custodians of the Sydney Basin, having a proven history of experience and understanding in Cultural Heritage protection, conservation and preservation works our involvement we will beneficial to not only Museums and cultural projects within New South Wales but to the ongoing education and preservation of all Aboriginal Cultures.

We would welcome the opportunity to discuss any aspect of this submission further with the Select Committees.

When addressing the Terms of Reference, Darug Custodian Aboriginal Corporation would like to put forward some suggestions and responses associated.

1a(v) the impact on the of the site at Ultimo and heritage items at Willow Grove and the Fleet Street precinct at Parramatta.

At the Willow Grove site there is a tree of significance to local and surrounding first nations (Aboriginal people). This tree is significant to the connections, travel, and gatherings across Aboriginal lands. If not for the entire site, then just the tree, it is important and critical for it to remain in situ. Aboriginal peoples' connection to our environment is of utmost importance. We believe we are one (part of who we are and our identity) and united to our natural surroundings, not only the physical but spiritual level; therefore, to remove would be a devastatingly painful event for Aboriginal people.

1a (vi) the use of the proceeds from the proposed sale of the site at Ultimo.

Recommendation/s put forward include designated amounts of the proceeds be utilised or held in trust for:

- Future cultural projects and programs to increase the custodianship and/or assist in the reclamation and rejuvenation of cultural practices within Aboriginal communities.
- Assist in the establishment of community keeping places in and for local Aboriginal communities in the acquisition, maintenance and preservation of their own collections that will remain on Country.
- Assist in the repatriation of cultural objects back to the traditional people and Country.

1b(ii) whether there is equitable access to collections across New South Wales, including at the Powerhouse Museum and the Australian Museum.

Currently, we do not believe that there is equitable access to the collections across New South Wales. Whether it be through the Powerhouse, Australian or other museums including collections held by the Local Aboriginal Land Councils, access to these collections is quite hard for people to attain. Recommendation such as providing allocated days and times would open the opportunities for people to access certain areas of collections with minimal procedures without compromising security issues. In perusing this recommendation, it will also eliminate or minimise the fear of illiteracy issue that many first nations people endure.

1c) Recommendation put forward that Mr Ken Wyatt, Minister for Indigenous Australians, has a seat and invited into the committee to assist Aboriginal and Torres Strait Islander people and communities to have a "voice" in legislative council and issues that directly relate to not only governmental policies but the traditional protocol and protection of cultural items/projects and their significance to Aboriginal people through connection to land, spiritual or physical, and the educational purposes of all Australians.
