WATER will be separated from the land and traded like shares in an effort to allow effective and efficient water trading in NSW, according to recommendations made by a Department of Land and Water Conservation Commissioned report.

VICTORIA consulting economists Marsden Jacobson Associates were retained by the DLWC to prepare the report into water trading development and monitoring, which was released two months ago.

Under the proposed new trading framework, water entitlements could be held by any person or entity.

"They will not need to own land or other water. Water will be treated no differently to SHARES or LAND (and Is) then seen as an asset."

The report recommends that the Water Act and regulations be amended to separate ownership of land from water.

However, these aspects of the report have alarmed Murrumbidgee Valley Water Users Association president and retired rice farmer Jim Mc Gann. "The separation of water from land is a dangerous move in my belief, "(The report) cause nothing but concern to me and I believe people in the community should take it on board".

Mr McGann said he is concerned about how the recommendations will affect the value of irrigation land across the region.

"How can you trade something that comes from the sky?

"It is unbelievable what the bureaucrats and economists are doing to people west of the divide, and we're just have to accept it.

*Re floodplain Harvesting .... The question we should be asking in regard to rain. Who owns the rain?*

## River runs dry, it's not cricket

JUST as floodwaters look likely to send a flush of water down the Darling-Barwon system, the plight of the river has been highlighted by western leaseholders.

The photo was used by Greens MI.C Jeremy Buckingham to highlight the lack of environmental flows down the famous river system last week.

But nothing is expected

to change when the floodwaters come down to NSW, with the flow only expected to get as far as Bourke.

Last week, the NSW Dcpartment of Industry - Water announced temporary restrictions on A, B and C class water access licences in the Barwon-Darling Unregulated River to protect valuable low flows entering the river. The restrictions have been deemed necessary as during the last two months, multiple locations along the Barwon-Darling Rivei, such as Bourke. Louth and Wilcannia, have experienced no flow conditions with water in pools and weirs rapidly depleting."

Tilpa locals are planning a cricket match on the dry hed next week.
