"What is floodplain harvesting?

Floodplain harvesting is the capture and use of over land flow water flowing across a floodplain during a flood. Irrigators everywhere in NSW (north and south) capture over land flow water as part of their works approval requirements to capture rainfall on farm to mitigate environmental impacts. Farms are specifically designed for this purpose.

Irrigators on floodplains have flood protection works designed to exclude overland flow to protect their crops, homes and farm infrastructure from damage.

It is not true that irrigators everywhere in NSW capture overland water.

Further on they claim in a later paragraph. "Farmers have had access to overland flows ever since the Water Act 1912 NSW. I disagree. That Water Act does not give anyone the right to take any water that does not belong to them. Overland flows do not belong to them.

Sadly, within that document there is no acknowledgement how they can help the environment recover from the devastation FPH has caused.

The full document should be read to see how the facts can be distorted. Sadly many believe these "alternate facts".

Please remember my original question when considering every submission: How much damage has been done to the environment and ecosystems of the Darling-Barka River and it's tributaries, and many Anna Branches by flood plain harvesting?
