***My submission addresses abuse of  
Water systems in the central west &

***It covers unmetered theft from my private  
Riparian System Pipes at Mudgee NSW for  
the past two decades. This riparian system  
is cunningly unmarked on any maps  
& my problems first surfaced alarmingly  
when Satellite mapping was introduced.  
I am dealing with water theft unmetered,  
fraud, criminality & theft of my water  
Licence attached to my land at Mudgee as per  
Gipa Report.***

up of some of the 250 page Submission I made  
2018 with a few updates to MDBRCSA.***

***I request a time to attend your Hearings & in the  
meantime a way of getting all of my deeds, documents  
& reports from many politicians, surveyors, LPI,  
Searchers & Gipa Report from Water NSW to you.  
Also want to produce evidence of the involvement  
of NSW Law Society & mafia solicitors involvement in  
producing unsigned Land Transfers & fraudulent  
surveys etc & stamped illegally by Land Titles  
Finance. Also the removal of deeds & Farm Water  
Act Deed 1946 part of my folio of deeds in my possession  
Also I wish to make a statement of complaint about  
NSW NRAR & coverups in last two years as well as involvement  
of NSW National Ministers Paul Toole & now stood down  
Troy Grant who was my local member & was notified  
of every fraudulent matter & completely ignored my complaints  
for almost a decade.  
I believe it would be a conflict of interest for Grant to have  
any interest in NSW water theft.***

### SUBMISSION TO NSW Upper House Parliamentary At the Murray Darling Basin Authority meeting in Albury INQUIRY

Mr Justice Walker Commissioner & the people of the Murray Darling Basin.

My name is PAULINE CARR from Mudgee in New South Wales under the umbrella of Central & Far West Murray Darling System Macquarie Catchment and this is MY STORY. I am a sixth generation Ozzie – my family having settled in the early 1850s on the land and we are now eight generations there.

I live in the area of the Meeting of the Waters where the Cudgegong River joins the Oakey Creek, Redbank Creek and Lawson Creek - one of the richest supplies of water in the Great Artisan Basin.

My property is between Lake Windemere & Lake Burrendong. My home is actually right where The Rivers meet.

This story sets a Historical Precedent in regards to Water Theft and has tentacles all over the world when in my personal research and experience there was a plan put in place around 1969/1970 to take control of the Riperian System and Water Supply in the Mudgee area. Surveyor who set this in place fled Australia.

I have provided to the Murray Darling Basin South Australian Royal Commission a 250 page Submission and Witness Statement in late March 2018. This Submission is the result of at least 15 years of work and research. State Water NSW 2ic validated my assertions in a Gipa Report of 2016 commenting that nothing in Surveying fitted together and one Surveyor confided in 2012/13 that the main dadum peg he had to work off had been moved one foot by a surveyor with a vested interest in the land near my water asset.

In 1986 I purchased riverfront land in the area previously described from the Mayor of the time of Mudgee Shire Council. When I inspected the land I was purchasing I was shown a Riperian System put in place by the Owner and there was an oily old black Lister Pump on the riverbank. There was a pump house on a concrete block on the land I was purchasing. The Owner pointed out to me the pipeworks in place – two 4" encased in 8". All validated by two NSW Senior Police Commanders.

I agreed to lease the Riperian System back to him as I would not be using it until later years – my super.

I went ahead purchased the land but could never obtain a drawing of what I was purchasing from any authority Local Council or NSW Govt. In my Research I have found false land transfer unsigned & fraud surveys on paper maps. With the introduction of Satellite mapping my problems really began.

I have lived alone for many years and went on working and minding my own business.

Around 2004 I became a target and found it hard to understand why I was being stalked by a surveyor who lived nearby and then to experience all types of harassment, threat, bullying & nuisance on my person including between 2004 and 2015 having five attempts on my life – all recorded in my Submission and by being chased by the now General Manager of my local council.

I attempted to report these matters to local Police and was constantly dismissed and then for a decade I tried to get the newly appointed Mid Western Regional Council (who had been in Administration) to assist me. There are at least one hundred recordings of ongoing abuse listed and reported to every Local Government and State Govt Dept in NSW. Police would never deal with the Council non compliance or charge any person for the most despicable acts. Pelted with my fruit off my own trees, mud thrown all over my home, theft almost weekly of my clothing from the clothes line, explosives detonated to destroy the pump shed, shot at through my laundry window, attempt to mow me down by motorbike, verbal abuse on a daily basis & my car interfered with. All listed with official complaints in the dozens of letters to every possible authority in NSW. Dismissed.

The perpetrators of these acts which my Research I believe reveal to be criminal, thought that I was an easy target as I was ageing, living alone and would never carry through to find the cause of this abuse. WRONG.

Once they started this course of action it was going to be difficult for them to stop so on and on it went till I was forced out of my home and property over <sup>8</sup>four years ago to a safe house. Even though these perpetrators knew the little older lady did not respond as was expected – I began to fight back in 2012. By this time it was clearly evident that the reason was to kill, maim or dispossess me of my assets. Perpetrators are named in my Submission to which I again draw to your attention. The consequence for me was always going to be an increase in the level of abuse.

These acts were coming from the highest in authority in Local Government, mainly Nationals in State Government who have all had personal dealings with me including my local member Police Minister of NSW, the past and present Local Government Ministers of NSW, Water Ministers Humphries & Page, the LPI or Land Titles Office, Head Surveyor of NSW and many in the Judiciary (named) abusing me. My research proves this is fact.

Well I am here to tell this Community Forum and the residents of NSW that I am still here and will not be leaving my assets or interests any time soon. I am an honest and now tough minded lady & within my very extensive Submission all details of the extent of water theft, attempted land theft, false surveying from the late 1960s to 2015, illicit trading of my water licence attached to my land by a Lawyer who did no Searches as to the ownership etc for the gain of water thieves.

In all my matters, research of the past ten years criminality looks to be in play and in Mr Jay Weatherill announcing this Royal Commission finally a State can have its own say and in his extending the terms of Reference other States are answerable for their actions regarding water theft.

\* There can never be any balance within the Murray Darling Basin Water Catchment when right at the beginning of the catchment from the Dunn Swamp near Rylstone NSW through to the Macquarie River this water theft has been perpetrated all unmetered through private pipeworks. It has gone on for so long that when I engaged persons ie Consultants, Water Diviner Pipe Locator and local farmers who understood my problems my house was subsiding. I went public on social media and spoke to a couple of local Councillors in my Council and the water theft ceased overnight with Council GM announcing that two of their pumps had to be shut down & water restrictions were put in place for me to find every piece of my land was affected by sink holes, cracking, salinity and my home then

physically sunk in at least one foot of raw sewerage. I've had between 10 and 15 ecoli infections in a Council area where there is no Health Inspector. Total dismissal by all in authority & I refer to Terms of Reference 8. Photos here for the perusal of all in attendance.

An amount of water stolen for at least a decade UNKNOWN. Loss to me one could never fathom.

\* Full Investigation into NRAR officers. Dodgy. Told by officer Dubbo he wished he could have done more to assist me. Stifled by big boys & mafia Nats & LG Mudge. Said he was not able to dig into my property to inspect my pipelines because they were private. I will give more evidence to you regarding these serious matters. Criminality in NRAR - Troy Grant - Mick Healy all covering over 2 decades of unmetered water from my allocation & private Riparian System.
