

## Be careful using visual descriptions of disease risk

It can be tempting to use visual aids to describe the risk of disease. For some people, a visual representation can be easier to understand than words alone.

However, be aware that people can interpret visual information in different ways, which may result in unintended consequences. Take the example below:

The first exposure of asbestos was in 2016. With continued investigation and "DoE band aid solutions" which confirm a minimum reading of 0.01ml /gm

We have over 1800 students attend this school daily

- a. 7 hours per day x 5 days per week. = 35hrs per week
- b. 35hrs x 10wks per term = 350 hrs per term
- c. 350hrs x 4 terms = <u>1400hrs of continued "low exposure" per year</u>
- d. Teachers attend this school and spend more hours per day than students
- 3. From various Air Monitoring operational reports during 2019 to 2021
  - a. I conclude that air monitors have been in operation from 2019 for approximately 1-4hours per day costing the NSW Government over \$470,000
  - b. Reference to Australia Safety and Compensation Council review report 2008 page 9 <u>"Consequently, it may be most appropriate in the absence of more definitive information to</u> <u>assume that there is no safe – or threshold - dose of chrysotile and other forms of asbestos</u> <u>fibres".</u>

1.2 TOTAL SAMPLE DURATION AND NUMBER OF SAMPLES Sample duration is influenced primarily by the reason for sampling, the level of fibre concentration to be measured, the concentration of non-fibrous dust and the requirements of the analytical method. This may result in more than one single sample being required. The Total Sample Duration should never be less than four hours, and preferably over an entire shift.

c. <u>Can the NSW Government Department of Education please explain – Why are air monitoring</u> <u>devices in operation for under 4hrs and why sampling duration is not conducted for the</u> <u>entire shift over all 5 working days during school week ?</u>
