### 5. Animal Welfare and Human Safety:

The welfare of animals subjected to aerial shooting must be a paramount concern. Additionally, the safety of humans within Kosciuszko National Park during these operations should be thoroughly evaluated to prevent any potential harm.

6. Impact of Previous Aerial Shooting Operations:

The impact of previous aerial shooting operations, such as the one in Guy Fawkes National Park, should be studied to understand the consequences and lessons learned from such actions.

7. Exploration of Alternatives:

Efforts should be made to explore and implement alternatives to aerial shooting, including nonlethal controls and management strategies that prioritize both animal welfare and conservation.

I believe that a moratorium on all killing should be considered as an immediate step to prevent further suffering and allow for a comprehensive examination of the issues at hand.
