- Clearly the current policy which allowed for the Bowden's mine approval is inadequate.
- This approval needs to be revoked until the policy is fit for purpose. If this inquiry is to be meaningful, then recall the recent approvals and submit them to a policy that is appropriate to a first world country in 2023.
- Cadia 3 years to admit there is a problem.
- 3 years for the EPA to investigate water contamination and dust pollution.
- Boggabri Coal Mine 5 years water theft.
- Tarago Rail 5 years failure to notify the residence of Lead Contamination.

## The DPE and IPC has given insufficient attention to the presented scientific evidence of The Bowdens Project.

They have completely ignored the potential, almost certain, harm to human life and the catastrophic environmental damage to the Lawson Creek, the Wildlife and the Biodiversity of life in our country.

- The Community have the right to live in a safe and healthy environment.

- Children are attending school, 5 days a week, 6 hours per day, 2 km from the mine site.
- There will never be enough procedures that will protect the lungs of the future generations from a heavy metal mine.
- The effects of lead poisoning are irreversible.
- Lead is extremely toxic,
- There is No safe blood levels of lead exposure in children, no safe blood levels have been identified as safe.
- Our government or Bowden's have No Right to take away a childhood's finest moments.
- The precious moments of children is the most beautiful of all life, mud on the face of a child, dirt in their hair and on their hands free of Lead and heavy metals
