
Methodology-Inaccurate data and lies

There was an impossible biological increase in numbers of brumbies in the KNP- this is contested by locals. The person doing the 'research' has a business and is paid for his inflated numbers. Carcass Management

Brumbies are being shot and their bodies are being left around to feed wild dogs and pigs. We already have a pig plague in NSW. This seems counter intuitive but they might be using 1080 to poison the predators. There is plenty of evidence that 1080 has secondary poisonings and native animals might be at risk.

Inhumane and cruel- Standard Operating Procedures

Brumbies do not die instantly. There is plenty of evidence that the SOP are not followed and that brumbies need 3 shots - many are shot and disabled and die a slow lingering death without being able to feed or drink. Foals are aborted and before they are born have their emerging faces chewed off by predators. Other foals are born and starve to death.
