I am Traditionally connected to Kosciusko Mountain Range, And My strong Indigenous culture traces back a very long way! That mountain is my sacred country and so Are The Brumbys and all that is on it , I am writing this letter to advise, That i do NOT GIVE YOU CONSENT TO SLAUGHTER ANY BRUMBYS AND IT MUST STOP AT ONCE! I also advise that i do not want any Brumbys (Wild horses) To be captured or harmed in any way..At this time ,They are at Critical point of becoming extinct and must be held highly protected immediately! , As you are fully aware there has been a massive amount of Evidence put forth to yourselves and other Depts, Including Penny Sharpe, A significant amount of evidence that many people have provided against you all, That's had any involvement in the Harm or the process of harming the Brumbys,,,That includes persons such as RSPCA and other Depts that have also been provided A great degree of Evidence that holds great weight, In having this Sickening Cruel, Slaughtering of the Brumbys that should of been stopped as a result of all the evidence that's continuously been provided,This slaughter should have been stopped some time ago.
