## INQUIRY INTO PROPOSAL TO DEVELOP ROSEHILL RACECOURSE

Firstly, I would like to give you a brief overview of my background and racing knowledge and experience.

I graduated from Macquarie University with a B.A Dip.Ed. degree in 1975 and embarked on a career as a senior secondary mathematics teacher. In 1989 I took leave, after accepting a position in the Commercial Sector, where I worked as the Contracts and Credit Manager for a national manufacturing company for a 5-year period.

In 1994 I accepted a private teaching position in the Parramatta area, where I worked until taking leave in 2004. From 2004 to 2022, I worked on a casual and temporary teaching basis in both Government and Private schools.

## RACING AND BOOKMAKING EXPERIENCE:

I purchased my first share in a racehorse in the late 70's through Hyperion Thoroughbreds. Horses I have part-owned include Quilonie, Prince Vanquish, and the most successful being Targlish who won the group 1 Galaxy at Randwick in 1989.

I have been a keen Form Analyst, Price Assessor and Punter all my life,

BOOKMAKER: Licensed 1986-94 (Guaranteed by NSW Bookmakers Co-Operative)

After many years with an interest in horse racing, form analysis and punting, I took out a bookmaker's clerk's licence and worked as a clerk for a short time before taking out my own Bookmakers Licence in 1986. I worked in the main interstate betting ring, operating on the away galloping meetings at the Bathurst, Lithgow and Wyong (5 years) Greyhounds, every Saturday until 1994. Also, midweek Provincial Galloping meetings at Wyong and Gosford. I handed in my Licence and resigned from the NSW Bookmakers Co-Operatve due to poor patronage, dropping turnover and the rise of the TAB.

## MEMBER AUSTRALIAN TURF CLUB:

I have been an active member of the Australian Turf Club (previously the STC), since 1981. This is now my 44th consecutive year as a club member.

Every year now, I attend most functions, and all race meetings at Rosehill Gardens.

Over the years I have attended race meeting up and down the east coast of NSW, and west of the Sydney Metropolitan area.

In short, I have a deep love and understanding of how racing works best for genuine racing enthusiasts.

## THE PROPOSED SALE OF ROSEHILL RACECOURSE:

Let me start with the proposal to destroy what should be, without doubt, a heritage listed site. The first race run in 1885!!! The history of the horses, the group races, the trainers, the jockeys, the bookmakers, the crowds and more. One hundred and forty years of racing history and heritage gone in a heartbeat!!!
