From Anthony Matthew Rooney; A Queensland Resident

Because The NSW Commission Findings

May Be Implemented By The Federal Parliament

Leaving Other State Citizens Without Capacity To Submit

To A Federal Government Commission On Loneliness

Which Happened To Me; A Victim Of Female Sexual & Domestic Violence

When Federal Parliament Implemented Victoria's Domestic Violence Commission Only.

Whilst I Missed Out On The Domestic Violence Commission;

I Do Not Want To Miss Out On A Loneliness Commission.

As Stated; I Want The Right To Be Lonely

& I Want Government & Community Groups To Cease Interfering With My Right To Be Lonely.

I Am An Ambivert Who Spends 95% Of His Life Introverted

But The 5% Of Life That I Socialise; I Am An Extrovert.

Particularly If Driving My 1937 Chevrolet Convertible.

But Then, That Activity Is Not Really Extroverted

But More Communal

Where People Tell Me Of Their Parents; Grand Parents & Or Relatives

That Drove Old Cars Or Even The Old Car They Owned.

My Communal Participation In An Old Car Brings A Lot Of Pleasure To Many People

Rather Than A Driving Experience Of Extroversion

& Certainly Not A Mating Ritual.

The Oppression Of My Ambivert Nature By Government & Community Groups

Began When I Was 21 & Had Saved \$6000 To Substance Rehabilitate

My Substance Abusing Parents Who Abused Substances From Their Teenage Years.

November 1984 When I Joined Al-Anon Family Groups;

Sibling Organisation To Alcoholics Anonymous

For The Families Of Alcoholics Which Was Government Run Till 1999

These Fellowships Had A Policy/ Theory Of Rock Bottom Alcoholism

Before Any Human Reaches Out For Help & Theory That The Spouses Of Alcoholics

Are Lonely Sexually Repressed Childhood Sex Abuse Survivors.

& Single People Reaching Out To Al-Anon Were Sexually Repressed Homosexuals.

The AL-Anon Family Group Decimated The Fact I Ran A Women's Refuge Age 19 In 1983

6 Years Before The Domestic Violence Act; 16 Years Before The Stalking Act & 40 Years Before

The Coercive Control Act As Well As Running A Homeless Men's Refuge

Which Included Suicide Prevention For I Client Who Was Same Sex Orientated.

We Were Providing First Nations Rites 9 Years Before The Mabo Decision,

Disability Rites 30 Years Before N.D.I.S; Elder Rites & Anti Tobacco

& Alcohol & Drug Rehabilitation & Anti Contact Sport
Because Concussion Is Life Long Disability.

As You Can See I Had A Full Rewarding & Meaningful Life
Which Enhanced My Employment As A Clerk In The Electricity Industry
Where I Was Held In Very High Esteem.
I Even Contemplated Being A Catholic Priest
Because From Age 15 I Wanted To End Paedophilia, Sexual Harassment; Abuse & Rape
Because My Father In 1978 Told Me The Underground Catholic Movement
Was Calling For A Royal Commission Into Paedophilia.

Watching Women & Children Grow In The Women's Refuge
In Non Sexual Relationship With Me;
; Free From Domestic Violence For The 1ST Time In Their Lives
Provided An Emotional & Mental Satisfying Euphoria For Me
That Was Never Surpassed By Sex Orgasm When I Became Sexually Active

I Was Setting Precedence; Providence, Prudence, Diligence & Discernment With Fact
I Was Born With Mild Hydrocephalus As A Baby & Was Inflicted Age 15 With Head Trauma To
The Back Of My Head By A Militant Transgender Teenager As Rape Revenge
Because The Militant Transgender Teenager Could Not Rape Me.
Then Age 15 I Was Forced To Walk Home 10kms In 35 % Heat Vomiting & Feinting,
Then Was Unconscious Without Medical Help For 52 Hours.

Age 21 I Experienced 2% Short Term Memory Loss & 2 % Short Term Memory Recall Failure But
Superior Instant Crisis Identification; Thus The Right Person To Run Women's Refuge
Because I Did Not Associate In Pubs & Or Night Clubs & Avoided Fighting Males
So My Anonymity In Women's Refuge As A Defender Was Appreciated & Utilised.

The Best Way To Describe What Destroyed My Ambivert Nature
Is An Analogy In Biblical Parable Form Which Tells The Story Of A Man { Recovering Alcoholic }
Who When Forgiven 10 Thousand Gold Coins Strangles A Man {Me }
Who Owes Him 100 Cents.
With The Abuse By Recovering Alcoholics To Ambivert Single & Celibate Christian; { Me}
Forcing A Pop Psychology Mantra That I Had Hit Rock Bottom, Was A Lonely &
A Repressed Homosexual!

Alcohol Was Regarded A Vital Social Lubricant & Means To Personal Fulfilment
By Members Of Alcoholics Anonymous & If They Became Addicted;
Then It Was Their Belief That Their Minority Genetic Disposition That Caused The Addiction
& Not Their Social Abuse; Social Sexual Abuse & Or Social Criminal Abuse
Which These Abuses Were Alleged To Occur After Addiction. (False)

Because I Did Not Drink Alcohol & Or Do Drugs,
I Was Labelled As Emotionally & Mentally Immature
& They Alleged My Intention To Provide Rehabilitation For My Parents
Was Because I Wanted To Make My Psychology & Psychiatry Safe
Because I Allegedly Could Not Admit I Was A Latent Homosexual.

Neuroscience Has Proven Me Correct That The Human Brain Is Not Fully Developed Till 25 Years
Of Age & Humans Should Not Consume Alcohol & Or Drugs Before 21 Years Of Age
& The Longer A Human Delays Consuming Alcohol & Or Drugs

The Higher Their Resistance To Addiction Will Be
Because There Is No Safe Level Of Consuming Alcohol & Drugs.
Social Happiness Is A Manufactured Environmental Construct & Initiation Obligation
That I Never Subscribed To Because I Was Happy In My Ambivert Nature

Age 16 I Had Spiritual Euphoria For Living By Christian 10 Commandments
But More Importantly Had Theory Of Mind About Spiritual Euphoria
& Never Felt Alone In Social Occasions Because GOD Was Always With Me.

Age 21 & 1 Month Before Attending Al-Anon,
I Had A Non Sexual Relationship With A Female Recovering Drug Addict
Who Was Also A Female Recovering Sex Worker
Who Told Me I Had The Best Respect & Eye Contact With Women Of Any Man She Ever Met
& That I Would Make A Great Catholic Priest & Or Monogamy Husband For A Catholic Wife
& Would Have A Promising Career In Young St Vincent De Paul
Running Men's & Women's Refuge.
She Did Not Like Alcoholics Anonymous & Or Narcotics Anonymous
Because These Self Help Groups Had More Politics Than The Sex Industry.

This Recovering Female Drug Addict/Recovering Sex Worker
Said She Could Not Ask Me Out & Or Have Sex With Me
Because Her Mistakes In Life Were Hers To Rehabilitate
& The More Autonomy She Took For Her Mistakes
The Greater The Integrity To Her Sobriety
& I Needed A Women Of Natural Sexual Integrity
Because Of My Naturally High Social/Sexual Integrity.

At My 1ST Al-Anon Meeting; The Wife Of The AA Police Liaison Officer
Aggressively Accused Me Of Being A Rock Bottom Alcoholic 7 Times
Who Had To Report To Her Police liaison Officer,
But I Do Not Like Recovering Alcoholics As Much As I Do Not Like Practising Alcoholics
& Besides I Was Not Guilty Of Any Crime In Providing Rehabilitation For My Parents.

The Wife Of The AA Police Liaison Officer Forced Guilt By Association On Me
To St Vincent De Paul 1956 Where She Alleged 1956 St Vincent De Paul Kept Her Husband Drunk.
She Also Forced 1956 Guilt By Association To A Publican Who She Alleged Caused
Her 1956 Abortion.
I Was Not Born Till 1963.

I Knew Within 5 Minutes Of Attending AL-Anon That The AA Police Liaison Officer
Had Turned The Local 3 AA Fellowships Into Zero Impact Cults
By Keeping People In Their Past & In Their Trauma
& It Would Be Hard For Me To Escape This Local AA Cult
That Was Taking Funding From The Alcohol; Drug & Sex Industry
To Keep Membership To Point One Percent Of Problem Alcoholics
Who Were The Worst Of Worst Alcoholics
Investing In Insider Trading , Nepotism & Cronyism
& Also To Inflict Sex Reform. Same Sex Reform & Abortion Reform & Occult Reform On Society
Because The AA Police Liaison Officer Forced The 3 AA Fellowships
Into An Anarchy Structure Without Rules & Infrastructure & Or Problem / Conflict Resolution
Because The Violent & Corrupt Criminal Members Rose To Power.

I Knew Before Attending The 3 AA Fellowships, The 3 AA Fellowships May Be A Corrupt Cult & That My Neurocognitive Unique Status Would Either Escalate Neurologically & Rapidly If The 3 AA Fellowships Were Genuine Alcohol Rehabilitation Services For My Parents But Equally, My Neurocognitive Unique Status Would Rapidly Decline If I Was Morbidly Abused Incorrectly As Being Morally Deficient For Having Hydrocephalus As A Baby. & For Not Drinking, Drugging & Not Being Promiscuous In Australia's Hedonistic Society. All 3 Occurred By Proxy.

December 1984 I Stopped The Rape Of An 18 Year Old Woman, Perpetrated By A Nephew Of A Linesman In The Electricity Industry & Dec 27th 1984 To 25th January 1985 I Was Sent To Outback Queensland Punishment For Whistle Blowing On The Rape Culture In The Electricity Industry. & In Isolation Of Outback Queensland; I Experienced Vicarious Trauma But Was Not Lonely.

This Rape Culture Defines The Then Patriarchal Social Network Of 5 Alpha Males Who Then Defined The Social & Social/Sexual Structure In The Electricity Industry That Employees Were Not Prepared To Challenge Because They May Loose Insider Trading Opportunity, Nepotism & Cronyism Advancement But I Put The Rape Victims Needs First.

Friday Night 25th January 1985 I Had To Return The Fleet Car To The Fleet Car Depot After Spending The Month Isolated In Outback Queensland Where I Experienced Vicarious Trauma & Did Not Have Opportunity To Return To My Parents Home 160 kms Away. I Needed Someone To Talk To About Vicarious Trauma; So I Attended The Friday Night AL-Anon Meeting; Only To Be Forced To Attend Australia's Largest AA Convention Of 500 AA Members. I Was Concerned Why I Had Not Been Told Of This Convention @ My First & Only Four AL-Anon Meetings

Upon Walking Into The AA Convention , The Wife Of The AA Police Liaison Officer Did Not Even Say Hello To Me But Went Into A Lengthy Spray That I Was To Be The First AL-Anon Speaker @ The Public AL-Anon Meeting 2.00pm Sunday Of The Convention. The Wife Of The AA Police Officer Insisted More; The More I Protested With Rational Argument. I Was Not Allowed Fact, I Had Never Been To A Convention Ever In My 21 Years Of Life; That I Had Never Done Any Public Speaking In My Life; That I Knew Nothing About The 3 AA Fellowships; That I Did Not Know 1 Person @ The Convention. When I Said " It Is Against My Religion To Speak About My Dying Alcoholic Father" The Wife Of The AA Police Liaison Officer Replied; " SO WHAT; We Have Members Whose Parents Are Dying"

The AA Police Liaison Officer Then Took Over The Bullying Of Me Forcing Me 20 Times To Be 1ST Public Speaker @ The Public AL-anon Meeting. Even Though I Insisted I Joined An Anonymous Fellowship. But The AA Police Liaison Officer Insisted He Turned His Group Into A Public Speaker Group.

I Was Not Allowed Anonymity For Myself, My Father; My Mother; My Siblings; My Friends; People I Went To School Whose Parents Were In AA. Clients Of The Women's Refuge & Men's Refuge, People I Did Not Like But Had To Keep Their Anonymity, My Fellow Employees My Managers.

The AA Police Liaison Officer Insisted I Admit Fault But I Did Not Steal, Did Not Gossip; Did Not Drink Did Not Drug, Did Not Sexually Abuse.

I Premeditated Before Joining The 3 AA Fellowships That The Authority In The 3 AA Fellowships May Attempt To Extort Me By Threatening To Refuse My Father A Detox Bed & Have My Father Arrested For Drink Driving Thereby Extorting Large Amounts Of Money Out Of Me But I Did Not Predict That I Would Be Publicly Shamed & Slandered By Being Forced To Go Public At A Convention.

It Was 5 Years Before The Fitzgerald Enquiry Into Police Corruption.

15 Minutes Before The Public AL-Anon Meeting;
The AA Police Liaison Officer Threatened The Threat I Knew He Would Inflict That If I Did Not Publicly Sacrifice Myself; My Father Would Be Denied A Detox Bed & Be Arrested For Drink Driving Which Was A Death Sentence To My Father.
& If I Was Not Sponsored By The Militant Same Sex Orientated Catholic Priest The AA Police Liaison Officer Brought Up From The Same Sex Orientated Haunt St Paul's Catholic Seminary Sydney
Which I Knew From Age. 15 St Paul's Seminary Was A Same Sex Orientated Haunt.

Extremely Reluctantly I Sacrificed Myself Rather Than My Father
& Was 1st Public Speaker & The Public AL-Anon Meeting
Hoping To Meet A Traditional Conservative Catholic Priest In The Southern Queensland Region Of Alcoholics Anonymous To Replace & Discipline The AA Police Liaison Officer
& The Militant Same Sex Orientated Catholic Priest From St Paul's Seminary.

Late February 1985 The AA Police Liaison Officer Reviewed The Fact That @ The Australia Day AA Convention; I Had Defied His 20 Orders For Me To Public Speak With 40 Sound Logical & Legal Arguments Demonstrating I Knew The Law & Social Intimacy; So The AA Police Liaison Officer Threatened Me If I Defied The Cult He Established He Would Force Me Into A Nervous Breakdown
& If I Left The AA Cult, He Would Hunt Me Down & Force Me Into A Nervous Breakdown.
& The AA Police Liaison Officer Being A Sociopath
Was More Than Capable Of Carrying Out That Threat.

Police & Alcoholics Anonymous Have Strict 2x 3 Year Terms
But The AA Police Liaison Officer Was In Power Un Audited From 1970 Till His Death in 2001
The AA Police Liaison Officer In The 17 Years He Had Dominance But Not Power Over Me.
Never Spoke Even 1 Civil Word To Me;
Always Coming At Me With Premeditated Verbal & Social Agenda Of Browbeating Me Into Submission & Then An Agenda Of Antagonising My Evidence & Every Possible Response To Maintain Me In Servitude To His Cult, When Citizens Were Kept in Their Past & In Their Trauma,

They Were Given The Sex They Desired & Were Deprived Of As Teenagers
But The AA Police Liaison Officer Knew I Was A Celibate Christian
So That Is Why The Oppression Rather Than Manipulation Was Inflicted February 1985.
The AA Police Liaison Officer Was Hell Bent On Changing Autonomous Social Structures For Sex Reform; Same Sex Reform & Abortion Reform & Occult Reform

The Militant Same Sex Orientated Catholic Priest Forced 18 Months Of Sexual & Morbid Mental & Verbal Domestic Violence In The Form Of Coercive Control On Me,
The Militant Same Sex Orientated Catholic Priest Would Yell,
“ For Fuck Sake; Get Your Fucking Father Out Your Fucking Head”
“ For Fuck Sake; Get Your Fucking Mother Out Your Fucking Head”

“ For Fuck Sake ; Get Your Fucking Family Out Your Fucking Head”

“ For Fuck Sake; Go Out & Get A Fucking Fuck”

“ For Fuck Sake; Force A Fucking Ejaculation “

Any Of My Attempts To Talk The Militant Same Sex Orientated Catholic Priest

Out Of Yelling & Swearing At Me Only Escalated His Coercive Control.

He Would Go Silent Then Change Topic; Talk Briefly On That Foreign Topic;

Then Change The Topic Back To My Complaint

Where He Would Abuse Me For Being Demanding. { False }

The Militant Same Sex Orientated Catholic Priest Joined The Catholic Priesthood

Because It Was An Easy Target With No Authority & Or Discipline

& He Would Not Be Challenged By Other Alcoholic Priests, Monsignors & Bishops

About Forcing Social Sexual Change & He Would Not Listen To My Father

Telling Me The Catholic Underground Was Working To End Paedophilia In A Conservative Society.

The Militant Catholic Priest Social Theory Was Based On Dysfunctional Drug Addicted Suicidal

Artists & Musicians Such As James Dean; Jimmy Hendricks, Janice Joplin & Celebrities That Died In Their 20'S.

The Militant Same Sex Orientated Catholic Priest Suffered Irrationality About

& Could Not See He Had Deprivation Theory To The Introduction Of The Contraceptive Pill

& 60'S Drug Culture & Anti War Movement ;

Where I Took A Perspective Of Looking 7 Generations Back & 7 Generations Forward

& Planned To Live In The Middle Of Society Extremes & Avoid Pendulum Politics.

The Bishop Heavily Reprimanded The Militant Same Sex Orientated Catholic Priest For Giving

A Sunday Sermon During Lent That Catholics Do Not Give Up Smoking For Lent

Because Abstinence Of Nicotine Makes Humans Cranky, Unproductive & Uncooperative

Demonstrating The Militant Same Sex Orientated Catholic Priest

Did Not Know How To Work As A Family Unit & Support Someone Rehabilitate.

The Militant Catholic Priest Only Knew Same Sex Orientated Night Club Sociology

Where Same Sex Orientated Humans Combine Resources

To Get Drunk, High & Sexually Fulfilled.

The Militant Same Sex Orientated Catholic Priest Was Only 1 Year Sober In AA

& Recovering Alcoholics Are Not Allowed To Sponsor AL-Anon Members Like Me

Who Are Not Alcoholic.

I Could Not Refuse To Be Sponsored By The Militant Same Sex Orientated Catholic Priest,

Because The AA Police Liaison Officer Would Force Me Into Nervous Breakdown

So I Tried To Find A Non Alcoholic Catholic Priest In Southern Queensland To Sponsor Me

But Such Priest Are Rarer Than Hen's Teeth.

After 18 Months The Militant Same Sex Orientated Catholic Priest

Forced A Rape Or Sanction In The Mental Health System Threat On Me,

Then When I Agreed To See A Psychiatrist,

The Militant Same Sex Orientated Catholic Priest

Extorted \$8000 Out Of Me For Him & Me & His 2 Friends To Holiday In China

(My Annual Income Was \$6000)

Or He Would Rape & Sanction Me In The Mental Health System.

I insisted I Wanted To Know What He Was Looking For In My Psychiatric Function
But He Abused Me More.
I Insisted I Wanted To Read The Psychiatrist University Thesis That Qualified The Psychiatrist
& I Demanded to Know The Psychiatrist Politics & Sexual Politics
Because If I Was Going To A Psychiatrist, I Wanted A Sexually Conservative Psychiatrist.
The Coercive Control Abuse Became Extreme.

The Militant Same Sex Orientated Catholic Priest
Went Looking For Child Sex Abuse In My Past
& Would Not Allow Me To Put That Child Sex Abuse In Context To My Adult Life,
My Employment,, My Volunteering @ Women's & Men's Refuge,
My Associates Such As The Recovering Female Sex Worker? Female Recovering Drug Addict.

The Catholic Priest Was So Violent & Coercive Controlling
I Lost Sight Of Fact That He Caused The Impotency In Me
That In Reality Was The Reason The Psychiatrist Was Concerned I Never Had An Ejaculation .
The Reality Was This Was The Responsibility Of A Sex Counsellor & Not A Psychiatrist
But The Militant Same Sex Orientated Catholic Priest Established An Escape Route For Himself
Because If He Failed Raping & Grooming Me For Transgender
He Could Always Argue I Was Insane
& He Also Denied Me Private Health Insurance & Personal Solicitor
Whilst Maintaining I Experienced Poverty By Him Borrowing My Life Savings
Whilst Breaking Down My Family Unit That Needed Minor Rehabilitation
& Not Reorganization Under Separation.

I Was Taken Out Of The Political System Because They Did Not Want Conservative Alcoholics
Families Rehabilitated Thus Undermining Conservative Social Societies
So As To Grow Sex Reform. Same Sex Reform; Abortion Reform & Occult Reform.

The Psychiatrist Gave Perverse Sex Books Which Included Necrophilia, Bestiality & Croppia
Simultaneously With An Auto Biography Of A Christian Single Male
Who Never Had An Ejaculation Then Confides In A Girl
Who Is Sexually Patient With Him & They Marry.

I Did Not Think The Priest Wanted A Sexual Relationship With Me
Because The Priest Had A Girlfriend,
I Was Rightly Devastated When The Priest Tried Raping Me At A Friends Farewell
His Entrapment & Had His Escape Premeditated Demonstrating He Was A Sex Predator
& He Investigated For A Month To Find A Psychiatrist
Who Would Cover Up The Attempted Rape Of Me,
The Psychiatrist Was A Morbid Relapsing Alcoholic Member Of Alcoholics Anonymous.

The loneliness Commission Needs To Act That Australia's Social/Sexual Community Is All Wrong
& Never Can Be Set Right Because The 1948 Kinsey Sex Report
Did Not Obtain Court Records Of People Who Prevent Rape
& Study Their Ethical Sex Lives
& Educate Society About Sex After Preventing Rape & Sexual Harassment
No The 1948 Kinsey Sex Report Relied On Sex Reports By Prisoners & Paedophiles.

The Catholic Priest Was Moved Around Australia,

Which Was His Plans To Bring Around Sex Reform; Same Sex Reform, Abortion Reform & Occult Reform Unchallenged By Unregulated Sex Abuse & Rape & Alcoholism In The Catholic Church. The Militant Same Sex Orientated Catholic Priest Would Have Know About The Underground Movement To End Paedophilia In The Catholic Church But He Did Not Want Conservative Social Sexual Society As He Believed The Only Crime Was Starvation He Coercive Controlled My Insistence On Sexual Ethics That Is Why He Used The Mental Health System Against Me, He Is Still An AA Member Relapsing Drunk. The Catholic Priest Coercive Control Abuse Was So Bad I Lost Ability To Read & Speed Read.

1988 Alateen Kids Elected Me Alateen Coordinator For The 3 AA Fellowships & 1990 I Whistle Blew On The Paedophile Rape Of Bundaberg Alateen Girls, Committed By A Vietnam Veteran AA Member Sponsored By The AA Police Liaison Officer On A Asset Rich Cash Poor Basis With Private Health Insurance, Access To A Family Barrister & A Veteran Affairs Pension Where The AA Police Liaison Officer Corrupted The Dept Of Police Prosecution Withdrawing Rape Charges & Implementing Child Abuse Charges Whilst The Vietnam Veteran Extensively Intimidated The Family Of The Raped Girls. Stacked AA Meetings With Vietnam Veterans Paedophile Domestic Violence Perpetrating AA Members & After The Vietnam Veteran AA Member Served Only 3 Months in Prison & When Released On A Friday He Was 1ST Speaker @ The Bundaberg AA Convention Where He Bragged He Had To Do What He Had To Do To Be Where He Needed To Be. In Front Of & Directed At The Alateen Girls He Raped.

Dear Loneliness Commission. Please Acknowledge Australia Has Never Fought A Just War Because Australian Land Was Never Invaded. We Have Done The Fighting For England & America Who Invaded The Arab World In 1880 Over Oil. But Please I Am Neutral Peace & Civility Activist & I Don't Believe That Our Social Structure & Concepts Of Loneliness Should Be Dictated To Australians Because Of Anzac Day Because WW1 & Gallipoli Had More Continuous Objectors Than Soldiers. 4 Million Australians Protested Iraq & Afghanistan War But There Are Only 40 000 Soldiers .

The AA Police Liaison Officer Brought The Most Violent Mentally Physically & Sexually Abusive Drug Abusing Female Whore To Stalk Me Into A Sexual & Cohabiting Relationship As Direct Revenge For Me Whistle Blowing On Paedophilia By Vietnam Veteran AA Members Sponsored By The AA Police Liaison Officer & For Defying The AA Police Liaison Officer's Cult.

I Received 4 Years Of Coercive Controlling Domestic & Sexual Violence & Infidelity From The Drug Abusing Female Whore Who; With The AA Police Liaison Officer Sanctioned Me In The Mental Health System For Conjugal Paranoia When Conjugal Paranoia According To The Diagnostic Manual For Mental Illness Is The Incorrect Imagining Your Spouse Is Having An Affair.

The Psychiatrist To Vietnam Veterans Association Who Sponsored Many Vietnam Veterans
In Alcoholics Anonymous Worked With The AA Police Liaison Officer
To Sanction Me In The Mental Health System As Revenge Against Me For
Whistle Blowing On Paedophilia, By Vietnam Veterans.

The Female Psychiatrist Giving A Second Opinion Decimated Sound Social Sexual Health Saying
“ The Reason Why You Are Jealous Of Your Wife Having An Affair
Was Because You Were Not Promiscuous Enough As A Teenager. “
Medically; Promiscuity Is To Sex What Addiction Is To Alcohol
But The Mental Health Act Makes Allowance For Promiscuous People May Not Be Mentally Ill.
But Modern Australian Social Sexuality Now Regards Promiscuity An Initiation Right.

The Female Psychiatrist Ignored Fact I Ran A Women's Refuge March 1983 To November 1987
That; Before I Joined The 3 AA Fellowships I Had Non Sexual Relationship With Female
Recovering Sex Worker/Female Recovering Drug Addict
Who Said I Had The Most Respect & Eye Contact Towards Women Of Any Man She Met
& Had Similar Plutonic Relationships Outside The 3 AA Fellowships
That The Stalking Violent Female Did Not Know About & Did Not Want To Know About.

During My Marriage Breakdown I Was Never Lonely Or Felt Victimized Despite Knowing
I Was The Severe Victim Of Morbid Coercive Controlling Domestic Violence
& Never Retaliated With Violence In Any Form
Because One Day In The Future Medical Science Would Reveal There Is No Safe Level
Of Consuming Drugs & Alcohol & 10 Years From Now Pubs Will Be A Thing Of The Past
& By 2040 Hedonistic Lifestyles Will Be A Thing Of The Past .
I Am A Social Pioneer Who Will Be Recognized In My Senior Years.

My Substance Abusing Parents Drank Drove To Give Perjured Evidence About Me
With The Violent Coercive Controlling Sexually & Domestically Violent Female Whore
& I Was Sanctioned In The Mental Health System For 4 Years.
My Father Wrote Off 6 Cars In The Preceding 3 Years Drink Driving & Was Never Charged.
The Female Whore Claimed I Was Religiously Insane
Because I Did Not Forgive Her Like Forgiveness In The Bible Parable Of The Prodigal Son
But The Stories Of Forgiveness Of Monetary Debt In The Bible Are Inconsistent.
The Whore Would Beat Me In My Left Ear Which She Knew Has Severe Tinnitus
Which Was Transfer Hatred Of Her Bible Bashing Father Who Has Severe Self Inflicted Tinnitus.
My Tinnitus Was Caused By Domestic Violence By My Mother Who Not Only Once Nearly
Murdered Me But Gave Evidence With The Violent Whore To Sanction Me In The Mental System .

For The Record ; I Never Believed Jesus Christ Was A Social Worker With Mystical Healing
Powers But I Believed Carpentry & Boat Building & Dry Land Farming Were The Leading Science
Of 2000 Years Ago & That John The Baptist & Jesus Christ Discovered The Difference Between
Coma & Death & The Herbal Medicine From The Wilderness To Remedy Coma.
The Violent Whore Never Once Spoke To Me About Religion
& Any attempts To Get Her To Participate In Counselling
The Whore Would Instantly Explode Into Violence.

The AA Police Liaison Officer Hinted I Was Conjugal Paranoid
By Citing A Court Rape Case Where The 10th Man To Have Gang Sex With A Woman
Was Charged With Rape. Hardly An Analogy That General Society Would Accept

& Forced A Drug Dealing Outlaw Biker On Me Surreptitiously
The Outlaw Biker Left An Intellectually Challenged Person On My Door Step
For Non Consented Respite , Then Via Mobile Phone The Drug Dealing Outlaw Biker Would
Verbalize Death Threats To Me Because I Knew Too Much About Corruption
In Substance Rehabilitation & The 3 AA Fellowships .

The Drug Dealing Outlaw Biker Bragged He Was A Christian Pastor
But I Knew It Only Took 2 People In Queensland To Register A Church
Whilst I Also Remember Reading 1987 In A Christian Magazine By Rev Jimmy Swaggart
That Rev Jimmy Baker Became A Minister Of Religion During A Murder Court Case
Because Jesus Christ Changed The Finger Prints Of Drug Dealer Murderer Jimmy Baker
During The Court Case, But 1987 I Knew Rev Jimmy Baker Guilty Of Police Corruption.
1999 I Was Not Surprised That Rev Jimmy Baker Was Convicted Of Sex With A Prostitute.

2005 I Knew The Drug Dealing Outlaw Biker Was Guilty Of Corruption In The Minor Drug Court
Where The Drug Dealing Outlaw Biker Extorted Me & Society Thru Death Threats To The
Intellectually Challenged Adults & Juvenile Delinquents
The Minor Drug Court Gave Him Supervision Of

The Drug Dealing Outlaw Biker Would Threaten To Amputate My Toes & Thumbs
Demonstrating How He Amputated Toes & Thumbs Of Rival Out Law Biker Club Members.
It Was Hard To Stay Rational Even Though I Knew That Verbal Terrorism Is Convicted In Prison
As Long As Physical Terrorism But It Was Very Frightening That The Drug Dealing Outlaw Biker
Had No Addiction To Drugs But His Primary Addiction Was Violence
& He Did Not Care If He Spent Several Lives In Prison
So Long As He Had Access To Violence,
He Threatened To Throw An Incendiary Into My House & Burn Me To Death.

Dear Loneliness Commission Please Look At The Abuse Of Religion
As A Means To Control People Rather Than Rehabilitate People
With People Living Hedonistic Lives Because Apparently Sins Are Forgiven
& Addiction Is A Disease & Stigma Un Heavenly
& Once In The Flock Of Christians, One Human May Never Have To Lonely Ever Again
In This Life & Or The After Life.

Dear Loneliness Commission, Please Look At Psychologist; Psychiatrist & Mental Health & Social
Health Workers & Volunteers Socially Engineering Patient Outcomes For Financial & Political
' Gain, Profit & Politics Rather Than Multi Culturally Multi Ethically Multi Laterally Socially
Facilitating All Diversity Like I Was Doing Age 21 Running A Women's & Men's Refuge.
The Most Extreme Corruption Of This Was The Treating Mental Health Team
Who Appointed The Drug Dealing Outlaw Biker As The Mental Health Ward Chaplain

Despite Fact The Drug Dealer Outlaw Biker Was On The Run For 3 Years
& Only Had His Opinion He Was A Minister Of Religion,
Nor Graduation Certificate For Drug Rehabilitation Let Alone Not A Qualified Drug Counsellor,
No Diploma In Sociology, Psychology & Nor Theology.

The Treating Team Who Appointed The Drug Dealing Outlaw Biker, A Ward Chaplain
Were Former Drug Abusing Juvenile Delinquents Who Were Convicted As Teenager
& Told By A Judge To Go To University But Studied How To legalize Drugs
Because They Perceived Loneliness & Stigma For Being Juvenile Delinquents
& Were Determined As Adults To Get Revenge On Society By Legalizing Drugs & Hedonistic
Lifestyles
& To Swing The Revenge Political Pendulum Against Conservative People
Who They Would Label As Lonely Sexually Repressed Hedonistic Lifestyle Repressed Humans

After I Have Adopted Institutional Behaviour

There Needs To Be A Neurolink Phone Service Similar To Police Link
So Citizens Can Report Non Urgent Crimes To Neuro Diverse People & Or Non Urgent Crimes By
Neuro Diverse People So Situations Such As I Living Under Coercive Control Can Make Phone
Contact On Day One & Not After 6 Months When We Are So Stressed Out We No Longer Make
Sense,

2007 The Treating Team Did Not Account For The \$50 000 The Drug Dealing Outlaw Biker
Extorted Out Of Me.

2014 The Treating Team Did Not Account For The \$40 000 Extorted out Of Me By A Private
Detective Who Spent 3 Years In Prison For Car Stealing Racket & Drug Dealing
As A Queensland Police Service Detective Convicted By The Fitzgerald Inquiry .

2014 The Detective Felt Justified In Extorting \$40 000 Out Of Me Because I Was Allegedly
Immature For My Alcohol & Drug Abstinence Advocacy
