A RSPCA inspector for nearly two years has used harassment, coercive control, bullying, threats and abuse. Has stalked me in and out of uniform, was caught using binoculars from up the road. Was dishonest and lied to police, members of the community and vets. Manipulated and threatened people to sign statements they never were allowed to proof read and what was stated in the statement is not what they said. The RSPCA was dishonest and lied in court papers. Falsified sanction notices and used false pictures as evidence in one photo it's a clear blue sky, sunny and hot and people in short sleeved tops and in another photo in which was meant to be on the same day was over cast and wet and a person in a long sleeve woollen jump. The temperature on the day was thirty plus degrees and humid.

The inspector did not follow litigation or investigate. Did not ring vets or farriers or medical people involved. Was warned by lawyers not to communicate and or approach me and if needed to only through them, but did not listen and did the opposite. Was told to return animals as the inspector did not follow rules, litigation and seized animals that was not ever mentioned on sanction notices or that they had met before. Seizure notice was falsified and dishonest and what was seized was not on the seizure notice. Animals were owned by more than one person. The RSPCA person had not spoken to myself for over six months and was telling people they had. Sanction notices were left on the door without seeing the animals prior.

While harassing and bullying me this inspector ignored ponies suffering in paddocks. Dogs locked in cages with no food or water and in hot temperatures, cattle laying dead the paddock. What is worse while trespassing on our property and being on the neighbours paddock ignored sheep with at least three to five years of fleece on them even when the owner begged for help. Then a couple of weeks later walked away them dead in the paddock after suffering a horrible death. This same inspector told another local person they would pick up the dogs on the property after they were in hospital after an assault, the dogs were found still chained up and close to death nearly two weeks later. Around the same time this inspector seized my animals the RSPCA told another well know rescue they could not seize a horse as it was not malnourished or neglected enough when it was close to death and a body score of less than one. At the same time the RSPCA visited a property and did nothing where a pony had a broken leg and was left to die. This sucks as the inspector shot a well loved pony of ours and seized animals of us in better condition and were well loved by a number of people. Another agistees pony was shot and left with its intestines and organs left out and hanging. The inspector said it was after an autopsy but the Australia Vet Association and the state veterinary board said a vet would not do that as it is very unprofessional and wrong. A vet the inspector mentioned we set up a plan as another agistee moved their horses onto another property so the vet was called out and after a while the vet was asked if they knew any and vet replied with no haven't seen any of these before have they come from interstate?

After the animals were seized on my agistment another owner and a family member rang the RSPCA and was told they had no animals of that description. Someone drove to the huntervalley shelter as we were told that was the closest and the shelter that would be used. Paddocks and stables were empty. Another associate went to the Yagoona and to head office and same thing again. They are ordering us to pay a stupid amount and we don't even know if the animals are still alive or where they are. On seizure day the horse the RSPCA said was in the worse condition was not seized and out of all the animals they took the animals in best condition and left behind the worse. Still to this day we don't know where they are as we know the RSPCA inspector lied about the animals being seized. Plus in between visits by the RSPCA everything was quiet and peaceful but then out of the blue something would happen and sure enough the next day the inspector turned up. To the point a neighbour actually stayed that inspector is the one harming the animals as I don't believe in coincidences and that smirk he had answers it all. The RSPCA was told to stop the illegal and criminal behaviour but never did. Weirdly it was like they were spying on us and knew when people were home and when not as was caught by a son and the inspector told the son they had permission by the property owner when they did not and the son was the son of

the property owner and knew they were lying. The inspector tried to blame me for other people's horses and than is trying to get me on double jeopardy as I already been punished for something and they are trying again. The inspector is accusing us of no farrier when horses had shoes on and the farrier was only out in the couple of weeks before hand, the vet was out two days before. The lies of no feed when there were round bales in paddocks etc. they animals seized were the most expensive and worth more than the ones left behind. Plus two of the animals seized we only had one agreement and were to be sent back after we didn't require them and the owners have never been contacted and when the owners ring the RSPCA they get told they dont have said animal or that the inspector would ring back and the inspector never does. The RSPCA leaked information to the media and the inspector was caught talking to a report when nothing had been said in court or a plea had not been mentioned. The reporter made out I was guilty in a news paper article. When court was not over and only just started.

The inspector was in conversation with a vet and was caught saying they wished they were on the shooting team to shoot the Brumbies. The inspector did not hold back on animals they hated and that needed to be shot. Including cats, some dogs and most breed of horses and sheep. The inspector doesn't understand animal husbandry, animal colours as things they ordered would kill the animal. But if they knew that, that's just horrid and cruel.

The inspector knew I was going through a tough time and when police and specialised organisations say well the RSPCA is funded to help people like you and was like no they are burying me. Had a police officer tell us we now understand why the inspector was not a police officer anymore. The inspector helps another person to keep hoarding abusing animals and let's it go when they have been name and shaned on all social media places and they keep getting animals. We have had must of our animals for over ten years and they are family members.

The animals are our life and what the RSPCA has done has terrified us, made us scared of white four wheel drives. The inspector has pushed members of the family to what to commit suicide and made our lives living hell because we can't trust them. The inspector has made our mental health issues ten times worse and they keep the narcissisticz abuse and threats up. The RSPCA accused a person making the first complaint but the etson accused said no they didn't why would they because they would be just dobbing themselves in. But because the rspca mentioned this person they now facing of losing everything and their pension and livelihood.
