# **Question 13**

13. This is not a function of the Office of Liquor, Gaming and Racing. The detection and enforcement for alleged breaches of section 21 of the *Prevention of Cruelty* 

to Animals Act 1979 is the responsibility of Greyhound Racing NSW, RSPCA NSW and the NSW Police.

### **Question 14**

14. Please provide an update on the review of NSW thoroughbred racing legislation, including when a response to the report's recommendations is likely to be handed down

### Answer

14. The Report on the five year statutory review of the *Thoroughbred Racing Act* 1996 and the three year statutory review of the *Australian Jockey and Sydney Turf Clubs Merger Act 2010* was tabled in the NSW Parliament on 6 August 2014. The government is currently considering the Report's recommendations.

### **Question 15**

### **Answer**

15. Information regarding scheduled meetings held with stakeholders, external organisations and individuals will be published in accordance with Memorandum 2014-07 - Publication of Ministerial Diaries.

Office of Liquor, Gaming & Racing has a formal program of structured and planned meetings with several key stakeholders with the capacity to contribute to achieving the statutory objectives of the liquor and gaming laws.

Since July 2013, 11 stakeholder meetings were held involving representatives from a range of regulated industries including liquor and gaming.

The Office of Liquor, Gaming and Racing works with the NSW Ministry for Health, harm reduction groups and public health groups.

During 2013-14 the Office of Liquor, Gaming & Racing Executive Director and former Minister met with the following groups on one occasion each:

- NAAPA
- FARE
- Australian Medical Association NSW Police Association

The former Executive Director met with the Thomas Kelly Youth Foundation in 2013.

The Executive Director also met with FARE (one face to face and one phone briefing), and presented at the NAAPA Forum: Alcohol Policy in NSW: Where to now? in April 2014 at NSW Parliament

Senior OLGR officers meet with local public health groups to discuss alcohol policy issues, compliance matters, and as part of the liquor accord program.

In the past 12 months OLGR met with the Foundation for Alcohol Research & Education (FARE) on one occasion, and with Tony Brown – Chairperson of Newcastle Community Drug Action Team and Project Manager at Alcohol Community Action Project on one occasion. OLGR officers also met with the Ministry of Health representative responsible for oversight of the Community Drug Action Team program.

# **Question 18**

- 18. How many liquor licence holders did not submit their biennial return by the due date of 31 March 2014?
- (a) Of those licence holders who did not submit their return in time, how many are still outstanding?
- (b) What is the Office of Liquor, Gaming and Racing doing to ensure all returns are lodged?
- (c) Have any penalties been applied to date for the non-lodgement of returns in this round?
- i. If so, how many penalties have been applied and what was the nature of the penalty?

- 18. 4,757 liquor licence holders did not submit their biennial return by the due date of 31 March 2014. 13,519 liquor licence holders submitted their biennial return by the due date.
- (a) As at 31 August 2014, 3,389 returns were still outstanding. It is expected that a significant proportion of these venues are no longer trading and therefore will not lodge a return (see enforcement action information below).
- (b)(c)(i) OLGR continues to follow up on non-responding venues and as part of a risk-based approach is currently investigating approximately 550 venues for failing to supply a return. To date, 15 licensees have been issued with a \$1,100 penalty notice and a further eight licensees have been issued with written

warnings. The balances of the first phase of investigations are expected to be concluded by end September 2014, with outcomes to inform further compliance activities.

### **Question 19**

- 19. How many dormant liquor licenses are there currently in NSW?
- (a) How many of these have become active in the last 12 months and where were they made active?
- (b) How many of these dormant licences have become active within liquor freeze precincts in the past 12 months?

- 19. Dormant liquor licences are current licences that have temporarily ceased to trade. As at 29 August 2014, there are 522 such licences in NSW.
- (a) Fifty five (55) Ceased to Trade licences have recommenced trading during the period 01 August 2013 to 01 August 2014 in the following locations:

# **Question 20**

20. What is the expected annual revenue of the new risk based liquor licencing system for the upcoming financial year?

#### **Answer**

- 20. Indicative revenue modelling suggested recovery of regulatory costs of around \$20M in the first year of the scheme. The risk-based licence fee scheme uses weighted loadings to encourage an overall reduction in authorised extended trading hours for licensed venues in NSW. The intent of the scheme is to encourage improved compliance and contribute to a reduced risk of alcohol-related harm while ensuring venues that operate in higher risk periods or contravene liquor laws make a more substantial contribution to the cost of regulation. It is premature to provide advice on revenue that will accrue from operation of the scheme as it is designed to:
  - 1. clarify the scope of potentially abandoned licences,
  - 2. result in significant surrender of authorised trading hours; and
  - 3. ensure future conduct by business operators informs the application of risk loadings.

It is also intended to encourage businesses to adopt lower risk operating models (and therefore pay a lower annual fee).

21. Please provide a list of all liquor licence breaches (provided by premises, breach and date) detected by either the police or the Office of Liquor, Gaming and Racing that occurred within the past two years within the Sydney CBD Entertainment Precinct.

#### **Answer**

21. OLGR detected breaches are detailed the table at Attachment 1. OLGR does not hold records on breaches detected by NSW Police.

### Question 22

- 22. Since the introduction of the banning orders for the Sydney CBD Entertainment Precinct, how many people have been subjected to the 48 hour ban and how many to the 12 month ban?
- (a) Of the 12 month bans listed above, how many have been subject to appeal?

### **Answer**

- 22. A total of 123 people have been subjected to the 48 hour banning orders. 59 people have been subjected to the 12 month banning order.
- (a) None.

### **Question 23**

23. Since the introduction of the new alcohol laws in January this year, how many licensees have attracted fines for failure to comply with the new laws?

### **Answer**

- 23. As at 1 September 2014, OLGR has identified nine (9) licensed venues in breach of the new laws. Of which:
  - Prosecution has been initiated for two offences,
  - Four warning letters have been issued, and
  - Three are matters are under investigation and regulatory action has not yet been determined.

### **Question 24**

- 24. Since the introduction of the new alcohol laws in January this year, how many venues within the CBD Entertainment Precinct have applied for an exemption to the lock out requirements?
- (a) Have any venues been successful in their application?
- (b) If so, how many and who?

- 24. As at 1 September 2014, eight exemption applications to the lock out condition have been received by the Office of Liquor, Gaming and Racing. Seven of the applications remain under consideration and one has been withdrawn.
- (a) None of the applications have been determined.
- (b) N/A

- 25. Please provide an update on the use of controlled purchase operations (CPO) to support the enforcement of laws prohibiting the sale of alcohol to minors?
- (a) If CPOs are in place, how many have been conducted and what has been the results?

### **Answer**

25. The government's package of reforms announced in January 2014 recognised the importance of the underage drinking laws in reducing alcohol-related violence. The package included a commitment to conduct controlled operations involving minors or young looking adults to test compliance with the liquor laws and determine whether liquor is being sold to minors.

Under the Liquor Act, it is an offence to request or order a minor to purchase alcohol from licensed premises. Therefore, controlled operations using minors cannot presently be conducted.

There are a number of safety issues associated with minors purchasing alcohol, as well as a need to consider the sensitivities of these types of operations.

In developing its response to the Liquor Act review, the government considered options to strengthen compliance with laws prohibiting the sale of alcohol to minors so as to reduce the harms associated with underage drinking. A strong responsible service of alcohol message needs to be supported by effective deterrent measures that are commensurate with the seriousness of the offence. The implications of non-compliance need to be swift to ensure problems are not compounded through repeat offences.

The government will therefore develop amendments to the *Liquor Act 2007* to allow an escalating penalty regime to be prescribed for the offence of selling liquor to a minor on licensed premises. Significant penalties, including suspension and cancellation of a liquor licence will apply in respect of offences under section 117(1) of the Liquor Act 2007, where liquor is sold to a minor on licensed premises. These amendments will be introduced during the Spring 2014 sittings of Parliament.

26. Please provide an update on the progress of the "high profile road safety style social media and advertising campaign" on alcohol that was announced in January?

### **Answer**

# **GAMING**

### Question 27

- 27. Did the government review the state cap on gaming machine entitlements this year?
- (a) If so, how was the review conducted?
- (b) If so, which stakeholders were consulted?
- (c) If so, what were the results of the review?

### **Answer**

- 27. The state cap on gaming machines was reviewed by the Independent Liquor and Gaming Authority in April 2014.
  - (a) The review was based on information compiled by Authority staff. As part of its review process the Authority considered:
    - changes in the nature of the markets for entitlements
    - commercial issues that will drive forfeiture of entitlements by clubs and hotels as trade in entitlements progress
    - available evidence on gambling related harm
    - recent community and population studies on gambling prevalence and problem gambling in NSW.

The Authority noted steady or declining problem gambling prevalence rates and modest declines in rates of gaming machine participation.

- (b) The review process did not include formal consultation with stakeholders.
- (c) The Authority concluded that the current cap on gaming machine entitlements should be maintained at this time.

## **Question 28**

28. How many gaming machine entitlement that are currently applied to multiterminal machines are there in NSW?

28. As at 25 August 2014 there were 2,389 gaming machine entitlements applied to authorised multi-terminal gaming machines in NSW clubs.

# **Question 29**

- 29. How many registered clubs have applied for multi-terminal gaming machine entitlements since August 2013?
- (a) Please provide this figure broken down by Local Government Area and number of entitlements applied for regardless of if the application was successful or not.

# Answer

29. Nine Between 2 August 2013 and 25 August 2014, a total of 40 registered clubs applied for an increase in multi-terminal gaming machines.

- 30. Which organisation or company won the tender for the study into gambling harm and minimisation that was advertised on the Office of Liquor, Gaming and Racing website last year?
- (a) Please provide an update of that study and when the report is expected to be finalised.

# **Answer**

- 30. In October 2013 the NSW Government awarded a contract to the University of Sydney to undertake research into gambling harm minimisation. The aim of the research is to determine the harms that can occur to players of gambling products available in NSW and the level of risk associated with those harms. The research will also identify the range of strategies that may be effective in preventing the development of those harms.
- (a) The research is underway and the report is due in the first half of 2015.

# **Question 34**

### **Question 35**

35. Please describe the measures in place to prevent and detect the proposed Barangaroo becoming a site for money laundering or organised crime activities?

### **Answer**

35. The Authority will be implementing the same measures that currently exist with The Star casino. This includes monitoring by government inspectors and regular onsite meetings with the casino operator and the NSW Police to facilitate the exchange of information and the timely exclusion of appropriate people from the casino. The Authority also holds regular meetings with the NSW Crime Commission, Australian Crime Commission and AUSTRAC to enable sharing of information and ongoing cooperation on money laundering or organised crime activities.

The Barangaroo Restricted Gaming Facility will be required to meet the obligations of the *Anti-Money Laundering and Counter-Terrorism Financing Act* (2006) administered by AUSTRAC. This includes having systems in place to detect transactions which may be suspicious of money laundering taking place.

Section 31 of the *Casino Control Act 1992* also requires Crown Sydney Gaming Pty Limited, the licence holder of the Barangaroo Restricted Gaming Licence, will be subject to regular investigations as to whether or not they are a suitable person to continue to give effect to the casino licence; and it is in the public interest that the casino licence should continue in force. These investigations will be conducted three (3) years after the commencement of operations and thereafter at intervals not exceeding five (5) years.

# Memorandum of Understanding with Clubs NSW

# **Question 36**

36. ClubsNSW MOU has been a great success, as a result of the implementation of the MOU between the NSW Liberals & Nationals in 2010. Currently the review of the 2010 MOU is underway, and preliminary analysis indicates an increase in social and economic contribution to the State of \$66 million per annum, including a reduction in state gaming machine duty of \$48 million per annum. No decision has been taken on any future MOU's.

### **Question 37**

# **Brett Whitley Foundation**

# **Question 38**

38. Can you advise whether the Department has received any advice that the actions of the Brett Whitely Foundation and the Newcastle Art Gallery in relation to the donation of \$350,000 from the Gallery to the Foundation subsequent to the gifting of the Black Totem sculpture were appropriate?

### **Answer**

38. Advice provided to Arts NSW has indicated that the Brett Whiteley Foundation Board has confirmed there was no agreement between the Foundation and the Newcastle Art Gallery. It was agreed by the Brett Whiteley Foundation Board there was no need to take further action.

39. Can you advise whether the Brett Whitely Foundation has had similar arrangements with other Art Galleries in NSW including the NSW Art Gallery and if so can you provide details of these arrangements?

### **Answer**

39. The Foundation reports that it has no arrangements with any art galleries regarding donations. The Foundation is a registered charity and accepts donations from individuals and organisations.

# **Newcastle Art Gallery**

# **Question 40**

- 40. During his first campaign in 2010 former Member for Newcastle Tim Owen promised that an incoming NSW Coalition Government would contribute the state government's \$7m share of funding for the redevelopment of Newcastle Art Gallery. Newcastle City Council applied for \$7 million from the NSW Government as a third part of matching funding for the extension of its Newcastle Art Gallery.
- (a) Despite being funded by the Commonwealth a decision was made by the NSW government not to provide matching funding. Why did the NSW Coalition Government fail to honour the commitment?
- (b) Did the Department get involved in this matter by either offering advice or an evaluation?
- (c) Was there any discussion between the department and Treasury or the Premiers Department on this matter?
- (d) Did the Department see the plans for the proposed extension?
- (e) Is there a view in the Department as to the appropriateness of the proposed extension?

### **Answer**

40.

- a) The NSW Government did not make a commitment to contribute financially to the redevelopment of Newcastle Art Gallery.
- b) The Department provided background information concerning the project.
- c) The Department provided background information concerning the project to the Department of Premier and Cabinet.
- d) Yes.

e) Newcastle City Council has indicated that it will not be progressing with the previously proposed extension and redevelopment. The department has not seen a new proposal so cannot comment on its appropriateness.

### **Question 41**

- 41. A meeting was held between Tim Owen, the General Manager of Newcastle City Council, Ken Gouldthorpe, George Souris and then Premier Barry O'Farrell to seek \$7m state funding for the Newcastle Art Gallery redevelopment. I assume your Department or Premier's Department prepared or contributed to a brief for the Premier on this funding request.
- (a) What was the Department's specific advice?
- (b) Please provide a copy of this advice?

# Answer

41.

- (a) The Department provided background information to the then Minister for the Arts; specifically, an update on recent decisions by Council concerning the project, and details of funding to be provided by the Department to the Gallery in 2014.
- (b) A copy of the advice "Meeting brief: Newcastle Art Gallery Redevelopment" is attached.

# **Question 42**

- 42. Prior to the meeting with then Premier O'Farrell, both the General Manager of Newcastle City Council and the Lord Mayor had been informed by Sharon Grierson, the then Federal Member for Newcastle, of advice from the federal Department of Regional Development that Newcastle City Council could contribute a lesser amount than the original \$6.5m proposed as long as the project could be delivered for that lesser amount. Both the Lord Mayor and General Manager were aware of the architect's advice that the project could be delivered at a lesser cost with the reduction of public spaces.
- (a) At the meeting with Barry O'Farrell did the General Manager Ken Gouldthorp make the Premier aware of the possibility outlined that if the state government were to contribute the \$7 m to match the Federal grant he had been told by the Federal Member for Newcastle that Newcastle City Council need only contribute \$3m?
- (b) Was the then Premier, Arts Minister or either department informed that the project costs included \$3m of existing maintenance costs for the gallery?

42.

- (a) This question should be referred to the Premier.
- (b) The last budget proposal for the redevelopment received by the Department, dated 18 March 2013; projected an expenditure of \$2,164,566 towards "refurbishment of existing building". The Department provided this budget to the DPC and the Minister for the Arts in April 2014.

## **Question 43**

- 43. Newcastle City Council publicly claimed that their financial situation meant that they could not afford to proceed with the Newcastle Art Gallery development.
- (a) Did Newcastle City Council make the departments aware that although they had budget constraints, a lower contribution by them of only \$3m would allow them to alleviate \$3m of maintenance costs as long as the NSW government contributed their \$7m as proposed?
- (b) Had the relevant departments been aware of the opportunity to reduce the contribution by Newcastle City Council to an amount commensurate with an existing asset maintenance cost would their advice have been any different?

## **Answer**

43.

- (a) The Department has no record of this being communicated.
- (b) The Department provided contextual advice concerning the project as previously proposed. It cannot comment on the advice it would have given about a different scenario.

## **Question 44**

44. In light of the resignation of Newcastle Lord Mayor Jeff McCloy and the State Member for Newcastle Tim Owen following revelations of corruption at recent ICAC hearings, does this Government plan to reopen negotiations with Newcastle City Council regarding the redevelopment of the Newcastle Regional Art Gallery, especially given that your Government had already committed \$7million to the project.

### **Answer**

44. The NSW Government has not committed funds to the project. Any future proposals for the redevelopment of the Gallery will be considered in the context of government priorities and the State Budget.

# **Regional Galleries**

45. What funding is provided to Hunter councils for regional galleries to design and deliver outreach programs to the populations of their LGAs?

### **Answer**

45. Since 2011/12, the NSW Government, through Arts NSW, has provided a total of \$712,486 in program and project funding to Hunter councils for regional galleries within their LGAs.

# **Question 46**

46. What grants has the Minister provided for Maitland Council and the Gallery to promote the Art Gallery?

### **Answer**

46. Since 2011/12 the NSW Government, through Arts NSW, has provided a total of \$198,510 in program funding to Maitland City Council for Maitland Regional Art Gallery as a contribution to its annual program.

### **Question 47**

47. What grants has the Minister provided for Gloucestor Council and the Gallery to promote the Art Gallery?

# **Answer**

47. Since 2011/12 the NSW Government, through Arts NSW, has provided a total of \$65,500 in program funding to the Gloucester Arts & Cultural Council Inc for Gloucester Gallery as a contribution to its annual program.

# **Question 48**

48. What grants has the Minister provided for Upper Hunter Council and the Gallery to promote the Muswellbrook Regional Arts Centre?

### **Answer**

48. Upper Hunter Council has not applied for or requested funding for Muswellbrook Regional Arts Centre from Arts NSW during the time of this government and therefore has not received any grants.

### **Question 49**

49. What grants has the Minister provided for Dungog Council and the Gallery to promote the Art Gallery?

49. Dungog Council has not applied for or requested funding from Arts NSW for a gallery during the time of this government and therefore has not received any grants.

# **Question 50**

50. What grants has the Minister provided for Port Stephens Council and the Gallery to promote the Art Gallery?

### **Answer**

50. Port Stephens Council has not applied for or requested funding from Arts NSW for a gallery during the time of this government and therefore has not received any grants.

# **Question 51**

51. What grants has the Minister provided for Lake Macquarie Council and the Gallery to promote the Art Gallery?

### Answer

51. Since 2011/12 the NSW Government, through Arts NSW, has provided a total of \$448,476 in program and project funding to Lake Macquarie City Council for Lake Macquarie City Art Gallery.

### **Question 52**

52. What grants has the Minister provided for Port Stephens Council and the Gallery to promote the Art Gallery?

# **Answer**

52. Port Stephens Council has not applied for or requited funding from Arts NSW for a gallery during the time of this government and therefore has not received any grants.

# **Question 53**

- 53. What grants has the Minister provided for Singleton Council to promote the Arts.
- (a) Will the Minister support Singleton in their quest to build an Art Gallery?
- (b) If so, how much funding will be provided?

- 53. Singleton Council has not received any Arts NSW grants during the time of this government.
- (a) Any future requests for assistance to build an Art Gallery will be considered in the context of government priorities and the State Budget.
- (b) as per response to 53 (a).

### Australian Museum

### Question 54

54. What is the current status of the state government commitment of \$7.2million to the Australian Museum for the immediate work to develop a new entrance, and a new gallery exhibiting 400 endangered animals in a biodiversity display plus a revenue raising rooftop restaurant?

### Answer

- 54. The NSW Government has committed the following:
  - FY 2014/15 \$2.5M (Stage 1 transforming the Museum NSW Trade and Investment)
  - FY 2014/15 \$2.011M (Master planning Treasury allocation)
  - FY 2015/16 \$2.711M (Master planning Treasury allocation)

Note that Stage 1 is a \$4M project. In addition to the \$2.5M, the Museum is also allocating \$1.5M from its existing capital funding.

Stage 1 projects include – the new entrance on William St (Crystal Hall) with extensive, 4.5m wide, low gradient ramp (greatly improved access); removing sub-station to include a garden; reconfiguring hallways and entrances to two major galleries; upgrades to associated fire stair and extending a public lift up two floors to the roof.

# Walsh Bay Arts Precinct

# **Question 55**

55. How close to completion is the construction work to redevelop the Walsh Bay area into an arts precinct – to create a distinctive and connected arts and cultural precinct that showcases our premier Australian arts companies – to support the arts and strengthen Sydney's visitor economy?

#### Answer

55. The Government has been steadily progressing work in planning for the Walsh Bay Arts Precinct Redevelopment over the past two years. In June this year a Concept State Significant Development Application was lodged with the Department of Planning and Environment. This application was placed on public exhibition from 17 July until 15 August and submissions have been made

by a number of groups and individuals. In accordance with the required process, Arts NSW will respond to these submissions and the Department of Planning and Environment will then assess the application.

# **Western Sydney Arts Development**

### **Question 56**

56. What work is being developed in Western Sydney to provide training for young people to develop careers in the arts?

### **Answer**

56. This question should be referred to the Minister for Education.

# **Arts and Cultural Policy**

# **Question 57**

- 57. In February 2013 the then Minister for the Arts appointed a reference group to guide the development of a NSW arts and cultural policy through the preparation of a discussion paper, a consultation process and the development of the final policy. The policy was to provide a clear direction for the sector over the next decade and aims to recognise its central economic role as part of the Visitor Economy Action Plan.
- (a) Where are the findings from the discussion paper and what is the government's response to the findings?
- (b) What is the current status of the NSW arts and cultural policy?

#### **Answer**

57.

- (a) The findings from the Discussion Paper have been consolidated into a Consultation Outcomes Report which is now available on the Arts NSW website. The findings are informing the development of the Arts & Cultural Policy.
- (b) The Arts & Cultural Policy is anticipated to be launched by the end of the year.

# **Aboriginal Arts and Culture**

# **Question 58**

58. According to Arts NSW, the NSW Aboriginal Arts and Cultural Strategy "aims to foster a vibrant Aboriginal arts and cultural sector that gives Aboriginal people greater opportunities to participate in, share and strengthen their culture through arts practice, and to develop careers and businesses in the arts and

- cultural sector. Support is prioritised against the strategy's four directions: artists, visibility, community and jobs."
- (a) What is the current status of this strategy?
- (b) How much money was allocated to it in the 2014/15 budget?

58.

- (a) The NSW Aboriginal Arts and Cultural Strategy 2010-2014 is in its final year.
  - Stage 2 of the NSW *Aboriginal Arts and Cultural Strategy 2015-2018* will build on the Strategy's achievements of the last 4 years and will focus for the next triennium on Direction 4 Jobs.
- (b) The strategic Aboriginal Arts and Culture 2014/15 budget is part of the overall 2015 Arts and Cultural Development Program (ACDP) budget.

# **Attendance at Sydney Opera House**

### **Question 59**

- 59. Given that of the top 20 Sydney postcodes registered as purchasing tickets to Opera House events last financial, not one is in Western Sydney and while more than 10,000 people from Surry Hills, Sydney City and Bondi bought tickets, only 448 people from Parramatta's four postcodes saw an Opera House show meaning the Sydney City art venues clearly aren't catering to the needs of Western Sydney residents:
- (a) Does this Government support Parramatta Lord Mayor John Chedid's suggestion of an expansion of the Riverside Theatres?
- (b) If so, what has the government done to progress this project?
- (c) If not, what plans does the Government have to support the arts in Western Sydney?
- (d) Why has this Government not supported the arts in Western Sydney?

- 59. Since the Coalition came to power in March 2011, more than 185,000 people from Western Sydney have attended shows or a tour at the Opera House and 15,400 students from 216 Western Sydney schools have participated in onsite and digital education experiences.
- (a) Arts NSW has received a proposal from Riverside that is under consideration. Discussions with the organisation are ongoing.
- (b) see 59 (a)
- (c) The Premier has appointed Ms Liz Ann Macgregor as cultural ambassador to Western Sydney. Arts NSW is working to strengthen its relationship with the arts and cultural sector in Western Sydney.
- (d) The NSW Government strongly supports the arts in Western Sydney through the new Arts and Cultural Development Program (ACDP), Screen NSW and the

state cultural institutions. Under the ACDP, the NSW Government requires organisations applying for program funding to deliver activities that engage people from at least one of the Government's priority areas. Western Sydney is one of the priority areas. Arts NSW is working closely with Urban Growth and other State agencies to explore the potential for the integration of arts and cultural facilities into the Parramatta North precinct, particularly the important heritage Cumberland and Old Kings School sites, as part of the Parramatta North Framework Master Plan.

### **Public Libraries**

# **Question 60**

- 60. This budget shows no increase in the per-head of population recurrent funding to public libraries (through the State Library).
- (a) How does the Minister expect our public libraries to stay afloat when Councils are increasingly unable to pay their unfair share of recurrent funding which is often over 90%?
- (b) Why has this budget not shown the direly needed increase in per capita funding, to match CPI?

### **Answer**

60.

- (a) Public libraries are owned and operated by councils and as such councils contribute the greater proportion of recurrent funding.
- (b) The Government has increased its funding to assist local authorities in the provision of public library services to a record high of \$27.5M in 2014/15. Per capita allocation is only one component of NSW Government support for public libraries. The statutory per capita contribution of \$1.85 plus the Disability and Geographic Adjustment Grant (DGA) gives \$2.74 average per capita. In addition, grants programs are focussed on supporting priority programs to assist councils improve public library services for NSW communities

HOSPITALITY, GAMING AND RACING

**Review of the Thoroughbred Racing Act** 

### **Question 61**

61. Minister you indicated that the revised Thoroughbred Racing Act would be tabled in the Parliament on the 30<sup>th</sup> of June. Why has that not occurred yet?

## **Answer**

61. The Report of the five year statutory review of the *Thoroughbred Racing Act* 1996 and the three year statutory review of the *Australian Jockey and Sydney Turf Clubs Merger Act 2010* was tabled in the NSW Parliament on 6 August 2014.

# Race fields

## **Question 62**

62. Minister for the 2013/14 financial period, how much revenue was raised through the Race fields Legislation tax rate?

#### **Answer**

62. The race fields fee scheme is not a government tax. The government has no involvement in the collection or allocation of race fields fees. Consequently, this information is not held by government and should be referred to the relevant controlling body.

The Racing Administration Act 1998 and supporting regulations deal with race fields information use approvals and fees.

The legislation provides that a relevant racing control body (Racing NSW, Harness Racing NSW and Greyhound Racing NSW) may impose a condition on a race field information use approval that the holder of the approval must pay a fee to cover the cost of assessing the application for the approval.

## **Question 63**

What was the distribution between each major racing industry (Harness, Greyhounds and Racing NSW?).

## Answer

## **Liquor Licences**

## **Question 81**

81. Between January 2013 and January 2014 – how many liquor licenses were in the Sydney CBD Precinct Area?

#### **Answer**

81. The CBD Precinct Area was declared in February 2014 and at that time there were 1,318 licensed venues located within it. As at 29 August 2014 there are 1,325 liquor licences within the Precinct.

The Authority captures liquor licensing statistics from the Government Licensing System (GLS) based upon suburb, postcode and Local Government Area (LGA). GLS cannot report on licensed premises unless they are squarely located within one of these categories.

The CBD Entertainment Precinct is within the City of Sydney LGA and 2000 postcode. The Sydney LGA comprises 33 suburbs and the 2000 postcode comprises 8 suburbs, only some of which are within the Sydney LGA (eg, Darling Harbour).

The number of liquor licences within the CBD Precinct was confirmed via a geocoding tool. Because of this the Authority would incur significant costs if it were to replicate that process to produce the requested historical data. As an alternative the following information is provided –

 As at 1 January 2013 there were 2,226 liquor licences within the Sydney LGA  As at 1 January 2014 there were 2,397 liquor licences within the Sydney LGA.

## **Question 82**

82. As of 22 August 2014 how many liquor licenses are in the Sydney CBD Precinct?

The GSE Act applies to workforce management in the Public Service and more broadly across the government sector for provisions such as performance management and workforce diversity. Two important areas of reform relate to changes to the executive structure of the Public Service and changes to employment arrangements and management practices which apply more generally to non-executive employees of the Public Service.

Overall, the GSE Act provides the foundation of a modern and effective public sector workforce, attracting and retaining talented people who want rewarding careers and who are well-equipped to deliver the best service to the people of NSW.

136. Where the organisational review program identifies that changes are required to organisational structure, a change plan is developed. The majority of staff affected by the change plan are able to be redeployed or transferred to new roles. The majority of change plans deliver savings to the agency as well as aligning resources and organisational structures to operational goals and achievement of state plans or government priorities. Some change plans are in place to manage government service delivery decisions and do not deliver savings to the Department. The change plans are one of the strategies in addressing our budget allocation, for this financial year and over the forward estimates along with procurement savings, ICT savings and other operating cost reductions.

It is expected that one of the outcomes of the GSE Act reforms will be a reduction in senior executive roles.

## **Questions relating to Newcastle**

#### **Question 161**

161. Please provide a full explanation why state funding wasn't provided for the Newcastle Art Gallery to support the Federal funding that was originally offered and the \$1m community fundraising for this state's second largest art gallery?

#### **Answer**

161. No commitment has been made by the NSW Government to the Newcastle Art Gallery or Newcastle City Council to contribute financially to the redevelopment to date.

It is understood the agreement between the Federal Government Regional Development Australia Fund (RDAF) and Newcastle City Council did not stipulate the remaining \$7 million was to come from the NSW Government.

The proposal to the State Government was considered in the context of Government priorities and the State Budget at that time. The 2013-14 State Government budget, again, did not allow for a funding allocation.

## **Question 162**

- 162. Due to the loss of this project in the foreseeable future was any assessment made of the implications of this decision for:
- (a) The local economy?
- (b) The impact on the gallery's future visitation levels?

## **Answer**

162.

- (a) No, the Newcastle Art Gallery is a local government facility and therefore the impact of funding would be managed by Newcastle City Council.
- (b) No.

## **Question 163**

163. Are there any other specific funding projects for the arts in Newcastle?

#### **Answer**

- 163. Arts NSW's Arts and Cultural Development Program (ACDP) does not have a specific funding category for arts projects in Newcastle. However the ACDP has priorities such as regional NSW which includes Newcastle.

#### **Question 164**

## Questions relating to major museums funding

#### **Question 166**

166. Can you explain what funding is available to museums?

## **Answer**

166. Arts NSW's Arts and Cultural Development Program (ACDP) accepts applications from museums operating as not-for-profit organisations or local government bodies. The ACDP provides a range of funding opportunities for NSW museums to deliver arts and cultural activities across NSW. Applications to the main rounds of the 2015 ACDP have closed. The next round of ACDP funding (for 2016) will reopen in May 2015.

Arts NSW also provides devolved funding towards the Museums and Galleries NSW (M&G) program. M&G NSW offer a range of grants specifically for museums. These include Regional Museum Networking grants and a range of VIM grants for Volunteer Initiated Museums. These grant rounds operate throughout the year, with opening and closing dates posted on M&G NSW's website.

#### **Question 167**

167. The Museum of Applied Arts and Sciences, including the Powerhouse Museum has had budget cuts over the last three years and is undergoing a number of rounds of staff cuts, please explain how one of Australia's premier museums can achieve the goals of the new director to "realise plans to bring more of the collection into the galleries, rethinking and reinterpreting experiences and we will exploit new technologies to extend our reach and engagement to new audiences." (2012-13 Annual Report) with fewer staff?

167. In 2014 The Museum of Applied Arts and Sciences (MAAS) released a new 2020 Vision, to increase visitation and engagement. In order to achieve this vision a new structure has been developed to ensure staff work in a more focussed and strategic manner. The structure will ensure an acceptable level of staff to operating budget.

## **Question 168**

168. Please explain why it is necessary to dispense with curators who have such extensive knowledge and experience, given the staff cuts which are ongoing?

#### **Answer**

168. Staffing has been restructured to align with the 2020 Vision. All areas of MAAS operations have experienced some change. The structure and operations of the curatorial team are now aligned to eight collection disciplines. This will result in increasingly skilled and multidisciplinary curators and a stronger program delivery to the people of NSW.

#### **Question 169**

169. Please explain to what use the \$32.5 m capital expenditure for 2014-15 will be put?

#### Answer

169. The expenditure includes:

- \$28.95M for construction of a significant shared storage and collection access facility in Western Sydney on behalf of the Australian Museum, Sydney Living Museums and the MAAS.
- \$1M for Powerhouse Museum fire detection and alarm systems upgrade
- \$420,000 for Powerhouse Museum work, health and safety works
- \$227,000 for Powerhouse Museum toilets upgrade
- \$1.87M for minor works.

## **Question 170**

170. What is the intention of the Masterplan for the Museum of Applied Arts and Sciences with regard to the building which lies between Macarthur St and faces onto Mary Ann St in Ultimo?

#### **Answer**

170. MAAS is currently developing a Masterplan to ensure the Powerhouse is Australia's leading museum of Applied Arts and Sciences. The future of the

Harwood Building, between Macarthur and Mary Ann Streets in Ultimo, will be determined as part of this Plan.

- v. What capital works / infrastructure programs were funded in 2013/14?

#### **Answer**

171.

- i. No. The Library regulation which specifies the subsidy was reviewed in 2010 and will be reviewed in 2015.
- ii. The results of the review of the Library Regulation will be made public when a revised Regulation is promulgated.
- iii. The average payment to councils in 2013/14 in support of public libraries was \$2.74 per head. The total figure per council is a combination of the \$1.85 per capita prescribed amount and the Disability and Geographic Adjustment payment. Figures are published on the State Library of NSW website.
- iv. 2014/15 allocations to councils have not yet been determined. Once approved, the allocations will be communicated to councils and published on the State Library of NSW website.

## **Questions on the State Library**

## **Question 172**

- 172. In the 2013-14 Annual Report the Chief Librarian has acknowledged that the State Library must reduce its staff by 20% over three years and that 38 staff members had already taken voluntary redundancy.
- (a) Has any analysis been done, or are there plans in progress, to determine the interface required by staff with users of the new technology provided in libraries?
- (b) If so when will the results be available to the public, If not, why not?

- (c) Please provide an explanation of how the Library will be able to continue to deliver its vital services into the future with 20% fewer staff?
- (d) Despite computers performing some tasks previously done by librarians, there is anecdotal evidence that due to the changes in technology, librarians are busier than before providing assistance to users of the new technology, how can librarian numbers be reduced in the face of an increasing workload and yet provide adequate service to library users?

172.

- (a) Analysis of the interface required by staff with users of the new technology provided in libraries has been undertaken as part of the Digital Excellence Program funded by the State Government, including a complete renewal of the Library's underlying infrastructure and systems
- (b) There are no plans to release the analysis undertaken. The Library regularly assesses the impact of new technology on the services delivery including the training needs of both staff and clients. The analysis and results are made within operational and procurement processes, which are not made available to the public.
- (c) The Library is currently undergoing a major functional review which aims to streamline operations and review services to support the Library's commitment to the provision of contemporary and quality information services to the public.
- (d) The functional review currently under way aims to identify areas of high demand ensuring that current service levels are maintained whilst allocating resources to areas of growth including online services. The recent review of the Information Services Division has resulted in an increase in positions for professional librarians and curators and included provision for staff to continue to provide such technology assistance.

## **Question 173**

173. Please provide a breakdown of the tasks performed by the volunteers at the State Library.

#### Answer

173. Volunteer tasks at the State Library span two main categories: front-of-house and behind-the-scenes. Front of house volunteers offer guided tours, promote the *Curio* app and welcome visitors to the galleries, as well as the Shakespeare Room, they also present the Speakers Program offsite. Behind-the-scenes volunteers tasks include: sorting ephemera; assisting with digital images;

transcribing manuscripts, assisting with oral history and the performance of a range of basic administrative tasks such as mail outs, data entry and indexing.

## **Questions relating to Regional Conservatoriums**

#### Question 174

174. The NSW government has provided \$2.1m for the 17 regional conservatoria including \$690,000 for 23 projects.
