	\$80 million for preliminary work on a new straightened route between Menangle and Yerrinbool.
	\$125 million for the duplication of the rail line between Berry and Gerringong, along with extra platforms at Bomaderry.
	\$80 million to develop a new rail alignment between northern Sydney and Woy Woy. This will include investigations to inform major tunnelling work that would be required for this section.
	Initial \$10 million get work underway on the route to the Central West. This will include a particular focus on options for crossing of the Blue Mountains.
