Proposal Title: Unblocking supply chains

Notes and costing assumptions:

This policy proposes to reduce the cost of goods and services in NSW by:

- appointing a Supply Chain Commissioner
- providing a rebate for heavy vehicle course fees between \$500 and \$1,000 for 7,000 people aged under 30 and
- advocating for reform to national regulations on packaging.

The policy stipulates costs will be borne by specific departments without providing additional funding.

- The Department of Premier and Cabinet (DPC) will be directed to fund the Supply Chain Commissioner and associated staff at an estimated cost of \$14.7 million over the forward estimates.
- Transport for NSW (Transport) will be directed to fund the heavy vehicle course fee rebate, at an estimated cost of \$5.25 million over two years.

As the policy stipulates these costs should be absorbed by DPC and Transport without additional funding, the PBO has costed this policy as having nil budget impact, while also providing estimates of the departmental resources that will be required in the sections to follow.

Notes and costing assumptions continued:

Costs – Department of Premier and Cabinet

The PBO has estimated the cost to the department of appointing a Supply Chain Commissioner, using information supplied by Transport for NSW for a similar appointment and suitable supporting staff (Table 1).

The PBO notes that a discount should be applied to allow time for ramping up in the first financial year of the policy. The PBO has assumed costs in the first year would only be 25% of the full annual cost, considering the number of months that will remain in the 2022-23 financial year after the formation of government, and reduced the estimated costs accordingly (Table 2).

Costs – Transport for NSW

The policy states that the rebate offered to those undertaking heavy vehicle courses will:

- range between \$500 and \$1000
- be limited to 7000 applicants
- will cost \$5 million over two years
- be only available to applicants aged under 30
- be funded by Transport for NSW from existing resources.

Based on those stated policy parameters, the PBO assumes the average value of the rebate offered will be \$750, with an estimated total cost to the department of \$5.25 million over two years (Table 3).

Heavy vehicle courses are training courses that enable people to drive heavy vehicles. The PBO has compiled an example list of advertised prices of heavy vehicle courses (Table 4).
