## Notes and costing assumptions:

This policy proposes to double the Government commitment<sup>1</sup> of \$3m to the Regional Media Fund (taking the additional contribution to the Fund to \$6m) and allocate an extra \$3 million for advertising in regional print media. This brings the total cost of the policy over two years to \$9m. The government commitment of \$3m to the Fund is an election promise that has not been included in the forward estimates.

The policy assumes the funding will be sourced from the Regional Growth Fund (RGF). The PBO considers this assumption reasonable.

Advice from the Department of Regional NSW (DRNSW) on amounts in the RGF that are committed, uncommitted, reserved and unallocated is that there is a total of \$607.9 million that is "reserved" and "unallocated" (see table 1).

The "uncommitted" funding of \$108.4 million shown above is unlikely to be possible to reallocate in practice, given letters of offer have been sent to recipients advising them their grant has been approved. The funding available for reallocation is thus the total of the "reserved" and "unallocated" funds, or \$607.9 million.
