AN ICONIC WALKING PATH FOR ILLAWARRA FAMILIES

Wednesday 9 March 2011

A re-elected Labor Government will invest \$1 million to connect and upgrade walking tracks in the Illawarra – creating a single walking path from Bundeena to Dapto.

Under the plan, the *Bald Hill Link* will be constructed to link the Coast Walk in the Royal National Park with the Illawarra Escarpment walking tracks. The track south from Stanwell Park will also be upgraded as will the track north of Bald Hill to Otford.

Premier Kristina Keneally was joined by the Member for Heathcote, Paul McLeay, and Candidate for Keira, Ryan Park, at Sublime Point to make the announcement.

"We know that the most popular activity in our parks is walking. That is why a re-elected Labor Government will connect these two walking tracks," Ms Keneally said.

"By joining these two tracks will make this an iconic walk not just in the Illawarra, but across the State.

"I would also like to acknowledge Paul McLeay for this work on this project. This couldn't have happened without his advocacy and support. He has been its number one advocate."

The funding will be allocated to both the construction of links and facilities;

- \$350,000 to complete from the track from Bald Hill to Austinmer including the Bald Hill Link;
- \$350,000 to complete from Bald Hill to Otford; and
- \$300,000 for facilities such as visitor information sights and signage along the route.

Mr McLeay said: "This project will create an iconic walk right in the heart of our community. Once completed, it will attract walkers from across the State, as well as interstate and overseas visitors.

"Local families will also be able to enjoy this picturesque walk with easy access to public transport options along the route.

"The Royal National Park was the second national park created anywhere in the world – which is one of the reasons why it is so important to ensure it is there for the community to enjoy.

"This will complement the investment the NSW Government has already made in the track, particularly at Sublime Point.

"Having a walking path which reaches from Bundeena to Dapto will provide more opportunities to take in the spectacular beauty of our local area."

Mr Park welcomed the announcement and said it would complement the investment the NSW Government has already made in the track, particularly at Sublime Point.

"This track in the Illawarra Escarpment State Conservation Area is a draw card for visitors to the region and offers residents a great local attraction.

"This is a spectacular part of our State and I'm proud that the NSW Government has committed to this funding, so that future generations of families can continue to enjoy it."
