### CLIMATE CHANGE: A LIVEABLE WESTERN SYDNEY - ONE MILLION TREES

Sunday 27 February 2011

A re-elected Keneally Government will plant one million trees across Western Sydney by 2015 – as part of a \$10 million fund.

It will be in partnership with community and environmental organisations such as Greening Australia – which has put forward a similar unsolicited proposal to the NSW Government.

Labor's plan is based on similar global initiatives including New York City, Toronto, Tokyo and Los Angeles.

Set up in May 2006, *milliontreesLA* increased tree cover from 20 per cent to 27 per cent and generated \$100 million in electricity savings. New York City has set a one million tree target by 2017.

NSW Premier Kristina Keneally said: "Greening Australia has done outstanding work in this area and we would like to develop and expand on their expertise – possibly in partnership with them."

<u>The NSW Government will work with key researchers to identify priority areas – with a focus on re-afforesting the Western Sydney Regional Parklands and urban conservation corridors such as Ropes and South Creeks between Blacktown and Penrith.</u>

The remainder would involve greening up urban streetscapes in conjunction with local councils.

Western Sydney now has so much exposed paved surface, temperatures have risen markedly in the region – the annual summer maximum in Western Sydney is now six to eight degrees higher than it was in the 1960s.

The number of days with temperatures or more than 35 degrees a year has increased 250 per cent in Western Sydney since the 1960s, but only 22 per cent in the city. 1

"The lack of tree cover in Western Sydney means residents are experiencing a hotter climate already and this will only get worse with climate change," Ms Keneally said.

"More families in Western Sydney will have to rely on air-conditioners than the rest of the City, increasing their bills.

"Dramatically expanding tree cover will improve the health and quality of life of residents in Western Sydney, as well as ease electricity demand and cost-of-living.

"While we have a plan to create a clean, green Western Sydney, the Opposition leader Barry O'Farrell's vision is urban sprawl – with thousands of more cars on the road.

"Mr O'Farrell is a climate change denier. Just like Tony Abbott, Mr O'Farrell says he does not believe climate change is real.

"Well, putting your head in the sand isn't going to make the problem of a carbon constrained future go away."

### **Background Notes:**

- Trees clean the air by filtering a wide range of pollutants with a significant knock-on effect for sufferers of asthma and other respiratory disease.
- Trees deliver a pronounced cooling effect.
- Tree cover can cool ground temperatures by as much as eight degrees this is because paved surfaces such as roads and roofs absorb and then radiate heat from sunshine.
- Tree cover shades these surfaces, and trees respond to sunshine by allowing moisture from the ground to evaporate through their leaves, cooling the air. There is a big difference whether sunshine hits concrete or hits greenery.

The proposal is to spend \$10 million over 4 years to green Western Sydney using the services of Greening Australia (GA). Advice from the Minister for Climate Change and the Environment's Office (Minister's Office) indicates that expenditure will begin in 2011-12 and be spread evenly over the 4 years. The Minister's expectation is that the proposal would be funded with additional resources rather than from existing programs. It is assumed that the partnership with GA can be managed within the existing resources of the responsible agencies namely the Department of Environment, Climate Change and Water and the Office of Western Sydney.

#### Caveats or qualifications

The Minister's Office advised that GA would have the capacity to deliver this commitment through its volunteer network and infrastructure. GA delivers over 5,000 volunteer-work hours annually allowing greening projects to be delivered cost-effectively to government. However, the Minister's Office has not confirmed this proposal with GA. According to the GA 2009-10 financial statements, operational expenditure countrywide was around \$22m. This proposal represents an 11.4% increase in operations targeted at a limited geographical area (Western Sydney). If GA cannot ramp up activities, this could alter the proposed expenditure profile and program delivery.

Implementation issues (including how Treasury can assist in speedy implementation and any potential difficulties and how these might be overcome)

According to the Minister's Office, GA currently has similar smaller contracts with other state agencies such as the Western Sydney Parklands Trust and the Land and Property Management Authority. This could provide a model for the larger project being proposed.

Other comments (including explanation where Treasury costing differs from agency or PBO estimates

The Minister's Office advised that it will be meeting with GA to confirm this proposal on 23 February 2011. This meeting should provide a better indication of GA's capacity to deliver this project.
