I write regarding the Legislative Council order for papers under standing order 52 passed on 13 November 2024 (the Resolution) in relation to the ECEC Sector.

It has come to our attention that a document created by the Department in response to the Resolution, and included in the Department's first return lodged with the Clerk's Office on 11 December 2024, contains incorrect and misleading information which has the potential to harm a third party.

As you are aware, the Member who sought the documents highlighted particular areas of interest to the Department to support the return of key documents as quickly as possible. The Department continues to advise that full compliance with the Resolution would capture millions of documents which would not have been possible to prepare and produce in the 28 given days.

The Member agreed to defer compliance in relation to part (e) of the Resolution, on the condition the Department provided aggregate or summary data. Therefore, the Department created a summary document providing aggregate data to address items (e)(v), (e)(vi) and (e)(ix) of the Resolution and included it in the production, noting that it is dated outside the Resolution scope. The document reference is DOE.001.0000465 and it was included in the non-privilege bundle.

During the process of creating the aggregate data document, the Department of Education employee preparing the document was also processing documents in relation to a particular ECEC service, Kids Academy Spring Farm and their provider, Affinity, in response to paragraph (k) of the Resolution. Unfortunately, the aggregate data document was accidentally labeled with the name of the individual service.

Specifically, under the heading "**Addressing SO52 items (e)(v), (vi), and (ix)**" on page 1 of the document, is the summary data requested by the Member as part compliance with paragraph (e) of the Resolution. However, the information included in the document above that heading, which refers to Kids Academy Spring Farm and Affinity is not correct.

The Department confirms that the summary data in the tables correctly relates to all service providers in operation within NSW and does not relate solely to Kids Academy Spring Farm and Affinity.

The Department is aware that journalists have publicly reported incorrect information from the document, incorrectly attributing the whole-of-state data to the one service. Therefore, the Department is of the view that the information in relation to Kids Academy Spring Farm and Affinity should be redacted from the document so there is no confusion for the Parliament and the public, and also to ensure there is no potential harm to the ECEC service from the data being incorrectly attributed to their service.

The Department apologises unreservedly for the human error, and is requesting the Parliamentary record be corrected.

The Department therefore requests that:

- The information included in the document above the heading “**Addressing SO52 items (e)(v), (vi), and (ix)**” on page 1, be redacted (attached at TAB 1 is a redacted version of DOE.001.0000465); and
- The index is redacted to remove the name Kids Academy Spring Farm from the title of document DOE.001.0000465 (attached at TAB 2 to this letter is the redacted index).
