I write regarding the Legislative Council order for papers under standing order 52 passed on 13 November 2024 and further passed again on 18 March 2025 in relation to the Early Childhood Education and Care Sector (SO52).

On 27 March 2025 the Parliament passed a motion to have the Department of Education re-produce the first return of documents in accordance with the final report of the Independent Legal Arbiter. PRIVILEGE AND PERSONAL INFORMATION SUBMISSIONS FOR RETURN TO ORDER: Early Childhood Education and Care Sector

This submission has been prepared in support of the claims for privilege made, pursuant to Standing Order 52(7), by the Department of Education (the Department) over documents responsive to the Order of the Legislative Council of 13 November 2024, and the Order of the same scope that was further passed on 18 March 2025. They should be read in conjunction with the details of the documents specified in relevant indexes.

Claims of privilege over the information contained in the documents are made on the grounds of:

- 1. Public Interest Immunity (PII) Responsible and Effective Government
- 2. Public Interest Immunity (PII) Personal Information.

The Department has provided redacted copies of documents to the House as part of its non-privileged return.

Dispute of privilege claims

In the event a member disputes any claim made in these submissions (per standing order 52(8)), the Department is available to participate in discussions with the member regarding the scope of the dispute.

Per standing order 52(9), a disputed document or documents may be released to the Independent Legal Arbiter (**Arbiter**) for evaluation and report. The House may choose to publish documents following the Arbiter's advice as to the validity of the claim. Accordingly, the Department requests the opportunity to provide additional submissions in support of any claims that are referred to the Arbiter. This would afford the Department procedural fairness and reflects the fact that the Department may be able to provide additional material tailored to points raised by a member in dispute. Additional information provided by the Department in this context may in turn inform the House's consideration of the possible publication of papers subject to dispute.

Claim pursuant to standing order 52(6) - PII: Prejudice the proper functioning of government

DOE.002.0000079 contains information obtained from the Commonwealth Department of Education. The Arbiter has agreed in his final report to allow redaction of certain paragraphs that contain sensitive information to which the Commonwealth objected to release. Redaction has been made to those parts, for the reasons outlined in the Department's previous privilege submissions and the Arbiter's final report.

Claims pursuant to standing order 52(7) – Personal information

Standing order 52(7) applies in circumstances where a document "is subject to a claim that it contains personal information that **should not be made public** but is not otherwise subject to a claim of privilege". Standing Order 52(7) avoids the need to determine whether a claim that a document containing personal information should not be made public would also support a claim of "privilege".

The expression "is not *otherwise* subject to a claim of privilege" is taken to mean that the document is not subject to a claim of privilege for reasons unconnected with the disclosure of the personal information.

In relation to documents listed in the privileged index, a claim of personal information is made in accordance with standing order 52(7).

The Department also notes that the Arbiter agreed in his final report to allow redaction of certain personal information relating to children and their parents identified in the documents. The Deputy Premier and Ms Boyd have further agreed to redactions in relation to the personal information of educators identified in the documents.

Redaction has been made to documents to remove the personal information as outlined above.

Each document in this category contains documents which, if disclosed, would involve the disclosure of personal information of children, parents and/or early childhood education centre employees. Personal information subject to this category includes, but is not limited to individual:

- a) names;
- b) dates of birth;
- c) addresses;
- d) health information of an individual;
- e) identifying information that if disclosed would put a child or individual at risk of harm;
- f) information that would lead to the identification of a mandatory reporter.

The Department submits that:

- a) it is not in the best interests of the children, or in the public interest, to disclose the names and dates of birth of children, and by extension, their parents' names as this would also identify the children;
- b) it is not in the public interest to disclose personal addresses or email addresses of individuals employed by Early Childhood Education and Care (ECEC) services;
- c) it is not in the public interest to disclose the name of an individual connected with an ECEC service where to do so would reasonably create a risk of harm for that person.

The Department has made a claim for privilege on the basis of privacy in respect of a number of documents where the disclosure of these documents would result in the disclosure of personal information.

There are also a small number of documents that refer to mandatory reports and their informants. The Department submits that this information is highly confidential. Section 29 of the *Children and Young Persons (Care and Protection) Act 1998* provides strong protections of anonymity to mandatory reporters so as to ensure they continue to feel comfortable coming forward to make reports, as well as to maintain their safety and remove the risk of retribution. The Department submits that it is not in the public interest to release such information on this basis.

Further, this personal information is not publicly available and was received in circumstances where there was no expectation of publication. The publication of such information is not in the public interest. Furthermore, such information would ordinarily be protected from public disclosure pursuant to the *Government Information (Public Access) Act 2009, Freedom of Information Act 1982* or the *Privacy and Personal Information Act 1998*. If any member, after reviewing the redacted documents, considers pressing for certain personal information to be published in unredacted form, the Department would intend to provide the affected individuals with an opportunity to comment.
