I write regarding the Legislative Council order for papers under standing order 52 passed on 13 November 2024 in relation to the Early Childhood Education and Care (ECEC) Sector (the SO52 Resolution) and the final report of the Independent Arbiter, the Hon Keith Mason AC KC dated 20 March 2025 relating to a privilege dispute for the first return of documents for the SO52 Resolution (Report).

The Report noted an assumption that the parties would be able to agree on redacted versions of all the documents based on the Report.

In that regard, I wish to advise that the Deputy Premier and Ms Boyd MLC have agreed to the following:

- The offices and agencies named in the order will provide documents to the Parliament with the names and personal information (as set out in standing order 52 (7) (e)) of individual educators or witnesses to incidents redacted, as well as personal information that could identify an educator or witness where they have been the alleged victim of inappropriate behaviour or another similar incident, or the personal information is medical in nature
 - Anonymised information relating to educators will not need to be redacted where the names of educators and specific identifiable incidents as outlined above have been redacted
- Further potentially identifying information may be redacted in the event that an investigation into a matter is ongoing and an allegation has not been substantiated at the time of the release of documents, but the provision for the release of these documents, unredacted, is the same as is outlined below
- There will be an agreed upon easy/frictionless process for Ms Boyd or other Members to undertake to have unredacted versions of specified documents, with the names of individual educators provided, in the event that they had concerns about systemic, widespread, or other significant issues in the public interest with individual educators (the example given was an educator moving between multiple services and breaching the regulation at multiple services in a way that demonstrated that the RA had failed to act)
 - And this process is effectively Ms Boyd or any other Member informing the Department & Deputy Premier's Office that specific documents are to be provided publicly in line with the Arbiter's report, with a

reasonable timeframe (3 business days) given to the Department & Deputy Premier's Office for response

- The Independent Legal Arbiter will be made aware of this agreement

Attached to this letter at Tab A is a copy of an email chain reflecting that agreement between the parties.

I ask that this letter, along with Tab A, is provided to the Independent Arbiter for his information.

Dear Ms Boyd,

Thank you for taking the time to discuss this matter with my staff.

The Government is extremely concerned about the potential for the publicising of any personal and health information in relation to educators that work in the early childhood education and care sector as a result of this release, and we thank you for working with us in good faith to address these concerns.

As per the conclusion of the Independent Legal Arbiter's report, we are seeking to formalise an agreement regarding documents that have already been returned under the order of the House made on 13 November 2024, any future documents returned under this order, and by extension any documents returned under the order of the House made on 18 March 2025, noting that you have kindly agreed to limit the scope of this order to mirror that of the order made on 13 November.

The agreement we propose is as follows:

- The offices and agencies named in the order will provide documents to the Parliament with the names and personal information (as set out in standing order 52 (7) (e)) of

individual educators or witnesses to incidents redacted, as well as personal information that could identify an educator or witness where they have been the alleged victim of inappropriate behaviour or another similar incident, or the personal information is medical in nature

- Anonymised information relating to educators will not need to be redacted where the names of educators and specific identifiable incidents as outlined above have been redacted
- Further potentially identifying information may be redacted in the event that an investigation into a matter is ongoing and an allegation has not been substantiated at the time of the release of documents, but the provision for the release of these documents, unredacted, is the same as is outlined below
- There will be an agreed upon easy/frictionless process for Ms Boyd or other Members to undertake to have unredacted versions of specified documents, with the names of individual educators provided, in the event that they had concerns about systemic, widespread, or other significant issues in the public interest with individual educators (the example given was an educator moving between multiple services and breaching the regulation at multiple services in a way that demonstrated that the RA had failed to act)
 - And this process is effectively Ms Boyd or any other Member informing the Department & Deputy Premier's Office that specific documents are to be provided publicly in line with the Arbiter's report, with a reasonable timeframe (3 business days) given to the Department & Deputy Premier's Office for response
- The Independent Legal Arbiter will be made aware of this agreement

We also propose to brief the Hon. Sarah Mitchell MLC on the above and provide her with a copy of this agreement.

Finally, the Government will not seek to amend Item 1857 before the House for formal business, subject to this agreement being acceptable.

Should this all be agreeable to yourself, we would greatly appreciate it if you would indicate so via email before the House sits today.

I refer to the:

1. Standing Order 52 (**SO52**) resolution passed by the Legislative Council on 13 November 2024 calling for papers to be produced by the Department of Education (**DoE**), the Deputy Premier, Minister for Education and Early Learning and Minister for Western Sydney, the Minister for Police and Counter-Terrorism and Minister for the Hunter, the NSW Police Force, the Minister for Families and Communities and Minister for Disability Inclusion, the Department of Communities and Justice, or the Office of the Children's Guardian relating to the Early Childhood Education and Care Sector (**Resolution**);
2. Tranche 8 of the documents that are responsive to the Resolution that was delivered to The Cabinet Office on 17 April 2025 (**T8 Return**); and
3. DoE's Privilege Submissions to The Cabinet Office dated 17 April 2025 with respect to the T8 Return (**T8 Return - Submissions**) - see Annexure A.

The documents that are responsive to the Categories in the Resolution were originally due to the NSW Parliament on 11 December 2024.

In order to demonstrate compliance with the Resolution and to assist the Legislative Council, the DoE is now producing 623 documents as part of this ninth return of production (**Documents**). The DoE submits that 622 of the 623 Documents contain personal information but are not otherwise subject to a claim for privilege (within the meaning of Standing Order 52(7)) (the **SO52(7) Documents**).

This letter, together with the T8 Return – Submissions in Annexure A, constitute the Submissions of the DoE in relation to this ninth return and outline the basis for its claims of privilege made pursuant to Standing Order 52(7) in relation to the SO52(7) Documents (**T9 Return - Submissions**). The T9 Return - Submissions are supplementary to the T8 Return – Submissions and, accordingly, where relevant, the T9 Return - Submissions will refer to, and rely upon, the claims made in the T8 Return – Submissions.

The DoE's claims of privilege are outlined in this T9 Return - Submission so as to allow the Legislative Council to consider the claims and, where applicable, to understand the reasons that it is not in the public interest for the SO52(7) Documents to be made publicly available. These Submissions should be read together with the Index of Privileged Documents (Personal Information) (**Index**) produced by the DoE in this return, which identify the documents over which a claim of privilege has been made and the nature of that claim.

The DoE refers to the general privilege principles outlined on pages 1 and 2 of the T8 Return – Submissions.

1. Summary of privilege claims

- 1.1 The DoE asserts a claim of privilege over the SO52(7) Documents on the basis that they contain personal information, including, for example, the sensitive details of private individuals, such as children and/or educators.
- 1.2 The DoE refers to the privilege principles with respect to SO52(7) outlined at paragraphs 1.2-1.3 of the T8 Return – Submissions.

2. Personal information

Documents contain personal information, including the details of private individuals and businesses

- 2.1 The DoE refers to the Personal information privilege principles outlined at paragraphs 2.1-2.2, and 2.4-2.6 of the T8 Return – Submissions.
- 2.2 The DoE submits that 622 of the Documents contain details of private individuals, such as, for example, children and parents, but are not otherwise subject to a claim of privilege within the meaning of Standing Order 52(7).
- 2.3 Examples of this information include (but are not limited to):
- (a) private individuals' names (excluding DoE employees and employees of other Government departments and agencies) and including names of minors;¹
 - (b) private individuals' home addresses;²
 - (c) private individuals' dates of birth;³
 - (d) private email addresses;⁴
 - (e) mobile telephone numbers;⁵
 - (f) signatures;⁶ and
 - (g) medical information which could allow for the identification of a private individual.⁷
- 2.4 It is uncontroversial that information of this kind is personal and should be kept confidential, and that this type of information has previously been held by Independent Arbiters as a sufficient basis to establish a claim for privilege (or at the very least, further redaction).⁸ Further, the type of information listed in paragraph 2.3(b), (d)-(f) (above) is specifically listed in SO52(7)(e) as being personal information which should not be made public.
- 2.5 The DoE refers to the personal information privilege principles with respect to signatures outlined at paragraphs 2.9-2.10 of the T8 Return – Submissions.

I refer to the Standing Order 52 (**SO52**) resolution passed by the Legislative Council on 13 November 2024 calling for papers to be produced by the Department of Education (**DoE**), the Deputy Premier, Minister for Education and Early Learning and Minister for Western Sydney, the Minister for Police and Counter-Terrorism and Minister for the Hunter, the NSW Police Force, the Minister for Families and Communities and Minister for Disability Inclusion, the Department of Communities and Justice, or the Office of the Children's Guardian relating to the Early Childhood Education and Care Sector (**Resolution**). The documents that are responsive to the Categories in the Resolution were originally due to the NSW Parliament on 11 December 2024 (**Return**).

In order to demonstrate compliance with the Resolution and to assist the Legislative Council, the DoE produces 438 documents as part of this eighth return of production (**Documents**). The DoE submits that 437 of the 438 Documents contain personal information but are not otherwise subject to a claim for privilege (within the meaning of Standing Order 52(7)) (the **SO52(7) Documents**).

This letter constitutes the Submissions of the DoE as to the basis for its claims of privilege made pursuant to Standing Order 52(7) in relation to the SO52(7) Documents and are outlined in this Submission so as to allow the Legislative Council to consider the claims and, where applicable, to understand the reasons that it is not in the public interest for the SO52(7) Documents to be made publicly available. In asserting privilege over the SO52(7) Documents, the DoE recognises the "*legislative and governmental oversight functions*" of the Legislative Council and, for each of the SO52(7) Documents, has considered whether it is in the public interest that the SO52(7) Documents "*should not be made available more widely than to members*".¹ These Submissions should be read together with the Index of Privileged Documents (Personal Information) (**Index**) produced by the DoE in its Return, which identify the documents over which a claim of privilege has been made and the nature of that claim.

The SO52(7) Documents have been produced pursuant to the Resolution and under compulsion of law. In producing the SO52(7) Documents, the DoE does not waive any privilege over that material.

The SO52(7) Documents are detailed in the Index. The DoE understands that the consequence of claiming privilege in relation to the SO52(7) Documents listed in the Index is that, if successful, the SO52(7) Documents will only be available for inspection by Members of the Legislative Council and not disclosed to the public.

However, the DoE understands that this Submission will be published on the NSW Parliamentary website with each of the Indexes accompanying the Return. For this reason, details of the privileged information are referred to at a high level so as not to inadvertently waive privilege. As an overarching principle, the DoE notes that it is difficult to provide detailed public submissions in relation to the sensitive information contained in the SO52(7) Documents, and the reasons why this information should not be disclosed, without disclosing, to some extent, the very information that our assertion of privilege seeks to protect.

Further, the DoE submits that the approach taken to the redaction of sensitive material in the SO52(7) Documents have been applied in accordance with the following:

- *Final Arbiter Report under Standing Order 52 on disputed claim of privilege – Early Childhood Education and Care Sector*, dated 26 March 2025; and
- the agreement reached between the Deputy Premier of NSW, the Hon. Prue Car MP and Ms Boyd MLC, as outlined in the DoE's letter to the Legislative Council dated 2 April 2025 (albeit mistakenly dated 2 April 2024), including the email correspondence dated 27 March 2025 that was attached to the DoE's letter.

1. Summary of privilege claims

- 1.1 The DoE asserts a claim of privilege over the SO52(7) Documents on the basis that they contain personal information, including, for example, the sensitive details of private individuals, such as children or educators.
- 1.2 As stated by Priestley JA in *Egan v Chadwick* (1999),² the Legislative Council is *required* to prohibit the further disclosure of documents which it has compulsorily obtained where disclosure would be "*inimical to the public interest*".³ The DoE notes that, where a claim of privilege is made, Parliament is *duty-bound* to balance the conflicting public interests which may impact the resolution of that question in a form which is broadly equivalent to the "*judicial*" resolution of privilege disputes.⁴
- 1.3 Before addressing the privilege basis, the DoE submits that the sensitive information in the SO52(7) Documents would ordinarily be protected from public disclosure under the common law or pursuant to the *Government Information (Public Access) Act 2009* (NSW) (*GIPA Act*). Whilst the DoE recognises that differing tests apply to certain information being withheld pursuant to the GIPA Act compared to information being withheld on the basis of public interest immunity, both involve weighing the release of information against the public interest in knowing the information. Therefore, the DoE contends that case law related to the GIPA Act can be helpful in determining whether information should be disclosed.

2. Personal information

Documents contain personal information, including the details of private individuals and businesses

- 2.1 Claims for privilege over the personal information contained in a return, where that information is not generally available, are now expressly recognised as an available category of a privilege claim under Standing Order 52(7).
- 2.2 Information of this kind is ordinarily protected pursuant to the GIPA Act or *Privacy and Personal Information Protection Act 1998* (NSW).
- 2.3 The DoE submits that 437 of the Documents contain details of private individuals, such as, for example, children and parents, but are not otherwise subject to a claim of privilege within the meaning of Standing Order 52(7).
- 2.4 The Hon. Mr Keith Mason AO QC has noted that the Legislative Council has undoubted power to employ additional measures to prevent disclosure of confidential information where it is not in the public interest to do so.⁵
- 2.5 Each of the SO52(7) Documents contains information which, if made public, would disclose the personal information of identifiable private individuals.
- 2.6 To the best of the DoE's knowledge, the personal information that has been identified is not publicly available and was communicated in circumstances where there was a genuine expectation that it would not be published.
- 2.7 Examples of this information include (but are not limited to):
- (a) private individuals' names (excluding DoE employees and employees of other Government departments and agencies) and including names of minors;⁶
 - (b) private individuals' home addresses;⁷
 - (c) private individuals' dates of birth;⁸
 - (d) private email addresses;⁹
 - (e) mobile telephone numbers;¹⁰
 - (f) signatures;¹¹ and

- (g) medical information which could allow for the identification of a private individual.¹²
- 2.8 It is uncontroversial that information of this kind is personal and should be kept confidential, and that this type of information has previously been held by Independent Arbiters as a sufficient basis to establish a claim for privilege (or at the very least, further redaction).¹³ Further, the type of information listed in paragraph 2.7(b), (d)-(f) above is specifically listed in SO52(7)(e) as being personal information which should not be made public.
- 2.9 Additionally, the release of signatures reflects the increased risk that such information could be used to facilitate fraudulent conduct if released publicly. In support of that submission, the DoE refers to the Report concerning the *Appointment of Senior Trade and Investment Commissioner* dated 22 July 2022, wherein the Hon. Alan Robertson SC, acting as Independent Arbiter, held that a claim for privilege exists in respect of signatures as publication of them "*could facilitate fraud*" (pp 7-8).¹⁴
- 2.10 Dissemination of this information could harm or endanger the subject individuals (including by resulting in inappropriate contact or interference).
- 3. Further opportunity to make further submissions**
- 3.1 The DoE has attempted to specifically identify each of the documents containing privileged information in the Index. However, it is possible that not all privileged information has been identified.
- 3.2 In the event there is a dispute in relation to a claim for privilege and the matter is referred to an Independent Arbiter pursuant to Standing Order 52(9), the DoE requests the opportunity to provide further detailed submissions to the Independent Arbiter and, if necessary, consider the appropriateness of further redactions over the documents.
