WHEREAS the Parliament of New South Wales now stands prorogued to Tuesday, the twenty-fourth day of February instant: Now I, Sir GERALD STRICKLAND, Count-della Catena, in pursuance of the power and authority in me vested as Governor of the said State, do hereby futher prorogue the said Parliament to Tuesday, the third day of March next: And I do hereby further announce and proclaim that the said Parliament shall assemble for the despatch of business on the aforesaid third day of March next, at twelve o'clock at noon, in the buildings known as the Legislative Council Chambers, situate in Macquarie-street, in the city of Sydney: And the members of the Legislative Council and Legislative Assembly, respectively, are hereby required to give their attendance at the said time and place accordingly.

Given under my hand and seal, at Sydney, this seventeenth day of February, in the year of our Lord one thousand nine hundred and fourteen, and in the fourth year of his Majesty's reign.

PUBLIC STATUTES OF THE SESSION.

TWENTY-THIRD PARLIAMENT—SECOND SESSION.

APPROPRIATION ACT (5 GEO. V, No. 4, 1914)—

An act to appropriate and apply out of the Consolidated Revenue Fund of New South Wales certain sums to make good the supplies granted for the service of the year from the 1st day of July, 1913, to the 30th day of June, 1914, inclusive of both dates; to adjust the vote "Advance to Treasurer," 1912-13, Consolidated Revenue Fund, for supplementary charges during the period from the 1st day of July, 1912, to the 30th day of June, 1913, inclusive of both dates; to cover payments "Unauthorised in Suspense," Consolidated Revenue Fund, for urgent claims on account of services of the year 1912-13; to provide for public works and other services out of the Public Works Fund; and to provide for services out of the Closer Settlement Fund; and for purposes connected with and incidental to the above objects. [Initiated in the Assembly by Mr. Cann, 4 April, 1914. Assented to, 15 April, 1914.]

CLOSER SETTLEMENT (AMENDMENT) ACT, 1914 (5 GEO. V, No. 7, 1914)—

An act to authorise the purchase by the Minister of certain lands for settlement purchase; to make further provision for the disposal of land and improvements within settlement purchase areas; to confer and impose certain rights and liabilities on minors; to reduce the capital value of certain settlement purchases; to provide for the payment of interest on postponed instalments; to fix a date for the payment of instalments on settlement purchases; to enable the Minister to grant extension of time to pay instalments in certain cases; to amend the Closer Settlement Acts, the Closer Settlement Promotion Act, 1910, and other acts; and for purposes consequent thereon or incidental thereto. [Initiated in the Assembly by Mr. Trefle, 30 March, 1914. Assented to, 16 April, 1914.]

CROWN LANDS AND IRRIGATION (AMENDMENT) ACT, 1914 (5 GEO. V, No. 10, 1914)—

An act to amend the Crown Lands Consolidation Act, 1913, the Irrigation Act, 1912, and the Water Act, 1912, in certain respects; and for purposes consequent thereon and incidental thereto. [Initiated in the Assembly by Mr. Trefle, 11 March, 1914. Assented to, 16 April, 1914.]

DACEYVILLE EXTENSION ACT (5 GEO. V, No. 13, 1914)—

An act to sanction laying out an area of land and erecting thereon certain dwelling-houses, under the provisions of the Housing Act, 1912; and for purposes consequent thereon or incidental thereto. [Initiated in the Assembly by Mr. Cann, 18 March, 1914. Assented to, 16 April, 1914.]

INCOME-TAX (AMENDMENT) ACT (5 GEO. V, No. 8, 1914)—

An act to amend the Income-tax Act, 1911, and the Income-tax (Amendment) Act, 1912; and for other purposes. [Initiated in the Assembly by Mr. Cann, 2 April, 1914. Assented to, 16 April, 1914.]

INCOME-TAX MANAGEMENT (AMENDMENT) ACT, 1914 (5 GEO. V, No. 9, 1914)—

An act to amend the Income-tax (Management) Act, 1912, and in particular to amend the definition of income so as to include certain gains and profits; to give a retrospective operation to certain of the amendments so made; and for purposes consequent thereon or incidental thereto. [Initiated in the Assembly by Mr. Cann, 6 April, 1914. Assented to, 16 April, 1914.]

LOAN ACT (5 GEO. V, No. 5, 1914)—

An act to authorise the raising of a Loan for Public Works and Services, and for other purposes. [Initiated in the Assembly by Mr. Cann, 7 April, 1914. Assented to, 15 April, 1914.]

PARLIAMENTARY COMMITTEES ELECTION ENABLING ACT (5 GEO. V, No. 1, 1914)—

An act to enable certain elections to be held and certain things to be done during the second session of the present Parliament; to amend the Public Works Act, 1912, and certain other acts; and for other purposes. [Initiated in the Council by the Hon. F. Flowers, 11 March, 1914. Assented to, 25 March, 1914.]

SAVINGS BANKS AMALGAMATION ACT (5 GEO. V, No. 6, 1914)—

An act to dissolve the Savings Bank of New South Wales and to vest the property, rights, and liabilities of the said bank in the Government Savings Bank; to repeal the Savings Bank of New South Wales Act, 1902, and the Savings Bank of New South Wales (Amendment) Act, 1902; to amend the Government Savings Bank Act, 1906, and the Government Savings Bank Amendment Act, 1913, and certain other acts; and for purposes consequent thereon or incidental thereto. [Initiated in the Assembly by Mr. Cann, 25 March, 1914. Assented to, 16 April, 1914.]

STAMP DUTIES (AMENDMENT) ACT (5 GEO. V, No. 3, 1914)—

An act to impose certain stamp, probate, and other duties; to amend the Stamp Duties Act, 1898, the Stamp Duties Amendment Act, 1900, the Companies (Death Duties) Act, 1901, the Stamp Duties (Amendment) Act, 1904, and the Stamp Duties (Deductions) Act, 1904; to repeal the Probate Duties (Amendment) Act, 1899; and for purposes consequent thereon or incidental thereto. [Initiated in the Assembly by Mr. Cann, 31 March, 1914. Assented to, 14 April, 1914.]

STATE DEBT AND SINKING FUND (AMENDMENT) ACT (5 GEO. V, No. 11, 1914)—

An act to amend the State Debt and Sinking Fund Act, 1904. [Initiated in the Assembly by Mr. Cann, 25 March, 1914. Assented to 16 April, 1914.]

SUPPLY ACT (5 GEO. V, No. 2, 1914)—

An act to apply certain sums out of the Consolidated Revenue Fund towards the services of the year 1913-1914, and out of the Public Works Funds, and out of the General Loan Account for services to be hereafter provided for by loan. [Initiated in the Assembly by Mr. Cann, 30 March, 1914. Assented to 31 March, 1914.]

SYDNEY HARBOUR TRUST (WHARFAGE AND HARBOUR RATES) ACT (5 GEO. V, No. 12, 1914)—

An act to provide for fixing and collecting inward and outward wharfage rates and inward and outward harbour rates in the port of Sydney; to amend the Sydney Harbour Trust Act, 1900, the Sydney Harbour Rates Act, 1904, and the Sydney Harbour Trust and Navigation Amendment Act, 1908; and for other purposes. [Initiated in the Assembly by Mr. Hoyle, 7 April, 1914. Assented to 16, April, 1914.]

Adjournment: A member could not by innuendo convey the impression that another member had been guilty of want of decorum, by using language which he would not specify; members must not be spoken of as "traitors," 673.

Chairman of Committees: A motion for the appointment of the Chairman of Committees in the name of a private member was not technically Government business, but was more important than Government business, seeing that the appointment of Chairman of Committees and Deputy-Speaker was essential to the carrying out of Government business, and therefore the motion was in order, notwithstanding the sessional order that no business other than Government business should be taken, 219.

Closer Settlement (Amendment) Bill: The bill was out of order, because clause 20 dealing with the reduction of the capital value of settlement purchases on the Boree Creek Estate was beyond the order of leave, 299.

Closer Settlement (Amendment) Bill (No. 2): It would not be justifiable to rule the bill out of order on the highly technical point, that it would have the effect of amending the Common Law Procedure Act, and the Judgment Creditors Remedies Act. The title clearly showed that it was intended to conserve the existing law. The general policy of the bill was to prevent fraud, and the act providing for writs of *feri facias* was not amended, except in the sense that it might be modified or suspended in the interests of the country itself, 818; it was not competent for a member to discuss the basic principles and policy of closer settlement, but the discussion must be confined to the essential principles in the bill, 822.

ASSEMBLY (continued):

Deputy-Leader of the Opposition: A question of an ironical character was practically offensive to the Speaker, 97, 214; the Speaker was the custodian of the privileges and good order of the House, and he was the only individual concerned as to any notification by the leaders of parties in the House. Mr. Speaker resented the interference by a member in a matter which should be one of information for himself; when a question had been raised and ruled out of order, it was irregular to repeat the question, 214; the fact that disorderly language had been used in the past could not be used as a subterfuge for applying disorderly expressions in the present; a suggestion that the Speaker had, in endeavouring to earn the plaudits of the press, dealt unfairly with a member, was highly disorderly, 287.

Election Petitions: A petition, which as the result of an unintentional lapse, contained a wrong form of address to his Excellency the Governor, should not be ruled out of order, as the effect would be to prevent investigation of claims by the Elections and Qualifications Committee, which was a semi-judicial tribunal, 407; the Elections and Qualifications Committee could not sit during recess, and in a case where the committee could not conclude their inquiry into a petition, it was competent for them to recommend that the matter be referred to the committee to be appointed in the following session, 1163.

Income-tax (Further Amendment) Bill: The only way a taxation bill could be considered was upon a resolution of Committee of Ways and Means, and this resolution could not appear on the business-paper until it had been moved in the ordinary way, 525; a resolution of Ways and Means was the basis for a taxation measure solely, and the invariable practice had been to bring down a measure founded on resolution of Ways and Means, providing for the imposition of taxation entirely apart from the machinery bill, which was introduced in Committee of the Whole. No precedent could be found where in Committee of Ways and Means a resolution purely for imposing taxation had been passed, and the bill when presented had provided for the amendment of other acts which could not be regarded as *ejusdem generis*. The bill was out of order because it contained what must be regarded as extraneous matter, in the shape of provisions for the amendment of the Public Service Act and the Arrest on Mesne Process Act, 660.

The bill was out of order inasmuch as it contained provisions for the amendment of two acts which were not mentioned in the title, and would have the effect of circumscribing the rights of citizens under those acts, 815.

Stamp Duties (Amendment) Bill (No. 2): Where a bill based on a resolution of Committee of Ways and Means or Committee of the Whole had been withdrawn and it was proposed to bring in another bill of a similar nature, the usage was to read again the resolution and order another bill to be brought in. Standing order 332 applied only to the original introduction of a bill based on a resolution of Ways and Means, 694.
