  - a. On 29 April 2024, Unions NSW and SafeWork NSW held their annual
     International Day of Mourning service at Reflection Park in Darling Harbour,
  - b. The International Day of Mourning is observed worldwide in April each year as a day for families, friends, unions, and government to come together to remember those whose lives have been lost tragically at work or because of their work,
  - c. Members of families who have lost loved ones were very well represented at the memorial and spoke of their loss and the need for action to prevent similar tragedies occurring again,
  - d. Accordingly, the International Day of Mourning is also a time of reflection for industry and government to consider how we can do better to create safer workplaces,
  - e. Any death in the workplace is a death too many, and the NSW Government is committed to bettering work health and safety in New South Wales,

- f. Marking the International Day of Mourning, the Minister for Work Health and Safety and the Minister for Industrial Relations, the Hon. Sophie Cotsis MP, reaffirmed the NSW Government's commitment to introducing Industrial Manslaughter laws to Parliament this year. Mr PRESIDENT:

I give notice that on the next sitting day I will move:

- (1) That this House notes that:
  - (a) The most recent DCJ Caseworker Dashboard for the Illawarra Shoalhaven and Southern NSW shows vacancies for October 2023 to December 2023 is 7 per cent;
  - (b) The number of children in the Illawarra Shoalhaven and Southern NSW reported at risk of significant harm being seen is 23 per cent for October 2023 to December 2023;
- (2) That this House further notes that:
  - (a) On 1 May 2024, the Public Service Association arranged a protest on behalf of child protection workers from Wollongong Community Services Centres to protest high caseworker vacancies in child protection services in NSW;

Mr PRESIDENT:

  - (a) The most recent DCJ Caseworker Dashboard for the Central Coast and Hunter shows the number of children reported at risk of significant harm being seen is 17 per cent for October 2023 to December 2023;
  - (b) On 18 April 2024, the Public Service Association arranged a protest on behalf of child protection workers from Edgeworth Community Services Centre to protest its closure, caseworker vacancies, underfunding and mismanagement of child protection services in NSW;
  - (c) In an interview with ABC Newcastle on 18 April 2024, PSA Assistant General Secretary Troy Wright described the closure as a "furphy" and due to "cost cutting" which will have a "significant impost on families" and a "significant impost on our workers";
  - (d) The move to close Edgeworth CSC will create significant travel and contact obstacles for both residents and caseworkers, ultimately impeding the effectiveness of their work.

#### Mr PRESIDENT:

  - (a) The After Hours Response Team (AHRT) is a team at the Helpline that provides casework for urgent ROSH referrals that require DCJ's intervention, and urgent requests for assistance;
  - (b) On 18 March 2024, the AHRT called a snap two-hour stop-work in response to chronic overwork, staff suspensions and unreasonable workplace directives;
  - (c) On 24 April 2024, the AHRT called a snap 24-hour strike in response to chronic overwork, alleged systemic bullying and ongoing mismanagement;
  - (d) According to the Public Service Association, the strikes follow two senior managers being stood down from the AHRT and a series of unilateral changes to operational arrangements leading to chaotic and unsafe situations;
  - (e) The changes have led to staff working in excess of 18 hours at a time to keep the hotline open, resulting in the response time blowing out from under 30 minutes to hours.
