# **Terms of Reference**

- 1. That the Budget Estimates and related papers for the financial year 2004-2005 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees for inquiry and report.
- 2. That the committees consider the Budget Estimates in accordance with the allocation of portfolios to the committees.
- 3. For the purposes of this inquiry any member of the House may attend a meeting of a committee in relation to the Budget Estimates and question witnesses, participate in the deliberations of the committee at such meeting and make a dissenting statement relating to the Budget Estimates, but may not vote or be counted for the purpose of any quorum.
- 4. The committees must hear evidence on the Budget Estimates in public.
- 5. Not more than 2 committees are to hear evidence on the Budget Estimates simultaneously.
- 6. When a committee hears evidence on the Budget Estimates, the Chair is to call on items of expenditure in the order decided on and declare the proposed expenditure open for examination.
- 7. The committees may ask for explanations from Ministers in the House, or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure.
- 8. The report of a committee on the Budget Estimates may propose the further consideration of any items.
- 9. That a daily Hansard record of the hearings of a committee on the Budget Estimates be published as soon as practicable after each day's proceedings.
- 10. That the Leader of the Government is to provide to each Committee, by 6 July 2004, a schedule outlining the attendance of relevant ministers to appear before each committee, for the committee's consideration.
- 11. The committees may hold supplementary hearings as required.
- 12. The committees present a final report to the House by the last sitting day of the second sitting week in 2005—put and passed.

# Chapter 1 Introduction

## Examination of budget estimates

- **1.1** General Purpose Standing Committee No 3 examined the Budget Estimates and related documents for its portfolios at a series of public hearings held on the following dates:
  - 13 September 2004 Police
  - 14 September 2004 Justice
  - 15 September 2004 Fair Trading
  - 16 September 2004 Juvenile Justice, Western Sydney
  - 17 September 2004 Attorney General
- 1.2 This report outlines the administrative details of the budget estimates hearing process and a brief summary of some of the key issues raised. # Chapter 2 Public hearings – by portfolio

The key topics discussed at the hearing are provided below. For further details on these, and other matters, see the Hansard record of the hearing, available on the Committee's web page accessible via the Parliament's website at www.parliament.nsw.gov.au/budgetestimates.

### **Police**

- 2.1 On 13 September 2004 the Committee conducted a public hearing into the portfolio of Police. Amongst the issues discussed, recent ministerial directives were of particular focus. Other key issues discussed included:
  - reduction in administrative expenditure following the mini-budget
  - financial decision making process
  - allocation of budget within Police
  - firearms registry turnaround times and fees
  - inspections and audit of firearms safe storage
  - DNA testing backlog
  - Fringe Benefit Tax compliance in relation to gifts
  - Expenditure Review Committee
  - staffing at Goulburn Police College
  - security industry reform

## **Justice**

- 2.2 On 14 September 2004 the Committee conducted a public hearing into the portfolio of Justice. Key issues discussed included:
  - whether certain prisons would remain open
  - rate of female employees leaving the prison workforce
  - recidivism rates
  - post-prison transition to the community
  - mobile phones in prisons
  - compensation payments to inmates
  - replacement of boiler at Long Bay Prison commercial laundry
  - relocation of 100 staff positions to Goulburn
  - preventing contraband entering prisons

• Compulsory Drug Treatment Prison.

## Fair Trading

- 2.3 On 15 September 2004 the Committee conducted a public hearing into the portfolio of Fair Trading. Key issues discussed during the public hearing centred on investigations and penalties relating to the *Property, Stock and Business Agents Act.* Other issues discussed included:
  - savings in operating expenses
  - e-commerce education and protection for consumers
  - consumer protection against defective goods ('lemon laws')
  - tenant databases and blacklists
  - the use of forged qualifications in obtaining building and trades licences
  - relocation of Safety and Standards Branch
  - interest on rental bonds held by the Department
  - youth debt.

## Juvenile Justice and Western Sydney

2.4 On 16 September 2004 the Committee conducted public hearings into the portfolios of Juvenile Justice and Western Sydney.

### Juvenile Justice

- 2.5 Amongst the issues discussed, the administration and management of Kariong Juvenile Justice Centre were of particular focus. Other key issues discussed included:
  - riot at Acmena Juvenile Justice Centre
  - design faults at Kariong Juvenile Justice Centre
  - classification of detainees
  - major works at Cobham and Reiby Juvenile Justice Centres
  - Indigenous juvenile offenders
  - search powers at Juvenile Justice Centres
  - drug detection in Juvenile Justice Centres
  - drug use by detainees
  - transfer of detainees to adult prison system.

## Western Sydney

2.6 Amongst the issues discussed, the Orange Grove Factory outlet was the main focus.

## **Attorney General**

- 2.7 On 17 September 2004 the Committee conducted a public hearing into the portfolio of Attorney General. Amongst the issues discussed, the pilot domestic violence court was of particular focus. Other key issues discussed included:
  - expenditure on legal advice for ministers and the government
  - frequency of reporting of criminal court statistics
  - budget and staffing of the Office of the Director of Public Prosecutions
  - reviews of legal fees and court costs
  - courts security
  - court backlog maintenance program and capital works.
