Chapter 1 Introduction

Referral of the 2010-2011 Budget Estimates

- 1.1 On 24 November 2009, the Legislative Council resolved that 'the Budget Estimates and related papers for the financial year 2010-2011 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees for inquiry and report'.¹
- 1.2 The resolution (hereafter referred to as the Budget Estimates Resolution) requires each committee to examine the Budget Estimates for the relevant portfolios and report to the House by the last sitting day of the first sitting week in March 2011.

Chapter 2 Issues raised during hearings

This chapter provides a brief summary by portfolio of the key issues raised during the hearings.

Tourism, Hunter, Science and Medical Research and Women

- 2.1 A hearing to examine the portfolios of Tourism, Hunter, Science and Medical Research and Women was held on Monday 13 September 2010.
- 2.2 The following issues were raised in relation to Tourism:
 - The activities and meetings of the Major Events Committee
 - The role of Tourism NSW in promoting the Vivid Festival
 - The outcome of the Deloitte review of the Regional Tourism Partnership Program
 - The work of the Passenger Cruise Terminal Committee and the future locations of passenger cruise terminals in Sydney
 - Tourism campaigns to promote Sydney overseas, including partnerships with airlines and the three-year partnership with the Queensland Government to promote international visitors to both NSW and Queensland
 - Efforts to promote regional tourism in NSW
 - Efforts to promote nature tourism and greater tourist numbers in national parks.
- 2.3 The following issues were raised in relation to Hunter:
 - Public consultation on the scoping study into light rail in Newcastle
 - City renewal in Newcastle, including public transport policy
 - Progress on the Honeysuckle redevelopment project
 - Management of the Newcastle Sports and Entertainment Precinct in Broadmeadow, including investment in Energy Australia Stadium
 - Coastal management in and around Newcastle and in particular implementation of the Merewether Beach Reserves Plan of Management
 - Development in the Upper Hunter
 - The Hunter water strategy and the Tillegra Dam proposal.
- 2.4 The following issues were raised in relation to Science and Medical Research:
 - Government investment in the Health and Medical Research portfolio, including the appropriations in the budget papers and comparisons with investment by other States
 - Funding for health and medical research under the State Government's Science Leveraging Fund and the Federal Government's Centres of Excellence program
 - The role and work of the Chief Scientist and the Innovation Council

- Initiatives offered by the NSW Government to encourage young people to take up careers in science
- The operation of the NSW Life Science Research Awards, a program to encourage leading scientists worldwide to relocate to Sydney to undertake research.
- 2.5 The following issues were raised in relation to Women:
 - Funding for the Office of Women in the 2010-2011 Budget compared to the 2009-2010 Budget
 - The location of the Office of Women within the Department of Premier and Cabinet
 - Domestic violence statistics and sentencing of offenders by the courts
 - Implementation of the NSW Domestic and Family Violence Action Plan, including support for women and children escaping domestic violence and the implementation of a domestic violence website
 - Implementation of the Staying Home Leaving Violence strategy, designed to remove violent partners from the home
 - Initiatives to promote pay equity including encouraging the representation of women in non-traditional roles
 - Promoting women into leadership positions in the NSW public sector
 - Combating sexual harassment and bullying in the workplace, both in the public and private sectors.

Ports and Waterways and Illawarra
