Terms of reference

- 1. That the Budget Estimates and related papers for the financial year 2006-2007 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees for inquiry and report.
- 2. That the committees consider the Budget Estimates in accordance with the allocation of portfolios to the committees.
- 3. For the purposes of this inquiry any member of the House may attend a meeting of a committee in relation to the Budget Estimates and question witnesses, participate in the deliberations of the committee at such meeting and make a dissenting statement relating to the Budget Estimates, but may not vote or be counted for the purpose of any quorum.
- 4. The committees must hear evidence on the Budget Estimates in public.
- 5. Not more than three committees are to hear evidence on the Budget Estimates simultaneously.
- 6. When a committee hears evidence on the Budget Estimates, the Chair is to call on items of expenditure in the order decided on and declare the proposed expenditure open for examination.
- 7. The committees may ask for explanations from Ministers in the House, or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure.
- 8. The report of a committee on the Budget Estimates may propose the further consideration of any items.
- 9. That a daily Hansard record of the hearings of a committee on the Budget Estimates be published as soon as practicable after each day's proceedings.

Chapter 1 Introduction

Referral of the 2006-2007 Budget Estimates

- **1.1** On Thursday 8 June 2006, the Legislative Council resolved 'that the Budget Estimates and related papers for the financial year 2006-2007 presenting the amounts to be appropriated from the Consolidated Fund be referred to the GPSCs for inquiry and report'.¹
- **1.2** Each committee was to examine the Budget Estimates for the relevant portfolios and report to the House by the last sitting day of November 2006.²

Hearings

- **1.3** The Committee held nine public hearings as follows:
 - Monday 28 August Justice, Juvenile Justice
 - Friday 1 September Police
 - Friday 1 September Gaming and Racing, Central Coast
 - Friday 8 September Lands, Emergency Services, Rural Affairs
 - Friday 8 September Attorney General
 - Thursday 21 September Justice, Juvenile Justice
 - Friday 29 September Gaming and Racing
 - Monday 16 October Police
 - Friday 17 November Justice, Juvenile Justice.
- **1.4** A brief summary of the key issues raised during the hearings is contained in Chapter 2.

Chapter 2 Issues raised during hearings

This Chapter provides a brief summary by portfolio of the key issues raised during the hearings.

Justice, Juvenile Justice

- 2.1 A hearing examining the portfolios of Justice and Juvenile Justice was held on Monday 28 August 2006. The following issues were raised:
 - arrangements for and outcomes of youth justice conferencing
 - investigation of recent emails containing pornographic material circulated within the Department of Juvenile Justice
 - incidence of mental health issues, intellectual disability and drug and alcohol problems among clients of the juvenile justice system and action taken to support such clients
 - rates of self harm among detainees and a specific incident of self-harm
 - strategies to address the over-representation of Aboriginal young people in the juvenile justice system
 - incidence of and provisions for young people detained in adult correctional facilities.
 - changes to the visitor system at the Emu Plans correctional facility and other facilities
 - action taken by the Government in respect of quelling riots, the Violent Offender Treatment Program, and accommodating persons convicted of terrorist offences
 - action taken in response to staff alleged to have passed on emails containing pornographic material
 - inmates who have undertaken gender reassignment surgery
 - use of consultants by the Department of Corrective Services
 - detention of people who have committed serious crimes as a result of mental illness.

Supplementary hearings

- **2.2** A supplementary hearing examining the portfolios of Justice and Juvenile Justice was held on Thursday 21 September 2006. The following issues were raised:
 - investigation into inappropriate emails sent by Department of Juvenile Justice employees
 - number of detention centres and departmental offices with pay TV, as well as policy for the provision of pay TV and detainee rewards such as the use of game consoles
 - lockdowns in detention centres and other correctional centres, including incidence, duration, and circumstances in which lockdowns may be implemented

- mental health issues among detainees
- riot at Acmena detention centre, including cost of damage, cost of insurance policies, MOU regarding future assistance by Corrective Services officers, and procedures for activating the use of riot equipment
- smuggling of drugs into detention centres and use of sniffer dogs to detect drugs
- number of departmental staff leaving in the last year on health grounds
- Commissioner Woodham's employment contract and leave taken
- incidence of assaults on prisoners by other prisoners
- visiting arrangements at correctional centres and instances of visitors being banned
- interstate transfer of prisoners
- instances of unauthorised contact between male and female inmates in various correctional centres
- case of Maddison Hall and treatment whilst in prison.
- **2.3** A second supplementary hearing examining the portfolios of Justice and Juvenile Justice was held on Friday 17 November 2006. The following issues were raised:
 - matters relating to sick leave taken by Commissioner Woodham, including the policy regarding sick leave and medical checks for staff, and the conditions of Commissioner Woodham's contract
 - industrial action taken at Long Bay Correctional Centre
 - selection process for filling certain senior positions at the Department of Corrective Services
 - matters relating to visiting arrangements for correctional centres, including for women with children at Emu Plains, and the introduction of booked visits
 - improvements to the management of correctional centres, including new facilities and services for inmates with a mental illness, and improvements to the education system
 - national awards to the Department of Corrective Services
 - investigations into inappropriate emails sent by Department of Juvenile Justice employees
 - matters arising from the Justice Health survey report of young people in custody
 - new arrangements for transporting detainees to Parramatta Children's Court
 - arrangements for detainees to access mental health services
 - matters relating to education programs for detainees, including availability in school holidays, access to TAFE courses and links to apprenticeships
 - improvements to the management of juvenile justice centres, including therapeutic and developmental programs at Juniperina, improved measures to detect contraband, and new developments in staff training for Departmental employees.

Police

- **2.4** A hearing examining the portfolio of Police was held on Friday 1 September 2006. The following issues were raised:
 - operation of the NSW Crime Commission
 - total number of police officers, taking into account both recruitment and retirement of officers
 - cuts to support staff in local area commands and other parts of NSW Police
 - action in respect of organised criminal activity in South West Sydney
 - sales of cocaine associated with Operation Mocha
 - trial of Taser stun guns
 - reported increases in police time spent on paperwork
 - measures to protect children and reduce sex crimes
 - claims by police officers for medical retirement and retirement associated with being hurt on duty
 - actions to improve public order, including the deployment of the Public Order and Riot Squad.

Supplementary hearing

- **2.5** A supplementary hearing examining the portfolio of Police was held on Monday 16 October 2006. The following issues were raised:
 - alleged problems with Ford XR8 highway patrol vehicles, such as vehicles stalling during highway pursuits
 - various issues relating to the current intake of students at the Goulburn Police Academy, including the process for determining the graduation date, the attrition rate, Christmas holiday leave, measures to improve professional standards, action taken against students who are guilty of misconduct, and the policy for recording instances of misconduct on students' records
 - police response to violent outbursts at an under-18s dance party at the University of New South Wales, including the use of capsicum spray
 - planning for the future of the police workforce
 - the NSW Ombudsman's review of drug detection dog operations
 - proposed introduction of random drug testing for drivers
 - process for allocating additional police officers to stations
 - management of surplus police property
 - waiting times for the finalisation of Hurt On Duty claims.

Gaming and Racing, Central Coast

- **2.6** A hearing examining the portfolios of Gaming and Racing, and Central Coast, was held on Friday 1 September 2006. The following issues were raised:
 - operation of the bar at the NSW Police College, Goulburn without a licence.
 - changes to gaming taxation rates including the impact on employment
 - 'one casino' policy in NSW
 - proposed legislation to abolish the Liquor Administration Board
 - lessor lessee disputes over gaming machine entitlements and the impact of transfers of entitlements on country hotels
 - Central Coast water supply including a proposed desalination plant, water conservation initiatives and the transfer of water from the Hunter Valley to the Central Coast
 - route of Energy Australia high voltage power lines through the Erina-Wamberal area
 - train travel times to and from the Central Coast
 - impact on the racing industry from restricting internet access to the TAB and the introduction of BetFair
 - status of Central Coast road projects
 - impact of rising fuel prices on the Central Coast.

Supplementary hearing

- **2.7** A supplementary hearing examining the portfolio of Gaming and Racing was held on Friday 29 September 2006. The following issues were raised:
 - number of gaming machines in NSW and the government tax revenue taken from gaming machines in recent years
 - publication of data on gaming machine revenue and the availability of unpublished data for research purposes
 - Government assistance to problem gamblers and their families
 - funding arrangements with problem gambling service providers under the Casino Community Benefit Fund
 - impact of BetFair on the racing industry and bookmakers and the scope for legislative intervention
 - employment of Mr Griggs on secondment from the Premier's Department as Director, Communications and Strategic Support Division within the former Department of Gaming and Racing
 - one-way and two-way protocols for managing gaming machines in NSW
 - possibility of increasing prize money for country racing to assist the racing industry

- closure of the Cessnock Greyhound Club
- sale of toy poker machines to children in NSW.

Lands, Emergency Services, Rural Affairs

- **2.8** A hearing examining the portfolios of Lands, Emergency Services and Rural Affairs was held on Friday 8 September 2006. The following issues were raised:
 - conversion of enclosed roads and perpetual leases to freehold
 - covenants to protect the conservation of Crown leases following conversion to freehold
 - land rates on properties only accessible by water
 - Government action to encourage economic development on Crown lands
 - staffing of the Soil Conservation Service within the Department of Lands
 - fundraising strategies of the Rural Fire Service Association
 - operating costs of NSW Rural Fire Service aircraft
 - action to pursue the introduction of reduced fire-risk cigarettes
 - measures to ensure fire fighter safety when using bush trails
 - allegations of a cover-up in respect of the racecourse fire near Cessnock in 2002.

Attorney General

- **2.9** A hearing examining the portfolio of Attorney General was held on Friday 8 September 2006. The following issues were raised:
 - appeals process and educating magistrates with a high level of successful appeals against their decisions
 - use of terrorist legislation and special powers
 - case of Roseanne Catt and compensation for unlawful imprisonment
 - innovative pilot programs developed by the Department to address problems of reoffending within small communities
 - performance of courts including issues of timeliness, cost effectiveness and efficiency
 - rationalisation of children's courts including new centralised facility at Parramatta
 - Goodsell Building and advice to staff of presence of asbestos or otherwise
 - Courtlink project including cost, changes to the new contract and features of the new system
 - retention of biological samples and moratorium on the destruction of crime scene material

- review of the Mental Health Tribunal, including terms of reference and public submissions process
- review of privacy laws by the Law Reform Commission and the Privacy Commissioner
- upgrade of court security to improve safety including scanning equipment, monitoring devices and increased numbers of security officers
- reforms to sexual assault laws, including prohibiting self-represented accused from interrogating victims.
