Referral of the 2009-2010 Budget Estimates

- 1.1 On 27 November 2008, the Legislative Council resolved 'that the Budget Estimates and related papers for the financial year 2009-2010 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees for inquiry and report¹'.
- 1.2 The resolution (referred to as the Budget Estimates Resolution) required each committee to examine the Budget Estimates for the relevant portfolios and report to the House by the last sitting day of the first sitting week in March 2010².

Hearings

- 1.3 The Committee held seven public hearings as follows:
 - Monday 14 September 2009 Roads
 - Monday 14 September 2009 Ports and Waterways
 - Monday 14 September 2009 Finance, Infrastructure, Regulatory Reform

 - Tuesday 15 September 2009 Arts.

Chapter 2 Issues raised during hearings

This chapter provides a brief summary by portfolio of the key issues raised during the hearings.

Roads

- 2.1 A hearing to examine the portfolio of Roads was held on Monday 14 September 2009. The following issues were raised:
 - Proposed redevelopment of the Iron Cove bridge
 - Level of consultation over the introduction of regulations for modifications that affect the height of vehicles
 - Child restraints in buses
 - Measures to improve the air quality in the M5 East tunnel
 - Extension of the Hunter F3 expressway
 - Roads and Traffic Authority (RTA) responses to Freedom of Information requests
 - Gerringong to Bomaderry Princes Highway proposed upgrade
 - Process regarding invitations to tender for maintenance and infrastructure projects
 - Current levels of truck overloading in NSW and RTA actions to reduce frequency of overloading.
- A supplementary hearing to examine the portfolio of Roads was held on Tuesday 17 November 2009. The following issues were raised:
 - NSW road toll for four-wheeled and two-wheeled vehicles
 - RTA Construction program and Federal Black Spot projects
 - Provision of bicycle ways and cyclist safety on roads
 - Provision of noise barriers on roads such as the M5
 - Breakdown lane policy on main expressways
 - Auditor General's report on truck safety and the use of B-doubles

Ports and Waterways

Finance, Infrastructure, Regulatory Reform

 - Motor Accidents Authority and the Lifetime Care and Support Authority, including the operation of the Authorities and initiatives to improve services.
