## **Primary Industries, Small Business**

A hearing examining the portfolios of Primary Industries and Small Business was held on Monday 24 October 2011. The following issues were raised:

#### Primary Industries:

- Redundancies in the Department of Primary Industries
- Forests NSW plantation levels
- Murray Darling Basin Strategy
- Strategic regional land use planning
- Game Council of NSW
- Bio-security measures to protect animal and plant industries
- Water policies for regional and rural NSW
- Opportunities for recreational fishers in NSW.

#### Small Business:

- Establishment of the office of the Small Business Commissioner
- Reduction in regulations for small businesses
- Measures to boost small business confidence
- Incorporation of the Retail Tenancies Unit into the office of the Small Business Commissioner.

## Environment, Heritage

## Local Government, the North Coast
