Chapter 1 Introduction

Referral of the 2008-2009 Budget Estimates

- 1.1 On 5 December 2007, the Legislative Council resolved 'that the Budget Estimates and related papers for the financial year 2008-2009 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees for inquiry and report.'
- 1.2 The resolution (referred to as the Budget Estimates Resolution) required each committee to examine the Budget Estimates for the relevant portfolios and report to the House by the first sitting day in March 2009.²
- 1.3 On 26 November 2008, the House extended the reporting date to Thursday 5 March 2009.³
