Terms of Reference¹

1. That the Budget Estimates and related documents presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees for inquiry and report.
2. That the Committees consider the Budget Estimates in accordance with the allocation of portfolios to the Committees.
3. For the purposes of this inquiry any Member of the House may attend a meeting of a Committee in relation to the Budget Estimates and question witnesses, participate in the deliberations of the Committee at such meeting and make a dissenting statement relating to the Budget Estimates, but may not vote or be counted for the purpose of any quorum.
4. The Committees must hear evidence on the Budget Estimates in public.
5. Not more than 3 Committees are to hear evidence on the Budget Estimates simultaneously.
6. When a Committee hears evidence on the Budget Estimates, the Chair is to call on items of expenditure in the order decided on and declare the proposed expenditure open for examination.
7. The Committees may ask for explanations from Ministers in the House, or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure.
8. The report of a Committee on the Budget Estimates may propose the further consideration of any items.
9. A daily Hansard record of the hearings of a Committee on the Budget Estimates is to be published as soon as practicable after each day's proceedings.
10. The Committees have leave to sit during the sittings or any adjournment of the House.
11. After a Committee has considered proposed expenditure referred to it by the House and agreed to its report to the House, the Committee must fix:
 - (a) a day for the submission to the Committee of any written answers or additional information relating to the proposed expenditure, and
 - (b) a day for the commencement of supplementary meetings of the Committee to consider matters relating to the proposed expenditure, which day must be not less than 10 days after the day fixed under subparagraph (a).

12. (1) A Member may lodge with a Committee, not less than 3 working days before the day fixed under subparagraph (11) (b), notice of matters relating to the written answers or additional information, or otherwise relating to the proposed expenditure referred to the committee, which the Member wishes to raise at the supplementary meetings of the Committee.
- (2) Any notice lodged with a Committee must be forwarded by the Committee to the Minister in the House responsible for the matters to which the notice relates.
13. A Committee may determine at any time the number and duration of any supplementary meetings.
14. At a supplementary meeting, questions may be put to Ministers or officers of departments, statutory bodies or corporations, relating to matters of which notice has been given, and the proceedings of the Committee must be confined to those matters.
15. A Committee may report to the House any recommendation for further action by the House arising from the Committee's supplementary meetings.
16. Written questions relating to the Budget Estimates may be supplied to the Clerk of the Committee, who must distribute them to the relevant Minister and to Members of the Committee. Answers must be supplied to, and circulated by, the Clerk.
17. The Committees must:
 - (a) present a first report to the House before the House adjourns for the winter recess, and
 - (b) present a final report to the House by the first sitting day in August 2000.

Introduction

Establishment of the General Purpose Standing Committees

The five General Purpose Standing Committees were first constituted by resolution of the Legislative Council on 7 May 1997, during the 51st Parliament.² On 13 May 1999, shortly after the commencement of the 52nd Parliament, the five committees were reconstituted.³

The General Purpose Standing Committees may inquire and report on:

- (a) any matters referred to them by the House;
- (b) the expenditure, performance or effectiveness of any department of government, statutory body or corporation;
- (c) any matter in any annual report of a department of government, statutory body or corporation.⁴

Powers of the General Purpose Standing Committees

The General Purpose Standing Committees have power:

- (a) to send for and examine persons, papers, records and things;
- (b) to adjourn from place to place;
- (c) to make visits of inspection within the State;
- (d) to request the attendance of and examine Members of the House;
- (e) to publish, before presentation to the House, submissions received and evidence taken in public; and
- (f) to report from time to time their proceedings, evidence taken in public and recommendations.⁵

Referral of the 2000-2001 Budget Estimates

On 23 May 2000, the Legislative Council resolved that the Budget Estimates and related documents presenting the amounts to be appropriated from the Consolidated Funds be referred to the General Purpose Standing Committees for inquiry and report.⁶ Each Committee is to examine the Budget Estimates for their relevant portfolios and present a first report to the House before the House adjourns for the winter recess, and present a final report to the House by the first sitting day in August 2000.⁷

Under the resolution there is no requirement for the Committees' consideration of the Budget Estimates to be completed prior to the passage of the 2000-2001 Appropriation Bills. Separation of consideration of the Budget Estimates from the passage of the Appropriation Bills provides greater flexibility for the Committees to scrutinise government expenditure. Under section 5A of the Constitution Act 1902 the Legislative Council is not able to prevent the passage of Bills appropriating money for the ordinary annual services of the Government.

Chapter 1 Small Business, Tourism

The Committee heard evidence from the Hon Sandra Nori MP, Minister for Small Business and Minister for Tourism, together with officers of relevant departments, at a public hearing held on 6 June 2000. A brief summary of the issues discussed at the hearing is provided below. The discussion on these topics appears in the evidence and answers to questions on notice.

Small Business

Allocation of portfolio responsibility for small business

- 1.1** The Committee asked questions about the lack of a separate budget allocation for small business and the ministerial responsibility for small business aspects of the Department of State and Regional Development. Ministerial responsibility for Business Enterprise Centres (BECs) was also considered.

Strategies to assist small business

- 1.2** The Committee discussed strategies to assist small business in NSW other than the BEC scheme. A series of questions was asked about auditing of funds used for business development and the effectiveness of funding for small business development.

Role of Chambers of Commerce

- 1.3** A question was asked about the relationship between business development activities of the department and town Chambers of Commerce.

Impact of the GST on small business

- 1.4** Members asked a series of questions about a report by consultants Ernst and Young and commissioned by the department that considered the impact of the GST on small business. Questions were asked about the identity of four small businesses discussed in the report and the proprietor of a business at the place the report was launched.

Funding to support small business in New South Wales

- 1.5** Questions were asked about the budget announcement of \$8 million to support small business in New South Wales. Members discussed the level of funding growth by comparison to the previous year

Challenges faced by small business in New South Wales

- 1.6** Questions were asked about the major problems faced by small business in New South Wales and ways that the Department obtains information about the specific problems faced by small business.

Overseas Ministerial travel

- 1.7** The Minister was asked about her overseas travel over the last year and whether there were any plans for her to travel overseas during the coming year.

Promotional activity

- 1.8** Questions were asked about the cost of media monitoring by the Department of State and Regional Development for the financial year up until the date of the hearing. Questions were also asked about the advertising budget for the Department.

Departmental property

- 1.9** A question was asked about the extent of the Department's property holdings and whether there is a budget for property acquisition and disposal.

Consultants

- 1.10** Members asked questions about the level of expenditure by the Department of State and Regional Development on external consultants.

Tourism**Old Sydney Town**

- 1.11** Questions were asked about the disposal of Old Sydney Town by the government and co-owner, Westpac, earlier this year. Topics covered included the price realised by the disposal, the identity of the buyer, the fate of historical items located at the park, whether a development application has been lodged in respect of the site, and the capital value of the Park when it first became a majority owned government asset. A question was also asked about a sunken boat referred to during the 1999-2000 budget estimates hearings.

Regional coordination

- 1.12** A question was asked about the level of coordination between different areas of the state in the development of tourism packages.

Insurance in regional museums

- 1.13** Questions were asked about the level of insurance of regional museums in New South Wales.

Wet weather activities for families with children

- 1.14** A question was asked about whether any action had been taken by the Department to provide updated information on wet weather activities for families holidaying with young children.

Level of funding for Tourism NSW

- 1.15** Members asked questions about whether the level of budget funding to Tourism NSW was adequate in terms of the potential size of the tourism market for New South Wales. Questions were also asked about funding for regional and rural tourism in New South Wales and the level of funding for major events in New South Wales.

Impact of the Olympics on regional tourism

- 1.16** Questions were asked about the extent to which regional tourism bookings in New South Wales have reduce during the Olympic period.

Measure to enhance tourism in NSW

- 1.17** Members asked about measures being taken by Tourism NSW to encourage people to visit New South Wales over the coming year. Questions were asked about the level of assistance given to travel journalists who visit the state.

Tertiary training

- 1.18** Questions were asked about the number of universities that currently offer training in tourism.

Cost of Ministerial travel

- 1.19** A question was asked about the Minister's year-to-date travel costs.

Departmental Property

- 1.20** A question was asked about the level of property owned by Tourism NSW. Questions were also asked about the number of cars, televisions and mobile telephones owned by the Department.

Overseas offices

- 1.21** Questions were asked about the number of overseas offices operated by Tourism NSW.

Assistance to visitors from non-English speaking backgrounds

- 1.22** Several questions were asked about the forms of assistance given to visitors from non-English speaking backgrounds. Particular attention was paid to the issue of signage and telephone assistance for people who do not speak English.

Chapter 2 Health

The Committee heard evidence from the Hon Craig Knowles, Minister for Health, together with Mr Michael Reid, Director-General of NSW Health, and Mr Ken Barker General Manager, Financial and Commercial Services, NSW Health at a public hearing held on 6 June 2000. The Committee heard further evidence from Mr Reid, along with Mr Robert McGregor, Deputy Director General, Operations, NSW Health, and Dr Andrew Wilson, Chief Health Officer, NSW Health, at an additional public hearing held on 19 June 2000.

A brief summary of issues discussed at the two hearings is provided below. The discussion on these topics appears in the evidence and answers to questions on notice. During the course of the hearings the Committee Chair and witnesses tabled a number of documents. A list of tabled documents is provided in Appendix 1.

Waiting times website

- 2.1** The Committee asked the Minister a number of questions about NSW Health's waiting times website. There was considerable discussion about the accuracy and usefulness of the information presented on the website.

Isolated Patients Travel and Accommodation Assistance Scheme (IPTAAS)

- 2.2** The Committee asked a number of questions about the level of funding for IPTAAS. Members considered the \$20 personal contribution for patients and/or escorts who are pensioners or health care card holders.

Royal Far West Children's Health Scheme

- 2.3** Members discussed funding for the Royal Far West Children's Health Scheme. Particular attention was paid to dental and orthodontic services provided under the scheme. Members also asked about initiatives to provide services locally.

Community based health services

- 2.4** The Committee was advised that the budget for primary and community services in 2000/2001 was \$564,226,000. Mr Reid undertook to provide the Committee with information about the breakdown of that figure into post acute care and community nursing.

Mental Health Services

- 2.5** The Minister was asked what proportion of new funding for mental health services will go to services in the community, and what proportion will go to hospitals and other forms of institutional care. Mr Reid undertook to provide information to the Committee about how these funds will be expended, once a decision has been made in this regard.

Movements in funds between Area Health Services

- 2.6** Members discussed the movement of funds between Area Health Services as a result of patient flows in line with the Resource Distribution Formula.

Cross border funding flows

- 2.7** Questions were asked about the movement of health funds between NSW and other jurisdictions to support cross border patient movements.

Revised budget for 1999-2000

- 2.8** The Committee asked a number of questions about the comparison between the budget for 1999-2000, the revised budget figure for 1999-2000 and the budget for 2000-2001, and the correct way of calculating the increase in health funding in the 2000-2001 budget.

Debt levels of, and accounts payable by, Area Health Services

- 2.9** Questions were asked about the effect of the Government's initiatives to retire the debt of rural Area Health Services. Mr Reid undertook to provide the Committee with information about accounts payable by the Area Health Services, New Childrens Hospital and Ambulance Service, as at 31 May 2000 which were 45 days or 90 days overdue for payment. Further questions were asked about allocation of funds to pay creditors of the New England Health Service and the priority given to long term creditors of the Department.

Debtors to the Department

- 2.10** Some questions were asked about the level of debt owed to the Department and the action being taken to recover these funds.

Breast Cancer Centre

- 2.11** The Committee asked a question about progress on the NSW Breast Cancer Centre.

Coffs Harbour Hospital

- 2.12** The Committee asked a number of questions about the Coffs Harbour Hospital project. Areas considered included the impact of flood levels upon the project and the project completion date.

Health Research

- 2.13** The Committee queried the level of funding for health research. Members discussed the level of increase in funding and the priorities for funding.

Corrections Health

- 2.14** Members discussed funding of the Corrections Health Service. Topics covered included the consultative mechanisms used by the service, and the mechanisms for the evaluation of programs and the proportion of expenditure going to women's health programs.

Area Health planning

- 2.15** The Committee asked about the development of rural and metropolitan health plans for NSW. Particular attention was paid to the continuing role and range of services offered by smaller district hospitals, such as Auburn District Hospital, within these plans.

Contracting of private sector health services

- 2.16** Members sought information about future plans to by NSW Health to purchase health services from the private sector.

Shortage of junior doctors

- 2.17** The Committee discussed the current shortage of junior resident medical staff in Australian public hospitals.

Quality control

- 2.18** The Committee sought information about allocation of funding for quality control measures in NSW Hospitals. Reference was made to a recent incident involving kitchen hygiene at Gosford Hospital.

Incidents involving circumcision

- 2.19** Information was sought about the costs of routine male circumcision and the protocols in place to ensure that a child does not suffer during routine circumcision.

Use of antibiotics

- 2.20** Members discussed initiatives being undertaken to educate doctors and the public regarding the proper use of antibiotics. The Committee discussed recent research on the public health effects of antibiotic use.

Effect of the Olympics

- 2.21** Questions were asked about the impact of the Olympic Games on levels of service in NSW hospitals. Members sought information about whether there were any proposals to restrict services such as elective surgery during the games.

Independent testing laboratory for Sydney Water

- 2.22** The Committee asked about the tender process for selecting an independent water testing laboratory for Sydney Water. Members asked about the identity and level of accreditation of the successful tenderer and the value of the contract.

External departmental investigators

- 2.23** Questions were asked about proposals to establish a panel of independent investigations to conduct departmental investigations. Members asked about the funding allocation for such investigations and the relationship between the panel and the internal unit that currently conducts probity checks on departmental staff.

Miscellaneous

- 2.24** Questions were taken on notice in relation to a number of issues including: the 2000-2001 budget for the Wentworth Area Health Service; surgery levels in Taree, Port Macquarie and Coffs Harbour hospitals, and the funding of the MacArthur Drug and Alcohol Youth project.

Chapter 3 Community Services, Ageing, Disability Services and Women

The Committee heard evidence from the Hon Faye Lo' Po MP, Minister for Community Services, Minister for Ageing, Minister for Disability Services together with relevant departmental officials at a public hearing on Wednesday 7 June 2000. A brief summary of the issues discussed at the hearing is provided below. The discussion on these topics appears in the evidence and answers to questions on notice.

Community Services

Adoption

- 3.1** Questions were asked about proposals to make adoption available as a permanent care option for children at risk. Topics covered included the level of advice provided to the Minister regarding the proposal, the level of assistance provided to adoptive parents and the support given to subsequent children of parents who have a child removed for adoption.

Early Intervention

- 3.2** A question was asked about the exact budget allocation for early intervention programs.

Unallocated child protection cases

- 3.3** The Committee discussed the level of data collection within the Department of Community Services on unallocated child protection cases.

DoCS teleservice centre

- 3.4** Questions were asked about when the proposed Department teleservice centre would commence operation.

Failure to follow up child protection notifications

- 3.5** Members sought information about allegations of failure by the Nowra office of the Department to follow up child protection notifications for infants.

Referral to Community Services Commission

- 3.6** A question was asked about the reason the Department did not refer a matter involving the death of a child to the Community Services Commission.

Section 22 Child Risk Notifications

- 3.7** The Committee discussed the number of child risk notifications over the last year. Members asked who are the main notifiers of children at risk to the Department. Information was also sought about how the Department assesses whether notifications require a field response and the types of action taken following such an assessment. Questions were then asked about the benchmarks used to determine the timing and level of response following notification. Members queried the process of assessing a child as being at risk and the types of action following such assessment.

Foster care

- 3.8** Questions were asked about the budget allocation for foster care, and the new rate of payment for foster carers due to commence on 1 July 2000. Areas discussed included contingency funding for foster carers, provision for growth in the number of foster children over the coming year and the figure for inflation used as the basis for the Department's calculation of foster care allowances. Information was sought about the type of children who access foster care and the level of assistance provided by the Department to assist foster carers of children with challenging behaviours. Questions were also asked about whether there was any intention to modify the Department's policy prohibiting the use of corporal punishment by foster carers.

Cost of implementing the new child protection legislation

- 3.9** Questions were asked about the cost of implementing the *Children and Young Persons (Care and Protection) Act 1998*. Members queried the cost to non-government organisations of compliance with the new Act.

Information technology

- 3.10** The Committee discussed the age of the Department's information technology systems.

Staffing issues

- 3.11** Members asked a series of questions about departmental staffing. The Department took these questions on notice. Matters taken on notice include the level of staff turnover, the number of temporary District Officers, the number of vacant District Officer positions, the number of vacant Aboriginal District Officer positions and the number of exit interviews conducted since interviews commenced in 1998.

Departmental laptop commuters

- 3.12** Some questions were asked about the number of laptop computers in the Department and the extent to which officers with laptops are able to access confidential files from home.

Court Liaison Officer

- 3.13** A question was asked about where the Department intends to place additional Court Liaison Officers.

Family First Program

- 3.14** The Committee discussed funding for family support programs. Members queried the level of growth funding available to family support agencies. A question was also asked about whether there have been any further discussions about contracting out of substitute care services.

Children's Guardian

- 3.15** A question was asked about funding allocations for the establishment of the Children's Guardian in accordance with the *Children and Young Persons (Care and Protection) Act 1998*.

Disability Services

SACS Award

- 3.16** Questions were asked about whether the government would fund increases in the Social and Community Services (SACS) award for workers in the non-government sector.

Effect of GST

- 3.17** A question was asked about whether the government would increase funding grants to non-government organisations to compensate for the effect of the GST.

Devolution of large residential centres for people with disability

- 3.18** Members asked questions about the budget announcement of additional funding for devolution of large residential centres for people with disability. Areas covered include the identity of specific institutions for the stage 1 of the program and the criteria used to identify priorities for stage 1.

Accommodation for people with acquired brain injury

- 3.19** Some questions were asked about provision of supported accommodation for people with acquired brain injury.

Un-met need for services

- 3.20** The Committee discussed level of un-met need for services for people with disability and the action taken by the Ageing and Disability Department to determine the level of un-met need. In particular, Members asked about the allocation of 63 accommodation packages for people with disability that were announced in 1998.

Respite Care

- 3.21** A question was asked about allegations that Arncliffe Adult Respite Service has cancelled access to respite for people with disability due to blocked respite beds. Members then asked about initiatives to unblock respite beds throughout the State.

Indexation for non-government service providers

- 3.22** Members queried the level of indexation for non-government service providers given by the Department. Particular attention was given to the impact of the GST on non-government providers.

Women**New women's prison at Windsor**

- 3.23** Members asked questions about the level of advice provided to the Minister by the Department for Women regarding the new women's prison at Windsor. Matters considered include the level of community consultation undertaken by the Department.

Women's Grants Program

- 3.24** The Committee discussed the level of funding provided to the Women's Grants Program.

Chapter 4 Mineral Resources and Fisheries

The Committee heard evidence from the Hon Eddie Obeid MLC, Minister for Mineral Resources and Minister for Fisheries, together with officers of relevant departments, at a public hearing held on 9 June 2000. During the course of the hearing a document was tendered by the Minister. Details of tabled documents are provided in Appendix 1. A brief summary of the issues discussed at the hearing is provided below. The discussion on these topics appears in the evidence and answers to questions on notice.

Mineral Resources

Energy exploration in the Sydney basin

- 4.1** The Committee considered current investigations for commercial production of methane gas in the Sydney Basin coal seams by Sydney Gas Operations Pty Limited. Topics discussed included the potential economic benefits of local gas production for New South Wales, the level of consultation with local communities about the location of exploration activities, the level of compensation for land owners affected by exploration and community safety requirements.

Gretley mine accident

- 4.2** Questions were asked about the number of recommendations of the Commission of Inquiry into the Gretley Mine Accident that have been implemented.

Mine Safety

- 4.3** Members asked about the number of safety inspections undertaken by the Department over the last 12 months, the number of people accredited as mine safety officers and the current operations of the Mine Rescue Board.

Use of cyanide in minerals processing

- 4.4** Several questions were asked about the continued use of cyanide in minerals processing in New South Wales and the extent to which alternatives to cyanide are available.

Draft paper on water resources and water management

- 4.5** Members discussed the role of the Department of Mineral Resources in negotiating with interest groups over the Government's draft paper on water resources and water management.

Mineral sand exploration

- 4.6** A question was asked about proposals for sand mining at Lake Cathie, South of Port Macquarie. Several questions were also asked about the level of investment in mineral sands exploration in the Murray-Darling basin. The Committee then discussed plans for mineral sand mining on the New South Wales coast. A question was asked about where the water for extraction of mineral sands from the Birthday Gift and associated deposits will come from.

Proposed Lithgow Silicone Smelter

- 4.7** Information was sought about the role of the Department in relation to a proposed silicone smelter at Lithgow and associated quartz extraction at Cowra and charcoal production at Gunnedah.

Northparkes mine

- 4.8** Questions were asked about the Department's assessment of production at the Northparkes copper and gold mine.

Peak mine

- 4.9** A question was asked about the level of production of the Peak Mine at Cobar following the shutdown the Mine's operations.

Fifield mine

- 4.10** A question was asked about when the new Fifield mine will commence operation.

Gas deposits in the Culgoa National Park area

- 4.11** Members asked questions about the Department's knowledge of gas deposits in the area surrounding the Culgoa National Park in the Brewarrina-Bourke area. Questions were asked about the level of funding for minerals research in the region.

NSW Fisheries**Employment of Director of NSW Fisheries**

- 4.12** The Committee asked questions about the departure of the former Director of NSW fisheries, Dr John Glaister and the recruitment of his successor, Mr Steve Dunn. Questions were asked about the performance agreement and salary package of the new Director. The Minister subsequently provided the Committee with a copy of the Director's

Curriculum-Vitae, the advertisement placed for the position, and a job description for Director of NSW Fisheries.

Restructure of NSW Fisheries

- 4.13** Questions were asked about the restructure of NSW Fisheries referred to in the Budget Papers. Members asked questions about the time-frame and objectives of the restructure as well as proposed staffing levels following the restructure.

Legal Costs

- 4.14** A question was asked about legal costs incurred by NSW Fisheries in a recent Land and Environment Court case that concluded in January 2000. Questions were asked about the nature of any advice given to the Minister about the issues that gave rise to the case and whether a regulation had been drafted to overcome the problems caused by the case.

Fishing licences

- 4.15** Questions were asked about sources of funding for the proposed buy back of commercial fishing licences by NSW Fisheries. Members sought information about the value of commercial fishing licences. A question was asked about how funds raised through the sale of recreational fishing licences would be used.

Acid sulphate soils

- 4.16** A question was asked about what action is being taken to address acid sulphate soils in the Port Macquarie area.

Fish stocking

- 4.17** Questions were asked about the impact of fish stocking on native freshwater fish species and the level of public scrutiny of the Department's fish stocking program.

Aquaculture

- 4.18** The Committee asked about the level of cost recovery in relation the NSW aquaculture industry. Questions were also asked about action being taken by NSW Fisheries to remove restrictions on the export of oyster products from NSW.

Illegal activities

- 4.19** Questions were asked about progress in reducing illegal fishery activity in New South Wales.

Chapter 5 Administrative matters

Conduct of the budget estimates hearings

Questions by Topic

- 5.1** During 1999 hearings into the Budget Estimates, the Committee allocated time for questions equally between the Opposition and Independent members. This year, the Committee instead agreed to ask questions about a specific topic, such as Corrections Health, until questions from all members on that topic were exhausted, before proceeding on to a new topic. Members found this process allowed for more effective questioning of witnesses and recommend its use in future hearings.
