- 2. That the Budget Estimates and related papers for the financial year 2007-2008 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees for inquiry and report.
- 3. The committees are to consider the Budget Estimates in accordance with the allocation of portfolios to the committees.
- 4. The committees must hear evidence in public.
- 5. Not more than two committees are to hear evidence simultaneously.
- 6. The committees may ask for explanations from Ministers in the House, or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure.
- 7. A daily Hansard record is to be published as soon as practicable after each day's proceedings.
- 8. That the Leader of the Government is to provide to each Committee, by Friday 13 July 2007, a schedule outlining the attendance of relevant ministers to appear before each committee, for the committee's consideration.
- 9. The committees may hold supplementary hearings as required.
- 10. The committees are to present a final report to the House by Friday 30 November 2007.<sup>1</sup>

Extended to 6 March 2008 by resolution of the House Thursday 29 November 2007, *Minutes of Proceedings*, No 33, 1st Session of the 54th Parliament, 29 November 2007, item 5.

- 11. Committee members may lodge questions on notice with the Clerk to the committee up to two days following a hearing.
- 12. Questions lodged on notice are subject to standing order 67 and will be published in the Questions and Answers Paper.

## Chapter 2 Issues raised during hearings

This chapter provides a brief summary by portfolio of the key issues raised during the hearings.

## Fair Trading, Youth, Volunteering

- 2.1 A hearing examining the portfolios of Fair Trading, Youth and Volunteering was held on Monday 15 October 2007. The following issues were raised:

- 2.2 In November, the Committee resolved to write to the Minister for Fair Trading seeking clarification regarding the amount of departmental funding provided to AngliCare North Coast for the provision of financial counselling services and to seek facilitation of a meeting between the Office of Fair Trading and AngliCare North Coast.
- **2.3** The correspondence from the Committee to the Minister for Fair Trading and the response from the Minister are available on the Committee's webpage.

## Ageing, Disability Services

- A hearing examining the portfolios of Ageing and Disability Services was held on Monday 22 October 2007. The following issues were raised:

- Commonwealth/State and Territory Disability Agreements for funding
- Funds availability for home modification programs
- Details of departmental travel and salary costs

- The number and training of school counsellors and speech pathologists in NSW schools
- The number and targeting of workplace inspections by the Office of Industrial Relations, and the number of employment breaches by employers, in 2006/2007
- The operation of the fairness test under the Federal Government's WorkChoices scheme and the impact of WorkChoices on NSW employers and employees
- WorkCover conduct of workplace inspections, workshops and education programs in 2006/2007
- The results of an internal WorkCover survey of the job satisfaction of its employees and the level of bullying within the organisation
- Recent changes to the greenslip scheme including the introduction of the Lifetime Care and Support Scheme.
