Chair's Foreword

I present the report of the Select Committee on the proposed sale of Snowy Hydro Limited.

This inquiry was referred to the Committee by the Legislative Council on 3 May 2006, in response to the proposal by the NSW, Commonwealth and Victorian Governments to sell their combined assets in Snowy Hydro Limited.

However, on 2 June 2006, the Prime Minister, the Hon John Howard MP, announced that the Commonwealth was withdrawing the sale of its stake in Snowy Hydro Limited. Later that day, the NSW Premier, the Hon Morris Iemma MP, announced in turn that the sale of the NSW Government stake in Snowy Hydro Limited was impractical.

Given that the proposed sale of Snowy Hydro Limited is now not proceeding, the Committee resolved that it should report back to the Legislative Council on the conduct of the inquiry.

This report includes a recommendation for the Legislative Council to adopt new terms of reference into the continued public ownership of Snowy Hydro Limited.

Chapter 1 The proposed sale of Snowy Hydro Limited

Terms of reference and Committee membership

- 1.1 On Wednesday, 3 May 2006, the Legislative Council referred terms of reference for the establishment of a Select Committee into the proposed sale of Snowy Hydro Limited.²
- 1.2 The inquiry was adopted in response to the proposal by the NSW, Commonwealth and Victorian Governments to sell their combined assets in Snowy Hydro Limited.
- 1.3 The Committee's terms of reference appointed seven members of the Committee: Revd The Hon Gordon Moyes MLC (Chair), the Hon Melinda Pavey MLC, the Hon Patricia Forsythe MLC, Ms Sylvia Hale MLC, together with three Government members.
- 1.4 On Thursday, 11 May 2006, The President informed the House that the Leader of the Government had nominated The Hon Amanda Fazio MLC, the Hon Greg Donnelly MLC and the Hon Tony Catanzariti MLC as the Government members of the Committee.³
- 1.5 At the Committee's first meeting on Wednesday, 25 May 2006, the Hon Melinda Pavey MLC was elected Deputy Chair of the Committee.

Advertisement of the inquiry

- 1.6 At the Committee's first meeting on Wednesday, 25 May 2006, the Committee resolved to advertise its inquiry by:
 - placing advertisements in The Australia, The Sydney Morning Herald, The Daily Telegraph, The Canberra Times, The Cooma-Monaro Express, The Border Mail and The Land
 - placing additional advertisements in regional papers in the Central West, Riverina, Murray, Albury and Orbost regions
 - send a written invitation to make a submission to the inquiry to a range of parties, including NSW, Victorian and Commonwealth government departments and agencies, unions, local councils, irrigators, conservation groups and special interest groups
 - publishing a press release advertising the inquiry via Media Monitors
 - placing the inquiry on the Committee's website
- 1.7 The closing date for submissions was set at Friday, 23 August 2006.
- **1.8** The Committee subsequently received a total of 44 submissions and 3 supplementary submissions. A list of submissions is at Appendix 1.

- 1.10 On 2 June 2006, the Prime Minister, the Hon John Howard MP, announced that the Commonwealth was withdrawing the sale of its stake in Snowy Hydro Limited.⁴
- 1.11 Later that day, the NSW Premier, the Hon Morris Iemma MP, announced in turn that the sale of the NSW Government stake in Snowy Hydro Limited was impractical.⁵
- **1.12** Following these announcements, the Committee met to consider the future conduct of the inquiry.
