Terms of Reference

- 1. That the Budget Estimates and related papers for the financial year 2004-2005 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees for inquiry and report.
- 2. That the committees consider the Budget Estimates in accordance with the allocation of portfolios to the committees.
- 3. For the purposes of this inquiry any member of the House may attend a meeting of a committee in relation to the Budget Estimates and question witnesses, participate in the deliberations of the committee at such meeting and make a dissenting statement relating to the Budget Estimates, but may not vote or be counted for the purpose of any quorum.
- 4. The committees must hear evidence on the Budget Estimates in public.
- 5. Not more than 2 committees are to hear evidence on the Budget Estimates simultaneously.
- 6. When a committee hears evidence on the Budget Estimates, the Chair is to call on items of expenditure in the order decided on and declare the proposed expenditure open for examination.
- 7. The committees may ask for explanations from Ministers in the House, or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure.
- 8. The report of a committee on the Budget Estimates may propose the further consideration of any items.
- 9. That a daily Hansard record of the hearings of a committee on the Budget Estimates be published as soon as practicable after each day's proceedings.
- 10. That the Leader of the Government is to provide to each Committee, by 6 July 2004, a schedule outlining the attendance of relevant ministers to appear before each committee, for the committee's consideration.
- 11. The committees may hold supplementary hearings as required.
- 12. The committees present a final report to the House by the last sitting day of the second sitting week in 2005—put and passed.

Chapter 1 Introduction

Examination of budget estimates

- **1.1** General Purpose Standing Committee No 5 examined the Budget Estimates and related documents for its portfolios at a series of public hearings held on the following dates:
 - 14 September 2004 Regional Development, Illawarra, Small Business
 - 15 September 2004 Primary Industries
 - 16 September 2004 Mineral Resources
 - 16 September 2004 Rural Affairs, Local Government, Emergency Services, Lands
 - 17 September 2004 Environment
- **1.2** Supplementary hearings were held for the Environment portfolio (15 February 2005), Primary Industries (25 February 2005) and Mineral Resources (15 February 2005 and 30 March 2005).
- 1.3 This report outlines the administrative details of the budget estimates hearing process and a brief summary of some of the key issues raised. The full transcript of evidence taken at these hearings can be found the Committee's Web accessible at page at: www.parliament.nsw.gov.au/budgetestimates. - **1.5** In addition the Committee lodged written questions on notice for all the portfolio areas by placing questions on the notice paper with the Clerks at the Table on days that the House sits.

Chapter 2 Public hearings – by portfolio

The key topics discussed at the hearing are provided below. For further details on these, and other matters, see the Hansard record of the hearing, available on the Committee's web page accessible via the Parliament's website at www.parliament.nsw.gov.au/budgetestimates

Regional Development, Illawarra, Small Business

2.1 On 14 September 2004 the Committee conducted public hearings into the portfolios of Regional Development, Illawarra, Small Business.

Regional Development

- 2.2 Amongst the issues discussed, assistance to businesses in drought-affected areas was of particular focus as well as government expenditure on regional projects. Other key issues discussed included:
 - impact of restructuring of government agencies
 - second Airport at Wilton
 - funding to Chambers of Commerce throughout NSW
 - Main Street Small Towns program and Towns and Villages Futures program
 - funding of private industries, local government and community organisations in the Northern Region.

Illawarra

- **2.3** Discussions during the public hearing centred on the provision of health and emergency medical services in the Wollongong area. Other issues discussed included:
 - expansion of port activities in Port Kembla
 - high speed rail link between Sydney and Wollongong
 - Dombarton/Maldon rail link.

Small Business

- 2.4 The key issue discussed during the public hearing was funding for Business Enterprise Centres. Other issues discussed included:
 - closure of Orange Grove factory retail outlet
 - payroll tax relief
 - incentives for small businesses to relocate to regional centres

• small business development in regional areas.

Primary Industries

- **2.5** On 15 September 2004 the Committee conducted public hearings into the portfolio of Primary Industries.
- **2.6** A key matter discussed during the hearing was the impact of budget cuts and the departmental restructure on staffing and various research programs and facilities. Issues associated with genetically modified crop trials were also a focus. Other issues discussed included:
 - appointment of the Director General
 - timber assets
 - organic farming
 - shooters in State forests
 - the Game Council and game licences
 - wild fowl hunting and culling
 - caulpera eradication programs
 - Palmer report and illegal fishing
 - restocking of native and non native fish
 - fishing licence fees
 - shark-netting program
 - DPI conservation activities.

Supplementary hearing

2.7 On 25 February 2005 a supplementary hearing was conducted. There were numerous issues discussed, including:

- inspections into logging operations
- marine parks
- drought assistance
- National Livestock Identification Scheme
- fisheries management strategies
- grey nurse shark protection
- fisheries conservation managers
- Catchment Management Authorities
- staffing issues

- purchase of underwater cameras
- fishing licenses
- Indigenous fisheries strategy.

Mineral Resources

- **2.8** On 16 September 2004 the Committee conducted public hearings into the Mineral Resources portfolio.
- **2.9** Key issues discussed during the hearing included the departmental restructure and decentralisation and the environmental impact of certain mineral exploration and mining operations. Other key issues discussed included:
 - changes in the Coal Compensation Board's royalty scheme
 - the role and function of the minister for Mineral Resources within the Department of Primary Industries
 - subsidence management
 - Bounty Oil and Gas NL exploratory licences
 - sand extraction on the Somersby plateau.

Supplementary hearings

- 2.10 On 15 February 2005 a supplementary hearing was conducted. The key issues discussed concerned:
 - restructure of Department and relocation to Maitland
 - coal compensation liability
 - mine safety inquiry
 - mine safety monitoring
 - Director-General's performance agreement
 - long wall mining
 - Cataract River Taskforce recommendations
 - community consultation committees
 - mine site rehabilitation.
- 2.11 A further supplementary hearing took place on 30 March 2005, at which the following issues were the key focus:
 - Sydney Gas exploration activities on the Central Coast and approval process
 - subsidence management
 - community consultation in mining areas

- Wilpinjong exploration licence tender process
- rehabilitation of derelict mines and current mining sites
- allegations aired in certain media
- Bickham coalmine bulk sample.

Rural Affairs, Local Government, Emergency Services, Lands

2.12 On 16 September 2004 the Committee conducted public hearings into the portfolios of Rural Affairs, Local Government, Emergency Services, Lands.

Lands and Rural Affairs

- **2.13** The key focus of discussions were:
 - the conversion of eastern and central NSW perpetual leases to freehold title
 - management and sale of Crown roads.

Local Government

- **2.14** The key issues discussed included the statutory decision-making power of the administrator of Warringah Council to sell Warringah Civic Centre. Other issues included:
 - dismissal of Walgett Shire Council
 - financial implications of local council amalgamations and strategic alliances
 - the powers and procedures for investigating local councils.

Emergency Services

- **2.15** Amongst the issues discussed, rostering of fire fighters at Lismore fire station was of particular focus. Other issues discussed included:
 - lease of the King Air twin-turbo prop aircraft for fire fighting purposes
 - Rural Fire Services conference, August 2004
 - emergency evacuation response plan for Lucas Heights
 - faulty water tank mountings in fire trucks.

Environment

2.16 On 17 September 2004 the Committee conducted public hearings into the portfolio of the Environment. Groundwater contamination at the Orica Ltd site in Botany and the regulatory response by the EPA was discussed at length during the hearing. Other issues considered were:

- EPA investigation of breach of licence conditions by Waste Services NSW at its Lucas Heights treatment plant and penalty imposed and landfill gas levels at the Eastern Creek site
- storage of toxic hexachlorobenzene [HCB] material at the Orica site in Botany and EPA regulatory response
- suspension of waste treatment at the Lidcombe treatment plant during the Olympics
- funding and operations of the Dunphy Wilderness Fund
- pesticide use in the management of salvinia the Hawkesbury Nepean
- environmental management in the Kosciuszko area
- budget cuts to the National Parks and Wildlife Service and impact on staffing and services
- threatened species conservation under new legislation

Supplementary hearing

- 2.17 On 15 February 2005 a supplementary hearing was conducted. The key issues discussed concerned:
 - flora and fauna survey work and biodiversity certification
 - enforcement of integrated forestry operations approval conditions and threatened species licences
 - pesticides regulation
 - organic recycling targets
 - removal of Moreton Bay Fig trees from Royal Botanic Gardens
 - expenditure of Waste Levy funds
 - treatment of pollution in Botany Bay
 - Gwydir river environmental flow
 - former Pasminco lead smelter at Cockle Creek, Lake Macquarie
 - household chemical clean-ups.
